

- Course reversed for finals and run offs.
- SDCA reserves the right to alter course due to weather or field conditions
- Stakes will be split into flights by public random draw if entry in any regular stake is 20 or more.

ELIGIBILITY & ADDITIONAL INFORMATION

- Only pure bred Scottish Deerhounds one year of age or older on the day of the test/trial. Single stake can have breed disqualifications.
- Dogs not present at the ending time of roll call will be scratched and no refund will be given.
- Entries will be acknowledged by email IF you include a legible email address on your entry form.
- Bitches in season and lame dogs will be excused. Entries will be refunded. NO BITCHES IN SEASON ON THE FIELD!
- A list of all award donors will be printed in the catalog.
- Spayed and neutered dogs are eligible to participate. Monorchid and cryptorchid hounds are ineligible.
- There will be a minimum \$25 returned check charge.
- A \$5.00 fine will be assessed for any loose dog on the field that is not competing in the course in progress. • A \$5.00 fine will be assessed for any handler not cleaning up after their dog.
- Battery or gas powered, continuous loop equipment will be used.
- Lures consist of white plastic.
- SDCA reserves the right to alter course due to field and/or weather conditions on the day of the trial.
- Any person may, upon reasonable complaint, be asked to leave the grounds by the Trial Committee.
- **Children MUST be under control of their parents or guardians at all times.**
- Only the Lure Operator, Huntmaster, Judge, and Handler of the dog running in the course in progress will be permitted near the lure machine.
- Dogs must be individually registered with AKC (including PAL/ILP) FCI or individually registered with an ASFA recognized or ASFA Board approved Registry. REGISTRATIONS CANNOT BE PENDING.


STAKES OFFERED AND RUNNING ORDER

- **Open:**
Scottish Deerhounds that have met certification requirements, excluding ASFA Field Champions of Record.
- **Field Champion:**
Scottish Deerhounds that have earned their ASFA Field Championship titles.
- **Veteran:**
Any eligible Scottish Deerhound that has met certification requirements and is 6 years of age or older.
- **Single:**
Any eligible Scottish Deerhound including those disqualified to run in other stakes, and those with breed disqualifications.
NOT ELIGIBLE TO RUN FOR BEST OF BRED.
- **Kennel:**
Any two eligible Scottish Deerhounds designated at the time of entry in one of the regular stakes and owned by the same individual.
- **Breeder:**
Any two eligible Scottish Deerhounds designated at the time of entry in one of the regular stakes and bred by the same individual.
