

GENERAL RULES

1. All entries must be one year of age or older on the day of the trial.
2. Each entry will be inspected. If in the opinion of the inspection committee, any entry found to be lame, unfit to compete, or a female in season shall not be allowed to enter and entry fees shall be refunded. The decision of the field committee is final.
3. Muzzles are allowed. Dogs may wear any type of collar except no pinch collars and no electronic training collars or devices are allowed. The club recommends using a plain collar and lead. We discourage the use of flexi leads for safety reasons.
4. Electric, continuous loop machines will be used. Lures consist of white plastic bags.
5. The field committee reserves the right to bar known aggressive dogs from the event site. The decision of the field committee is final.
6. There will be a \$5 fine assessed for any loose dog not taking part in the course in progress. The following actions may result in a fine and/or being excused from the event: exhibiting unsportsmanlike conduct, not picking up after one's dog, or littering in any area of the event.
7. NO ONE is allowed on the field without the express permission of the Field Chairman, except the appointed Field Committee.
8. There is NO SMOKING in the following areas: In and around the Paddock area, in and around the Secretary's table, and nowhere on the field itself. Please be respectful of others.

INSPECTION:

All dogs will be inspected for soundness prior to running each event.
All bitches will be checked for being in-season prior to running each
event. *ENTRIES NOT PRESENT AT ROLL CALL WILL BE MARKED
ABSENT AND ARE INELIGIBLE FOR A REFUND.*

STAKES OFFERED:

REGULAR STAKES:

- OPEN STAKE: Open to all eligible basenjjs, excluding ASFA Field Champions of record. First time entrants must include a certification form and copy of registration.
- FIELD CHAMPION STAKE: Open to basenjjs that are ASFA Field Champions.
- VETERAN STAKE: Open to basenjjs whose age is at least six years.
- SINGLES STAKE: Any eligible basenji including those disqualified to run in other stakes. Not eligible for Best of Breed. Hounds are eligible to earn TCP and CPX titles from the Singles stake.

NON-REGULAR STAKES:

- BREEDER STAKE: For two basenjjs, designated at time of entry, bred by the same individual.
- KENNEL STAKE: For two basenjjs, designated at time of entry, owned and kenneled by the same individual.

Ties for the top five placements in any regular stake (or flights when the stake is split) will be run-off or forfeited. If one hound in a tie run is dismissed or disqualified, the hound not dismissed or disqualified is considered to have won the run-off. All ties must be determined by either run off or forfeit.

The entry for each basenji entering the Open or Veteran Stake for the first time MUST include a completed & signed ASFA Certification Form or Waiver Form (with proof of title) and a copy of the hound's registration certificate (Certification waived for Single Stake entries only).

RIBBONS:

BCOA will offer a "New Titlist" rosette for any dog finishing a title. Please notify the trial secretary, via email or include with your entry form, if you expect to be earning a New Title to ensure that we have one for you!

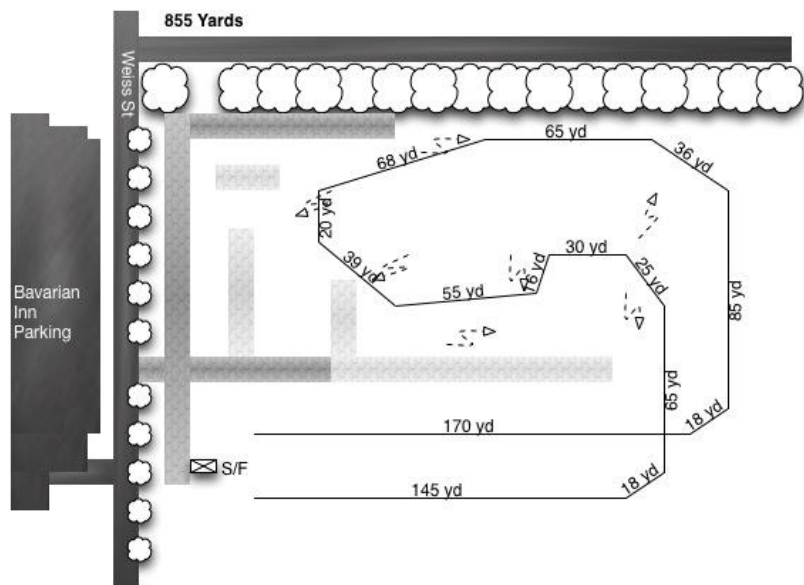
