

### DIRECTIONS TO HANOVER SHOE FARMS

Approx. 15 miles, 30 minutes from Gettysburg. Start out going northeast on Emmitsburg Rd/US-15 Bus N toward US-15 Bus S. Take the 1st right onto Barlow Greenmount Rd. Turn right onto Taneytown Rd/PA-134. Take the 1st left onto Barlow Two Taverns Rd. Turn right onto King Rd. (King Rd becomes Speelman Klingler Rd.). Turn right onto Baltimore Pike/PA-97. Turn left onto White Hall Rd. Turn slight right onto Littlestown Rd. Turn right onto Sells Station Rd. for 1.58 miles.

General Site Descriptions: The Sells Station Road soccer complex is fenced and remote from busy roads. The weather may be hot, and field conditions vary from dry through wet and muddy. **Please provide shade and water for your hounds.**

**ELIGIBILITY**

All entries shall be individually registered with the American Kennel Club (ILP & PAL included), the Federation Cynologique Internationale, an ASFA recognized foreign or ASFA Board approved registry. If this is your borzoi's first ASFA trial, you must submit a copy of his AKC registration paper, and the ASFA Certification Form. If your dog has earned the AKC senior courser, AKC field champion, LGRA GRC, NOTRA ORC, or Canadian field champion title, fill out the "Wavier" portion of the ASFA certification form, & include a copy of the dog's title. Otherwise, fill out the "Certification" portion, which has to be signed by a licensed ASFA judge who has watched your dog coursing with another dog.

Late, incomplete, conditional, unsigned, unpaid entries will NOT be accepted. Owners may not substitute for lame or in-season borzoi.

**Entries will not be acknowledged by mail.**

**STAKES OFFERED**

**Open Stake:** Any eligible Borzoi who has met certification requirements, excluding ASFA Field Champions of Record. A photocopy of the Borzoi's registration must be submitted at the Borzoi's first trial. An AKC Qualified Courser certificate is acceptable as a waiver for a first time entered Borzoi.

**Field Champion Stake:** Any ASFA Field Champion Borzoi.

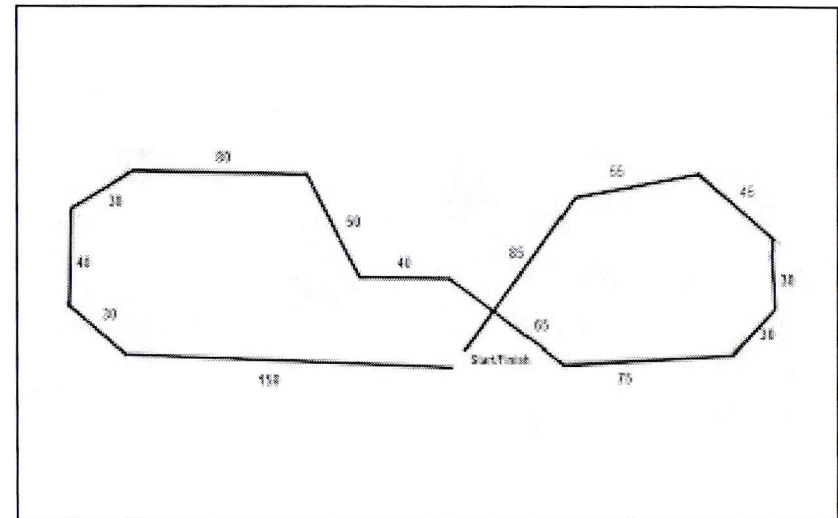
**Veteran Stake:** Any eligible Borzoi whose age exceeds six years, who has met certification requirements. Points earned in this stake are towards the V-FCH or V-LCM titles.

**CONDITIONS OF ENTRY**

All entries must be at least one year of age on the day of the trial. Stakes will be split if entry in any one stake is 20 or more at the time of the draw. Bitches in season and lame Borzoi at Roll Call will be excused and entry fee refunded. Spayed, neutered, monorchid or cryptorchid hounds without breed disqualifications may be entered. Borzoi not present at the time of Roll Call will be scratched. Hound certification runs will not be offered. A battery operated, continuous loop lure machine, with backup equipment, will be used. Lure will consist of highly visible plastic strips. **A \$5.00 fine will be assessed for any hound loose on the field not competing in the course in progress.** All Borzoi run at the owner's sole risk. **Please be responsible Borzoi owners and clean up after your dogs and yourselves.**
