## DIRECTIONS TO LAQUEST WHIPPET HEAVEN

### From Founders Inn: DIRECTIONS TO LaQuest Whippet Heaven

Take Regent University Drive and exit the hotel at the light. Turn Left onto Indian River Road. Merge slight right onto I64. Continue onto exit 299B (signs for I-664/US-13/US58/US-460/Suffolk/Newport News/Richmond (12.9 mi). Keep left at fork and continue toward 1-664N(0.2mi). Continue onto 1-664N (0.5 mi). Use the right three lanes to take exit 13A-13B for US 13N/US58E/Military Highway towards US 460E/VA-191N/Suffolk (0.7mi). Keep Left at the Fork and merge onto US-13S/US-58W (0.1 mi). Exit onto US-460 W/Pruden Blvd toward Petersburg. (11.3mi). Turn Right onto E. Main Street ( (25.9 mi). Turn Left onto VA-31 N (0.4 mi). Turn Left onto State Rte 615 (Carsley Rd) (4.9 mi). LaQuest Whippet Heaven is on the left (2.7 mi).

Camping & RV parking is permitted at the event site. Camping is allowed on the field. Large RVs and Travel Trailers should park on the gravel driveway only. RVs need to notify the FTS in advance so we know how many to plan for. Please do not show up Friday evening after dark unless you are familiar with the field as there are no lights to show the entrance. Camping on the field is free, but no hookups or water are available. RVs and Campers should make a **LEFT TURN** coming into the field if possible. The driveway is at an angle with drainage ditches on both sides.

An additional option for RVs is located at Airfield Camp and Conference Center: <https://www.airfieldconference.com>. They have full hookups available for \$30.00/night. The site is about 20 minutes from the Dendron Fields.

### ELIGIBILITY

All entries shall be individually registered with the American Kennel Club (ILP&PAL included), the Federation Cynologique Internationale, an ASFA recognized foreign or ASFA Board approved registry. If this is your borzoi's first ASFA trial, you must submit a copy of his AKC registration paper, and an ASFA Certification Form or AKC QC Form. If your dog has earned the AKC senior courser, AKC field champion or Canadian field champion title, fill out the "Wavier" portion of the ASFA certification form, & include a copy of the dog's title. Otherwise, fill out the "Certification" portion, which has to be signed by a licensed ASFA judge who has watched your dog coursing with another dog.

Late, incomplete, conditional, unsigned, unpaid entries will NOT be accepted. Owners may substitute for lame or in-season borzoi with another borzoi that they own.

**Entries will not be acknowledged by mail.**

### STAKES OFFERED

**Open Stake:** Any eligible Borzoi who has met certification requirements, excluding ASFA Field Champions of Record. A photocopy of the Borzoi's registration must be submitted at the Borzoi's first trial along with an ASFA certification, AKC QC or waiver certificate.

**Field Champion Stake:** Any ASFA Field Champion Borzoi.

**Veteran Stake:** Any eligible Borzoi whose age exceeds six years, who has met certification requirements. Points earned in this stake are towards the V-FCH or V- LCM titles.

**Singles Stake:** Any eligible Borzoi including those disqualified to run in other stakes. Each hound runs alone. Not eligible for Best of Breed or Best in Field. Hounds are eligible to earn TCP and CPS titles from the Singles stake.

---

### CONDITIONS OF ENTRY

All entries must be at least one year of age on the day of the trial. Stakes will be split if entry in any one stake is 20 or more at the time of the draw. Bitches in season and lame Borzoi at Roll Call will be excused and entry fee refunded. Spayed, neutered, monorchid or cryptorchid hounds without breed disqualifications may be entered. Borzoi not present at the time of Roll Call will be scratched. Hound certification runs will be offered. A battery operated, continuous loop lure machine, with backup equipment, will be used. Lure will consist of highly visible plastic strips. **A \$5.00 fine will be assessed for any hound loose on the field not competing in the course in progress.** All Borzoi run at the owner's sole risk. **Please be responsible Borzoi owners and clean up after your dogs and yourselves.**

**The Charles J.
