TRIAL HOURS: 7:30 am (facility opens) until completion

ROLL CALL: 9:00 am for Trial – *All exhibitors must be present for Roll*

Call INSPECTION: Immediately follows Roll Call with early Inspection
 available **DRAW:** Immediately follows Inspection

ELIGIBLE BREEDS AND REGISTRY: Only purebred Afghan Hounds, Azawakhs, Basenjis, Borzois, Cirneco del'Etnas, Greyhounds, Ibizan Hounds, Italian Greyhounds, Irish Wolfhounds, Pharaoh Hounds, Rhodesian Ridgebacks, Salukis, Scottish Deerhounds, Sloughis, Silken Windhounds and Whippets may enter. All entries shall be individually registered with the AKC (ILP/PAL included), UKC, an ASFA-recognized foreign or ASFA Board approved registry. A photocopy of acceptable registry must be submitted with each hound's first ASFA field trial entry. Limited breeds may be entered in the Limited Stake or the Singles Stake. Limited breeds currently include purebred Chart Polski, Galgo Espanol, Magyar Agar, Peruvian Inca Orchid, Portuguese Podengo (Pequeno), Portuguese Podengo (Medio & Grande), and must be individually registered with the appropriate registry.

All entries shall be individually registered with the AKC (ILP/PAL included), the NGA, the UKC, the FCI, an ASFA-recognized foreign or ASFA Board approved registry, or possess a CRN from the SPDBS. A photocopy of acceptable registry must be submitted with each hound's first ASFA field trial entry; this requirement is waived for hounds registered with the NGA.

CALIFORNIA COURSING ASSOCIATION

LURE COURSING TRIAL

OPEN STAKE: Open to any eligible sighthound excluding ASFA Field Champions of record, that has met certification requirements.

FIELD CHAMPION STAKE: Open to any ASFA Field Champion.

VETERAN STAKE: Open to any eligible sighthound whose age is over 6 years, except Irish Wolfhounds whose age shall be at least 5 years and Whippets, Rhodesian Ridgebacks, Salukis and Afghan Hounds whose age shall exceed 7 years on the day of the trial. Points and placements go towards the V-Fch and V-LCM titles.

LIMITED STAKE: Any eligible sighthound of a Limited breed that has met certification requirements. Not eligible to compete in Best of Breed or Best in Field.

SINGLE STAKE: Open to any eligible sighthound including those disqualified to run in other stakes. They are not eligible for Best of Breed or Best in Field. Hounds are eligible to earn TCP and CPX titles from the Singles Stake. Limited breeds are not eligible for these titles. Hounds will run alone.

LURE COURSING INSTINCT STAKES: Open to all Non-Sighthounds and Sighthound mixes:

Small Open for dogs 17 ½ inches or less at the withers and/or brachycephalic ("flat-faced") dogs who have not achieved the title of LCC. **Small Senior:** for dogs 17 ½ inches or less at the withers or brachycephalic ("flat-faced") dogs who have achieved the title of LCC. **Small**

Veteran: for dogs 17 ½ inches or less at the withers and/or brachycephalic dogs over the age of 7 years. **Large Open** for dogs over 17 ½ inches at the withers who have not achieved the title of LCC. **Large Senior:** is for dogs over 17 ½ inches at the withers who have achieved the title of LCC. **Large Veteran:** for dogs over 17 ½ inches at the withers who are over the age of 7 years. **Sighthound mix Open** for dogs with a sighthound breed in its background who have not achieved the title of LCC. **Sighthound mix Senior** for dogs with sighthound breed in its background who have achieved the title of LCC. **Sighthound mix Veteran** for dogs with

sighthound breed in its background over the age of 7 years. When running as a stake within a regular ASFA trial, small will run 50% of the ASFA course as laid out for the sighthounds up to a maximum of 400 yards. All other stakes will run the full ASFA laid out course length.

EARLY ENTRY FEES AND PAYMENTS

MAIL ENTRIES to the Field Secretary's address above and make checks payable to "CCA". FAX ENTRIES will not be accepted. E-MAIL ENTRIES to jennifergysler@gmail.com. They will be accepted provided the Field Secretary receives payment before 8pm on Wednesday, November 24, 2021, and the entry form is signed. Day of entries will be accepted provided we do not reach the limit of 50 hounds. If paying by PayPal, send payment to socalcoursing@gmail.com only, and pay for your own transaction fees. Do not defer the PayPal fees to the club or your entry will be declined.

ENTRY INFORMATION

1. All entries must be one year or older on the day of the trial.
2. Stakes will be split into flights by public random draw if the entry in any regular stake is 20 or more.
3. Bitches in season, lame hounds and hounds with breed disqualifications will be excused at rollcall.
4. Spayed, neutered, monorchid or cryptorchid hounds without breed disqualifications may be entered.
5. Hounds with breed disqualifications are not eligible to enter except in the Single Stake.
6. Hounds not present at the time of roll call will be scratched.
7. All hounds will run twice, in trios if possible or braces (except in the Single Stake), unless excused, dismissed or disqualified.
8. Hound certification runs will be offered a half hour prior to rollcall.

OPERATIONAL INFORMATION

1. Each course will be reversed for the final runs and reversed again for the Best of Breed run.
2. Gasoline powered continuous loop lure machines will be used. The lures will consist of plastic strips. Backup equipment will be available.

GENERAL INFORMATION


1. Please bring your own food, shade and water.
2. A restroom will be available.
3. No one, except Field Committee members, will be allowed on the field without the expressed permission of the Field Committee.
4. A \$5 fine will be assessed for loose hounds during courses in progress.
5. Anyone failing to clean up their dogs' waste will be excused from the field for the day.
6. Anyone exhibiting unsportsmanlike conduct will be excused from the field for the day.
7. CCA assumes no liability for injury to any person or dog before, during or after the Trial.

DIRECTIONS

From Orange County: Take the 55 North to the 91 East. Next, merge onto the 71 North. Then, take the Butterfield Ranch Road/Euclid Avenue (CA-83) exit. Turn right and the facility will be located on the right side 1/10 of a mile down Euclid Avenue.

From the Inland Empire: Take the 91 West onto the 71 North. Exit Butterfield Ranch Road/Euclid Avenue (CA-83) and make a right. The facility will be located on the right side 1/10 of a mile down Euclid Avenue.

From San Gabriel Valley: Take the 210 East to the 57 South. Then, transition on the 71 South towards Corona. Take the Butterfield Ranch Road/Euclid Avenue (CA-83) exit and turn left. The facility will be located on the right side 1/3 of a mile down Euclid Avenue.



PARK ADMISSION - IMPORTANT

Entry to the park is \$15 per person or per married couple, which includes up to 2 dogs. Each additional dog is \$3, children under 16 are free.

PRACTICE


