ELIGIBLE BREEDS AND REGISTRY: Only purebred Silken Windhounds may be entered. All entries shall be individually registered with the UKC, an ASFA-recognized foreign or ASFA Board approved registry, namely, the ISWS. A photocopy of acceptable registry must be submitted with each hound's first ASFA field trial entry.

LURE COURSING TRIAL

OPEN STAKE: Open to Silken Windhounds excluding ASFA Field Champions of record.
SPECIAL STAKE: Open to Silken Windhounds that have earned their ASFA Field Champion title.
OPEN VETERAN STAKE: Open to Silken Windhounds that have reached 6 years of age on the day of the trial. Points and placements go towards the V-FCh and V-LCM titles.
SINGLE STAKE: Open to Silken Windhounds including those disqualified to run in other stakes. They are not eligible for Best of Breed or Best in Field. Hounds are eligible to earn TCP and CPX titles from the Singles Stake. Limited breeds are not eligible for these titles.

SOCAL CUP QUALIFYING EVENTS

For any hound that enters these trials, they will accumulate SoCal points based on the number of dogs defeated within a particular sighthound breed. The dogs defeated are calculated on cumulative score without regard to the stake entered (i.e. open, special, veteran). Of the 14 scheduled trials, your hound must have minimally competed in 8 of them to attain eligibility into the SoCal Cup final in December.

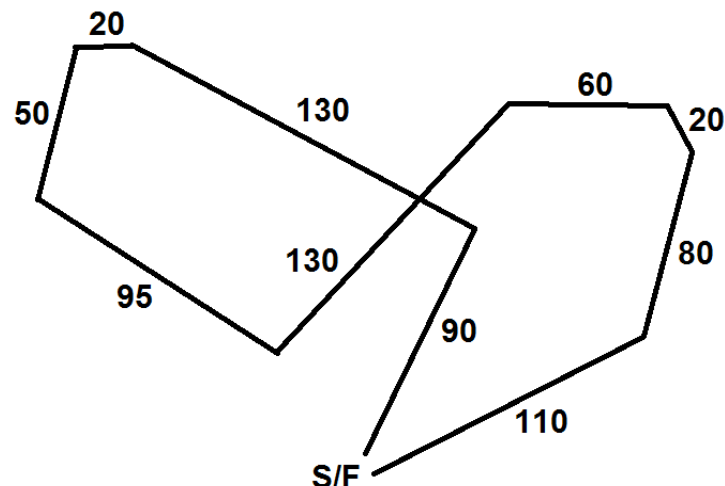

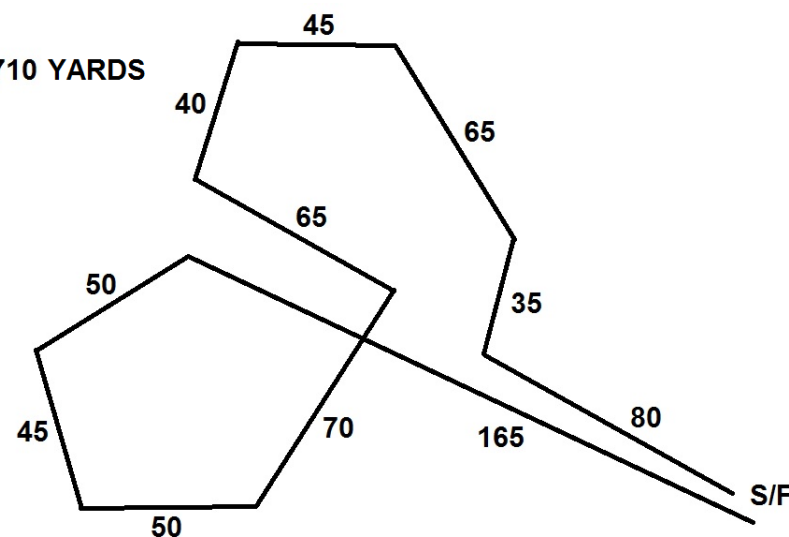
