TIMES AND ELIGIBILITY

TRIAL HOURS: 7:30 am (facility opens) until completion

ROLL CALL: 9:00 am for Trial – *All exhibitors must be present for Roll Call*

INSPECTION: Immediately follows Roll Call with early Inspection available

DRAW: Immediately follows Inspection

ELIGIBLE BREEDS AND REGISTRY: Only purebred Silken Windhounds may enter. All entries shall be individually registered with the Silken Registry (ISWS), UKC, an ASFA-recognized foreign or ASFA Board approved registry. A photocopy of acceptable registry must be submitted with each hound's first ASFA field trial entry.

CALIFORNIA COURSING ASSOCIATION

LURE COURSING TRIAL

OPEN STAKE: Open to any eligible Silken Windhound excluding ASFA Field Champions of record, that has met certification requirements.

FIELD CHAMPION STAKE: Open to Silken Windhound ASFA Field Champions.

VETERAN STAKE: Open to any eligible Silken Windhound whose age is over 6 years, on the day of the trial. Points and placements go towards the V-FCh and V-LCM titles.

SINGLE STAKE: Open to any eligible sighthound breed including those disqualified to run in other stakes. They are not eligible for Best of Breed or Best in Field. Hounds are eligible to earn TCP and CPX titles from the Singles Stake. Limited breeds are not eligible for these titles. Hounds will run alone.

LURE COURSING INSTINCT STAKE: Open to all non-sighthound breeds. All entries shall be individually registered with the AKC (including ILP & PAL), the UKC, the FCI, an ASFA recognized foreign or ASFA Board approved registry, or possess a CRN from the SPDBS. A photocopy of acceptable registry must be submitted with each dog's **first** ASFA field trial entry. Dogs without a recognized registry number may obtain an ASFA ID number for a \$10 registration fee at time of entry. This stake will be limited to a total of 10 entries. Small is for dogs shorter than 17.5 inches at the withers and/or brachycephalic ("flat-faced") dogs. Large is for dogs over 17.5 inches at the withers. Small will run 50% of the course as laid out in this premium up to a maximum of 400 yards. All other sizes will run the full coursing length.

SOCAL CUP QUALIFYING EVENTS

For any hound that enters these trials, they will accumulate SoCal points based on the number of dogs defeated within a particular sighthound breed. The dogs defeated are calculated on cumulative score without regard to the stake entered (i.e. open, special, veteran). Of the 14 scheduled trials, your hound must have minimally competed in 8 of them to attain eligibility into the SoCal Cup final in December.

EARLY ENTRY FEES AND PAYMENTS

MAIL ENTRIES to the Field Secretary's address above and make checks payable to "CCA". FAX ENTRIES will not be accepted. E-MAIL ENTRIES (to jennifergysler@gmail.com) will be accepted provided the Field Secretary receives payment before 10:00 pm on Wednesday, November 27, 2019, and the entry form is signed. If paying by PayPal, send payment to socalcoursing@gmail.com only, and **pay for your own transaction fees**. Do not defer the Pay Pal fees to the club or your entry will be declined.

ENTRY INFORMATION

1. All entries must be one year or older on the day of the trial.
2. Stakes will be split into flights by public random draw if the entry in any regular stake is 20 or more.
3. Bitches in season, lame hounds and hounds with breed disqualifications will be excused at rollcall.
4. Spayed, neutered, monorchid or cryptorchid hounds without breed disqualifications may be entered.
5. Hounds with breed disqualifications are not eligible to enter except in the Single Stake.
6. Hounds not present at the time of roll call will be scratched.
7. All hounds will run twice, in trios if possible or braces (except in the Single Stake), unless excused, dismissed or disqualified.
8. Hound certification runs will be offered a half hour prior to rollcall.

OPERATIONAL INFORMATION

1. Each course will be reversed for the final runs and reversed again for the Best of Breed run.
2. Gasoline powered continuous loop lure machines will be used. The lures will consist of plastic strips. Backup equipment will be available.

GENERAL INFORMATION

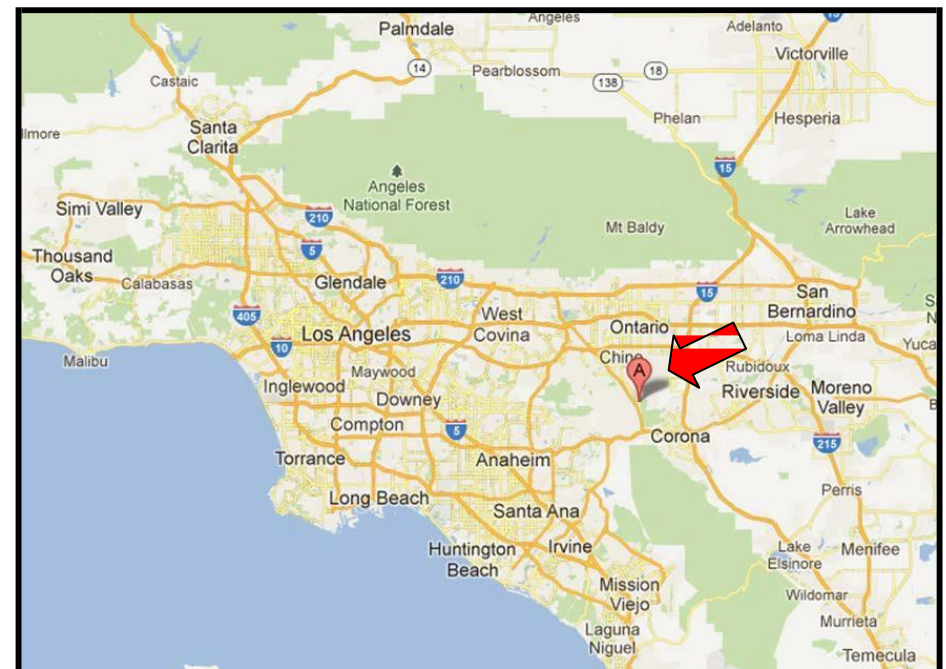
1. Please bring your own food, shade and water.
2. A restroom will be available.
3. No one, except Field Committee members, will be allowed on the field without the expressed permission of the Field Committee.
4. A \$5 fine will be assessed for loose hounds during courses in progress.
5. Anyone failing to clean up their dogs' waste will be excused from the field for the day.
6. Anyone exhibiting unsportsmanlike conduct will be excused from the field for the day.
7. CCA assumes no liability for injury to any person or dog before, during or after the Trial.

DIRECTIONS

From Orange County: Take the 55 North to the 91 East. Next, merge onto the 71 North. Then, take the Butterfield Ranch Road/Euclid Avenue (CA-83) exit. Turn right and the facility will be located on the right side 1/10 of a mile down Euclid Avenue.

From the Inland Empire: Take the 91 West onto the 71 North. Exit Butterfield Ranch Road/Euclid Avenue (CA-83) and make a right. The facility will be located on the right side 1/10 of a mile down Euclid Avenue.

From San Gabriel Valley: Take the 210 East to the 57 South. Then, transition on the 71 South towards Corona. Take the Butterfield Ranch Road/Euclid Avenue (CA-83) exit and turn left. The facility will be located on the right side 1/3 of a mile down Euclid Avenue.

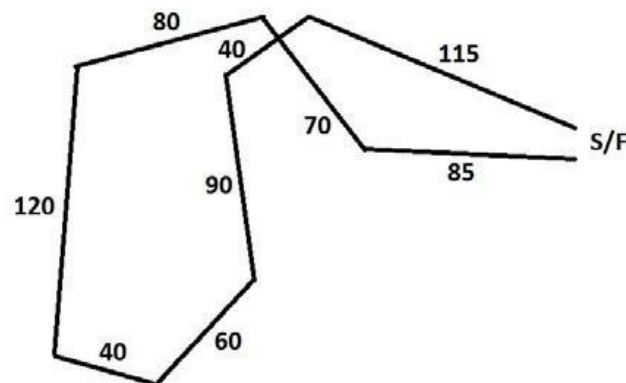

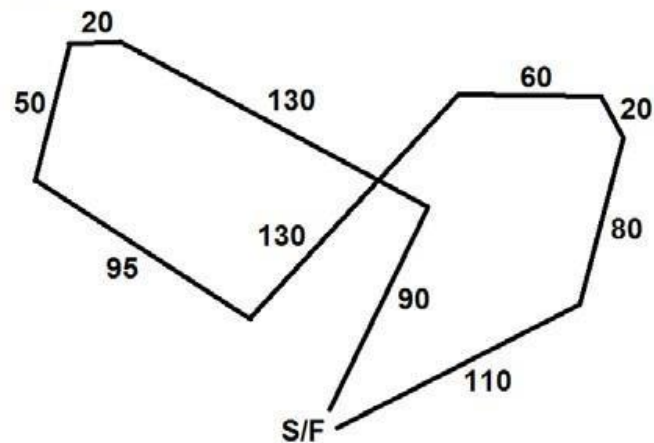
