They are not eligible for Best of Breed or Best in Field. Hounds are eligible to earn TCP and CPX titles from the Singles Stake. Limited breeds are not eligible for these titles.

#### **ENTRY INFORMATION**

- 1. All entries must be one year or older on the day of thetrial.
- 2. Stakes will be split into flights by public random draw if the entry in any regular stake is 20 or more.
- Bitches in season, lame hounds and hounds with breed disqualifications will be excused at rollcall.
- Spayed, neutered, monorchid or cryptorchid hounds withoutbreed disqualifications may be entered.
- 5. Hounds with breed disqualifications are not eligible to enter except in the Single Stake.
- 6. Hounds not present at the time of roll call will bescratched.
- 7. All hounds will run twice, in trios if possible or braces (except in the Single Stake), unless excused, dismissed ordisqualified.
- 8. Hound certification runs will be offered a half hour prior to roll call.

#### **OPERATIONAL INFORMATION**

- 1. Each course will be reversed for the final runs and reversed again for the Best of Breed run.
- 2. Gasoline powered continuous loop lure machines will be used. The lures will consist of plastic strips. Backup equipment will be available.

#### **GENERAL INFORMATION**

- 1. Please bring your own food, shade and water.
- 2. A restroom will be available.
- 3. No one, except Field Committee members, will be allowed on the field without the expressed permission of the Field Committee.
- 4. A \$5 fine will be assessed for loose hounds during courses inprogress.




