TRIAL HOURS: 7:30 am (facility opens) until completion
ROLL CALL: 9:30 am for Trial – *All exhibitors must be present for Roll Call*
INSPECTION: Immediately follows Roll Call with early Inspection available
DRAW: Immediately follows Inspection

ELIGIBLE BREEDS AND REGISTRY: Only purebred Afghan Hounds, Azawakhs, Basenjis, Borzois, Cirneco del'Etnas, Greyhounds, Ibizan Hounds, Italian Greyhounds, Irish Wolfhounds, Pharaoh Hounds, Rhodesian Ridgebacks, Salukis, Scottish Deerhounds, Sloughis, Silken Windhounds and Whippets may enter. All entries shall be individually registered with the AKC (ILP/PAL included), UKC, an ASFA-recognized foreign or ASFA Board approved registry. A photocopy of acceptable registry must be submitted with each hound's first ASFA field trial entry.

LURE COURSING TRIAL

OPEN STAKE: Open to any eligible sighthound excluding ASFA Field Champions of record, that has met certification requirements.
FIELD CHAMPION STAKE: Open to any ASFA Field Champion.
VETERAN STAKE: Open to any eligible sighthound whose age is over 6 years, except Irish Wolfhounds whose age shall be at least 5 years and Whippets, Rhodesian Ridgebacks, Salukis and Afghan Hounds whose age shall exceed 7 years on the day of the trial. Points and placements go towards the V-FCh and V-LCM titles.
LIMITED STAKE: Any eligible sighthound of a Limited breed that has met certification requirements. Not eligible to compete in Best of Breed or Best in Field.
SINGLE STAKE: Open to any eligible sighthound including those disqualified to run in other stakes. They are not eligible for Best of Breed or Best in Field. Hounds are eligible to earn TCP and CPX titles from the Singles Stake. Limited breeds are not eligible for these titles. Hounds will run alone.

SOCAL CUP QUALIFYING EVENTS [This Event is not a Qualifying Event]

For any hound that enters these trials, they will accumulate SoCal points based on the number of dogs defeated within a particular sighthound breed. The dogs defeated are calculated on cumulative score without regard to the stake entered (i.e. open, special, veteran). Of the 14 scheduled trials, your hound must have minimally competed in 8 of them to attain eligibility into the SoCal Cup final in December.

EARLY ENTRY FEES AND PAYMENTS

MAIL ENTRIES to the Field Secretary's address above and make checks payable to "CCA". FAX ENTRIES will not be accepted. E-MAIL ENTRIES to jennifergysler@gmail.com. They will be accepted provided the Field Secretary receives payment before 8:00 pm on Wednesday, November 21, 2018, and the entry form is signed. If paying by PayPal, send payment to socalcoursing@gmail.com only, and pay for your own transaction fees. Do not defer the Pay Pal fees to the club or your entry will be declined.

ENTRY INFORMATION

1. All entries must be one year or older on the day of the trial.
2. Stakes will be split into flights by public random draw if the entry in any regular stake is 20 or more.
3. Bitches in season, lame hounds and hounds with breed disqualifications will be excused at roll call.
4. Spayed, neutered, monorchid or cryptorchid hounds without breed disqualifications may be entered.
5. Hounds with breed disqualifications are not eligible to enter except in the Single Stake.
6. Hounds not present at the time of roll call will be scratched.
7. All hounds will run twice, in trios if possible or braces (except in the Single Stake), unless excused, dismissed or disqualified.
8. Hound certification runs will be offered a half hour prior to roll call.

OPERATIONAL INFORMATION

1. Each course will be reversed for the final runs and reversed again for the Best of Breed run.
2. Gasoline powered continuous loop lure machines will be used. The lures will consist of plastic strips. Backup equipment will be available.

GENERAL INFORMATION

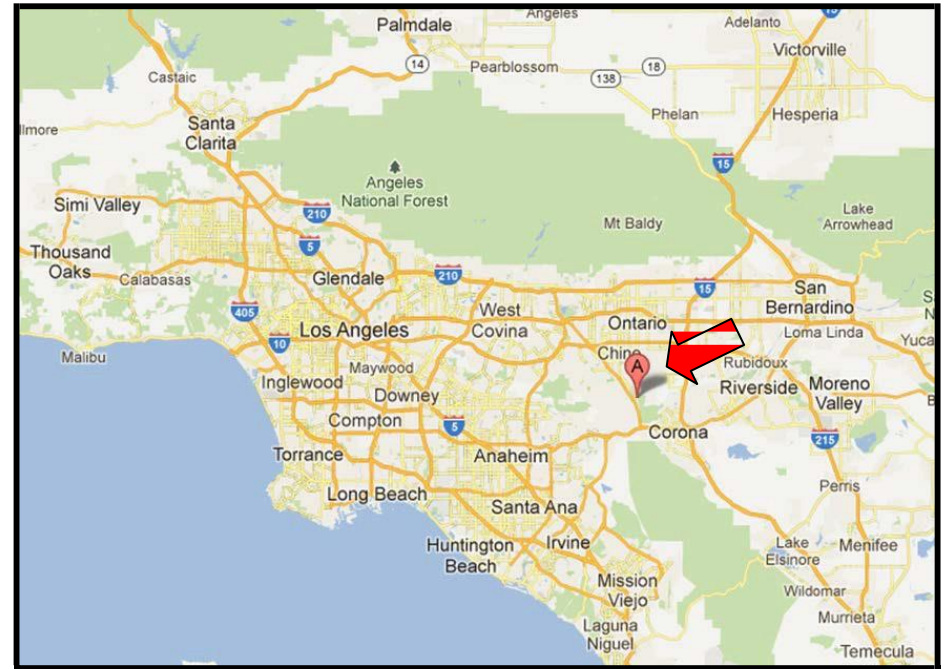
1. Please bring your own food, shade and water.

4. A \$5 fine will be assessed for loose hounds during courses in progress.
5. Anyone failing to clean up their dogs' waste will be excused from the field for the day.
6. Anyone exhibiting unsportsmanlike conduct will be excused from the field for the day.

DIRECTIONS

From Orange County: Take the 55 North to the 91 East. Next, merge onto the 71 North. Then, take the Butterfield Ranch Road/Euclid Avenue (CA-83) exit. Turn right and the facility will be located on the right side 1/10 of a mile down Euclid Avenue.

From the Inland Empire: Take the 91 West onto the 71 North. Exit Butterfield Ranch Road/Euclid Avenue (CA-83) and make a right. The facility will be located on the right side 1/10 of a mile down Euclid Avenue.

From San Gabriel Valley: Take the 210 East to the 57 South. Then, transition on the 71 South towards Corona. Take the Butterfield Ranch Road/Euclid Avenue (CA-83) exit and turn left. The facility will be located on the right side 1/3 of a mile down Euclid Avenue.

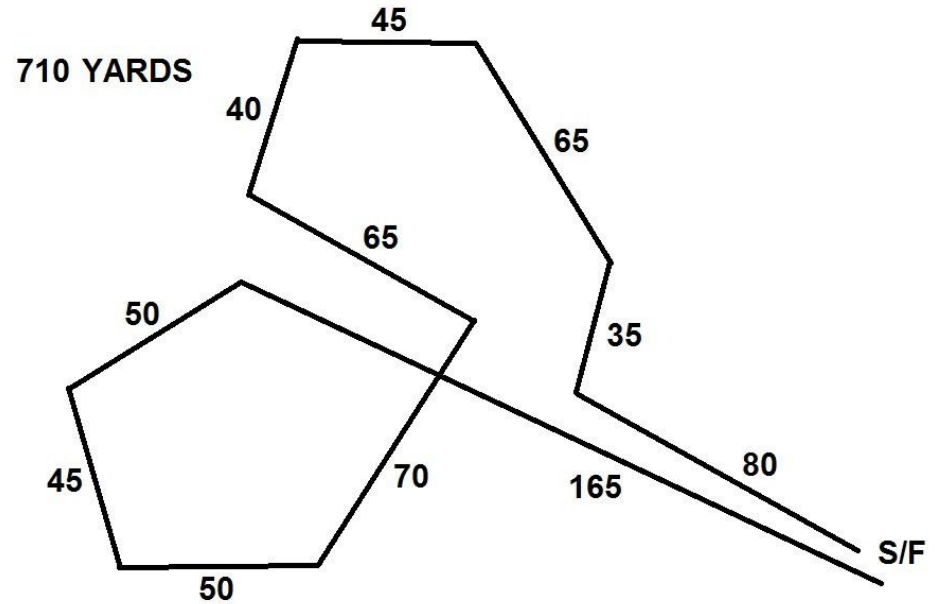
