Directions To

From San Gabriel Valley: Take the 210 East to the 57 South. Then, transition on the 71 South towards Corona. Take the Butterfield Ranch Road/Euclid Avenue (CA-83) exit and turn left. The facility will be located on the right side 1/3 of a mile down Euclid Avenue.

From Inland Empire: Take the 91 West onto the 71 North. Exit Butterfield Ranch Road/Euclid Avenue (CA-83) and make a right. The facility will be located on the right side 1/10 of a mile down Euclid Avenue.

From Orange County: Take the 55 North to the 91 East. Next, merge onto the 71 North. Then, take the Butterfield Ranch Road/Euclid Avenue (CA-83) exit. Turn right and the facility will be located on the right side 1/10 of a mile down Euclid Avenue.

Park Admission

Listed entry to the park is \$10 per person or per married couple, which includes up to 2 dogs. Each additional dog is \$3, children under 16 are free. Entered dogs' owners will automatically be listed. If you plan to attend with a non-entered dog, contact the Trial Secretary to be listed.

Eligible Breeds and Registry

Only Silken Windhounds may be entered in this trial. All entries in this trial shall be individually registered with the International Silken Windhound Society or United Kennel Club. Spayed or neutered hounds are eligible to run in any stake they are eligible to enter.

Stakes Offered

SINGLE STAKE: Any eligible sighthound including those disqualified to run in other stakes.
LIMITED STAKE: Any eligible sighthound of a Limited or Provisional stake breed that has met certification requirements.

BEST IN FIELD WILL BE OFFERED

Hounds must be one year or older on the day of the trial and will be examined for breed disqualifications • Spayed, neutered, monorchid or cryptorchid hounds without breed disqualifications may be entered; hounds with breed disqualifications are not eligible to enter except in the Single Stake • Bitches in season, lame hounds and hounds with breed disqualifications will be excused at roll call • Hounds not present at the time of roll call will be scratched • All hounds will run twice, in trios if possible or braces, unless excused, dismissed or disqualified • If hounds owned or co-owned by the same person are not to run together, the owner must state this on the entry form • Stakes will be split into flights by public random draw if the entry on any regular stake is 20 or more • Battery-powered continuous loop lure machines will be used, with backup equipment on site • The lure will consist of white plastic strips and/or fur strips • A \$5.00 fine will be collected from the handler of any non-competing hound running loose on the field during the course in progress, and from any person not cleaning up after his/her hound.

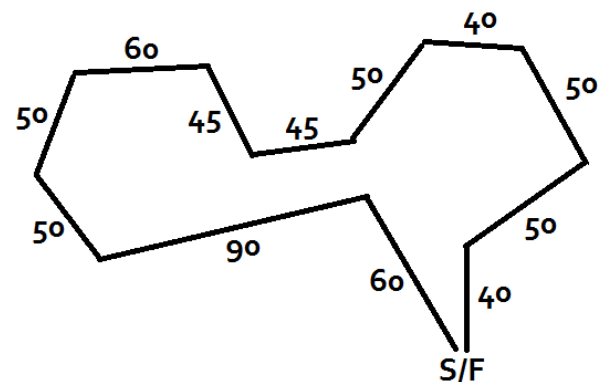
