**TRIAL HOURS:** 7:30 am until completion  
**ROLL CALL:** 9:00 am  
**INSPECTION:** Immediately follows Roll Call  
**DRAW:** Immediately follows Inspection

**ELIGIBLE BREEDS AND REGISTRY:** Only purebred Silken Windhounds may be entered. All entries shall be individually registered with the UKC, an ASFA-recognized foreign or ASFA Board approved registry, namely, the ISWS. A photocopy of acceptable registry must be submitted with each hound's first ASFA field trial entry.

## LURE COURSING TRIAL

**OPEN STAKE:** Open to Silken Windhounds excluding ASFA Field Champions of record.  
**SPECIAL STAKE:** Open to Silken Windhounds that have earned their ASFA Field Champion title.  
**OPEN VETERAN STAKE:** Open to Silken Windhounds that have reached 6 years of age on the day of the trial. Points and placements go towards the V-FCh and V-LCM titles.  
**SINGLE STAKE:** Open to Silken Windhounds including those disqualified to run in other stakes. They are not eligible for Best of Breed or Best in Field. Hounds are eligible to earn TCP and CPX titles from the Singles Stake. Limited breeds are not eligible for these titles.

## SOCAL CUP QUALIFYING EVENTS

For any hound that enters these trials, they will accumulate Bowen points based on the number of dogs defeated within a particular sighthound breed. The dogs defeated are calculated on cumulative score without regard to the stake entered (i.e. open, special, veteran). Of the 14 scheduled trials, your hound must have minimally competed in 8 of them to attain eligibility into the SoCal Cup final in December.

**ENTRY INFORMATION**

1. All entries must be one year or older on the day of the trial.
2. Stakes will be split into flights by public random draw if the entry in any regular stake is 20 or more.
3. Bitches in season, lame hounds and hounds with breed disqualifications will be excused at roll call.
4. Spayed, neutered, monorchid or cryptorchid hounds without breed disqualifications may be entered.
5. Hounds with breed disqualifications are not eligible to enter except in the Single Stake.
6. Hounds not present at the time of roll call will be scratched.
7. All hounds will run twice, in trios if possible or braces (except in the Single Stake), unless excused, dismissed or disqualified.
8. Hound certification runs will be offered a half hour prior to roll call.

**OPERATIONAL INFORMATION**

1. Each course will be reversed for the final runs and reversed again for the Best of Breed run.
2. Battery powered continuous loop lure machines will be used. The lures will consist of plastic strips. Backup equipment will be available.

**GENERAL INFORMATION**

1. Please bring your own food, shade and water.
2. A restroom will be available.
3. No one, except Field Committee members, will be allowed on the field without the expressed permission of the Field Committee.
4. A \$5 fine will be assessed for loose hounds during courses in progress.
5. Anyone failing to clean up their dogs' waste will be excused from the field for the day.
6. Anyone exhibiting unsportsmanlike conduct will be excused from the field for the day.
7. CCA assumes no liability for injury to any person or dog before, during or after the Tests and Trials.



**DIRECTIONS**

**From LA/San Gabriel Valley:** Take the 10 or 210 East to the 15 North. Take the Glen Helen Parkway exit (#122) exit and turn right. After 0.6 miles, turn right at the park entrance.

**From Riverside/Moreno Valley:** Take the 91 East which becomes the 215 North. Exit Devore Road (#54A) and turn left. Devore Road becomes Glen Helen Parkway and after 1.0 mile, turn left at the park entrance.

**From Orange County:** Take the 91 East to the 15 North. Take the Glen Helen Parkway exit (#122) exit and turn right. After 0.6 miles, turn right at the park entrance.

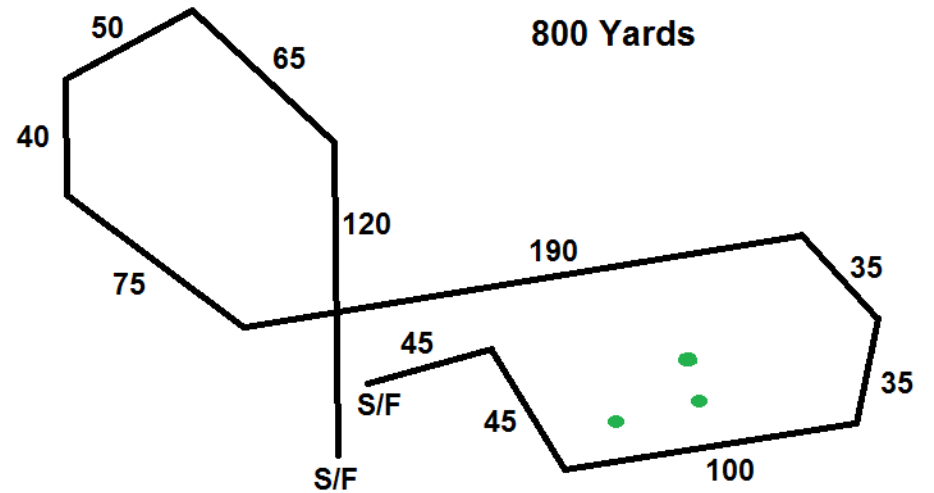

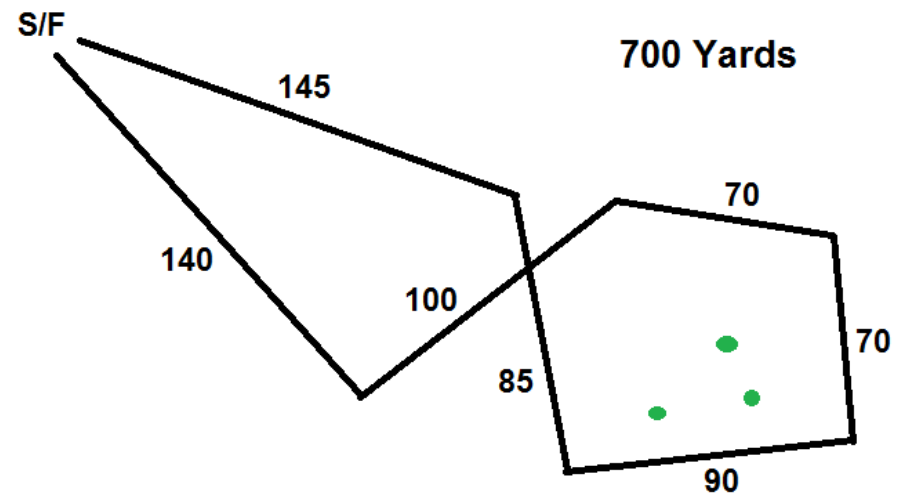
