Both days of our Regional Invitational will be the last event for this competition. Bowen Points will be awarded at each trial in the normal matter. The hound of each breed that has entered a minimum of 60% of these GRAND SLAM trials with the highest number of Bowen Points will be that breed's winner. Hounds do not have to reside in Region 8 to compete. The winning hound of each breed will receive a Grille Plate designating your hound as the winner plus a framed certificate so stating, to be presented at the Regional 8 trial.

ELIGIBLE BREEDS AND REGISTRY

Only purebred Afghan Hounds, Azawakhs, Basenjis, Borzois, Cirnechi dell'Etna, Greyhounds, Ibizan Hounds, Irish Wolfhounds, Italian Greyhounds, Pharaoh Hounds, Rhodesian Ridgebacks, Salukis, Scottish Deerhounds, Sloughis, Whippets and Provisional breeds, if any, may be entered in the regular stakes. Current Provisional breed: Silken Windhound. Limited breeds may be entered in the Limited Stake or the Singles Stake.

Limited stake breeds currently include: purebred Chart Polskis, Galgo Españols, Magyar Agars, Peruvian Inca Orchids, & Portuguese Podengos (Medio & Grande), and must be individually registered with the appropriate registry.

All entries shall be individually registered with the AKC, the NGA, the UKC, the FCI, an ASFA-recognized foreign or ASFA Board approved registry, or possess a CRN from the SPDBS. A photocopy of acceptable registry must be submitted with each hound's first ASFA field trial entry. This requirement is waived for hounds registered with the NGA

REGULAR STAKES OFERED

OPEN STAKE: Any eligible Sighthound that has met certification requirements excluding ASFA Field Champions of record.

FIELD CHAMPION STAKE: Any ASFA Field Champion.

VETERAN STAKE: Any eligible Sighthound that has met certification requirements and is 6 years of age or older (5 years for Irish Wolfhounds; 7 years for Afghans, Rhodesian Ridgebacks, and Whippets).

SINGLES STAKE: Any eligible Sighthound including those disqualified to run in other stakes. Not eligible for Best of Breed or Best in Field. Hounds are eligible to earn TCP and CPX titles from the Singles stake. Limited breeds are not eligible for these titles. Each hound runs alone.

LIMITEDSTAKE: Any eligible Sighthound of a Limited breed that has met certification requirements. Not eligible to compete in Best of Breed or Best in Field.

NON-REGULAR STAKES OFFERED

KENNEL STAKE: For hounds of any individual breeds; an entry shall consist of two hounds, designated at time of entry, in one of the regular stakes being owned and kenneled by the same person.


BREEDER STAKE: For any breed which shall have, designated at time of entry, two hounds bred by the same individual.



CONDITIONS OF ENTRY

- All entries must be one year or older on the day of the trial.
- Stakes will be split into flights by public random draw if the entry in any regular stake is 20 or more.
- Bitches in season, lame hounds and hounds with breed disqualifications will be excused at roll call.
- · Exhibitors are requested not to bring bitches known to be in season to the field
- Spayed, neutered, monorchid or cryptorchid hounds without breed disqualifications may be entered.
- Hounds with breed disqualifications are not eligible to enter except in the Single Stake.
- Hounds not present at the time of roll call will be scratched.
- All hounds will run twice, in trios if possible or braces (except in the Single Stake), unless
 excused, dismissed or disqualified. The members of the Coursing Hounds Association of
 the Mid-Potomac reserve the right to alter the course plan as required by weather and/or
 field conditions on the day of the trial.

Course plan each day will be reversed for final run. <u>Equipment:</u> lure machine is battery-powered continuous loop. <u>Lure type:</u> highly-visible white plastic bags.

DIRECTIONS TO THE FIELD:

Directions from the North:

From Interstate 70 in Frederick, MD: take Route 340/15 South. Bear onto 15S at the split. Leesburg is 24 miles. Follow 15/7 Leesburg bypass to 15 South. Oatlands is 6 miles south of Leesburg on Rt. 15. Turn LEFT on to Gap Road and proceed to the field on the right. Gap Rd. is BEFORE Oatlands. Watch for coursing signs.

<u>From Washington Beltway:</u> take either Route 7 or Dulles Greenway west to Leesburg 15/7 bypass, then exit south on Route 15-South. Follow rest of directions above.

Directions from the South:

Follow Route 15 North toward Leesburg. Oatlands is on the right before Leesburg. Go past the main entrance of Oatlands and TURN RIGHT on the first road, Gap Road. This is a narrow dirt road. Follow coursing signs to the field.

FIELD:

The field is not fenced, but is well off the main road. Please bring your own shade and water.

CERTIFCATIONS:

Practice will be offered on Saturday ONLY AFTER CERTIFICATIONS, weather, equipment, and time permitting. Cost is \$3.00 per hound .
