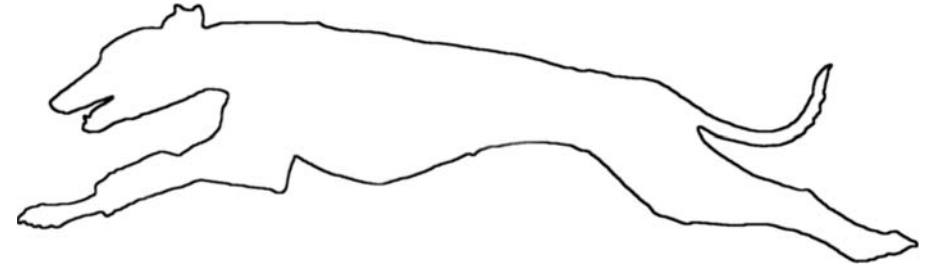
Directions to the field:

From the south: I-75 North to exit 187 (Hwy 83). Turn Right and follow Hwy 83 approx 25.5 miles. In Monticello, turn left onto W. Washington Street. Take the third right onto College Street. After about .4 miles, bear left onto GA Hwy 11 North/ Maddux Street. Follow GA Hwy 11 North for approx 15.3 miles to Mill Pond Rd. Turn right onto James Benton Rd. The entrance to the field is on your immediate right.

From all other directions: I-20 to GA Hwy 11 (this is on the east side of Atlanta). Exit 98, GA Hwy 11 South. Follow Hwy 11 South approx 8.8 miles, turn left onto James Benton Rd. The field will be on your immediate right.

Please join us in thanking Jackie Spears for the use of this wonderful field! We'll be running on a 99 acre bermuda field with few, if any, fencelines or treelines close to the course. We hope that you find it as nice and challenging as we do! Please treat the grounds as if it was your own front yard and make sure to place your trash in a trash bag and make sure to clean up after your hound. There will be a fine if you are found to not pick up after your hounds!

Practice and certifications will be offered during lunch Saturday and Sunday and after the trial on Saturday, weather, equipment and personnel permitting. There will be NO certifications offered before the trial Saturday or Sunday. Certifications will take place first, followed by practices. All certifications and practices will be first-come, first-served. There will be a sign-up sheet available to schedule certifications and practices.

Certifications will cost \$10 each, practice \$5 for non members, \$3 for members.

Camping will NOT be allowed on the field.

Best in Field will not be offered either day. Best in Event will be offered on Sunday. All breed winners who have run both Saturday and Sunday will be eligible to run for Best in Event, The CO trophy.
