PLEASE READ VERY CAREFULLY.

This year we are again in Southern Colorado and the Pikes Peak region, with its wide-open spaces and staggering views. The terrain at the trial site is grassy with very sparse overgrazed vegetation, there are no rocks and some cactus. The surface is coarse sand and drains well. As this is private property, we strongly recommend that vehicles proceed very slowly entering or leaving the trial site. The altitude is over 7000 feet. We do not expect this to affect either the general health or the athletic ability of your hounds but people with respiratory or cardiac problems should seek medical advice before exerting themselves at this altitude.

The COLORADO LURE COURSING ASSOCIATION will hold ASFA-Sanctioned All-Breed Lure Field Trial all three days at the same location.

ELIGIBILITY TO COMPETE IN CLCA'S GRAND NATIONAL BEST-IN-EVENT

The requirements needed to qualify to compete in the Grand National Best In Event run which will take place on Sunday, September 15th after the regular trial are as follows:

- Winner of Best of Breed, Friday, Saturday or Sunday.
- Competed in two of the three ASFA Trials, Sunday being mandatory
- Any hound that is DISMISSED or DISQUALIFIED at the Sunday trial will NOT be eligible to compete in the Best-in-Event.
- All hounds are required to run a BEST OF BREED run on Sunday, whether it is forfeited, the only hound qualifying, or only one in that particular breed.

The Grand National Best-in-Event is NOT an ASFA sanctioned event.

OBJECTIVE

The objective of the GRAND NATIONAL is to bring together the finest lure coursing sighthounds from the continent and to provide for them a challenging test of their relative abilities on a demanding and extended series of courses. The emphasis will again be on the individual breeds with each Best of Breed winner running approximately two miles during the two-day period to earn this title. In order to match various breeds against each other in competition, there will also be a Best-in-Event run-off of approximately one mile, depending upon field conditions.

JUDGES

Because of the unusual difficulty of the courses caused by distance and terrain as well as the anticipated quality of the dogs running, all trials will use two judges except for the Best-in-Event on Sunday, when more may be used and be selected from the panel of judges from Friday, Saturday, and Sunday.

TRIAL PROCEDURES

The ASFA sanctioned field trial on Friday will consist of a course of 735 yards reversed for finals, Saturday's course of 745 yards reversed for finals. Sunday's course will consist of Field "A" of 650 yards and Field "B" of 675 yards, with the preliminary run on Field 1 and the finals on Field 2. Best of Breed runs may be run on either of the course plans. Field "A" and "B" will be joined together for the BEST-IN-EVENT run, which is a NON-ASFA event. In order to compete in the 2025 Grand National Best-in-Event run on Sunday, the hounds have to be Best of Breed winners and have competed in two of the three ASFA trials, Sunday being mandatory. No hound will be allowed to compete who fails to receive a minimum of 200 points. All hounds must run a Best of Breed course in order to advance to the Best-in-Event, even if there is only one qualifying hound, or one stake in the breed. This applies to the Sunday trial only. The Best of Breed winners who have met these requirements will be advanced to the 2025 Grand National Best-in-Event competition, which will consist of one course of approximately one mile in length, depending upon course conditions. Any hound that is DISMISSED or DISQUALIFIED during the Sunday Trial will NOT be eligible to compete in the Best-in-Event Run. Any hound entered only in the *Singles Stake* that wins high single in trial on Friday, Saturday or Sunday and competes in two of the three days with Sunday being mandatory, may compete for Best Single in Event. This will be run on the Best in Event Field and will be judged before the running of the Best in Event. Any LCI entered only in the LCI Stakes (LCI Small, LCI Large, and LCI Sighthound Mix) that wins 1st place in the trial on Friday, Saturday, or Sunday and competed in two of the three days with Sunday being mandatory, may compete for Best LCI in Event. This will be run on the Best in Event Field and will be judged before the Best Single in Event. In the event there are multiple stakes of LCI Small, LCI Large and LCI Sighthound Mix (Open Excellent, Veteran) we will take the highest scoring LCI

from each designation, LCI Small, LCI Large, and LCI Sighthound Mix only. Highest score is over the combined days competing, Friday or Saturday and Sunday being mandatory.

TROPHIES AND ROSETTES

Ribbons suitably inscribed will be awarded for all placements on Friday, Saturday and Sunday. Trophies will be awarded for Best of Breed on Friday, Saturday and Sunday. The Best-in-Event winner will receive a trophy, along with a Humane Purse to be donated to a recognized canine humane society or research facility, subject to approval by the COLORADO LURE COURSING ASSOCIATION Board of Directors. Donations to the Humane Purse gladly accepted, see separate insert in the premium list. The CLCA is also offering a perpetual trophy for Best-in-Event consisting of a silver plated wine cooler on a walnut base engraved with the names of the Best-in-Field winners, to be retained by the Colorado Lure Coursing Association.

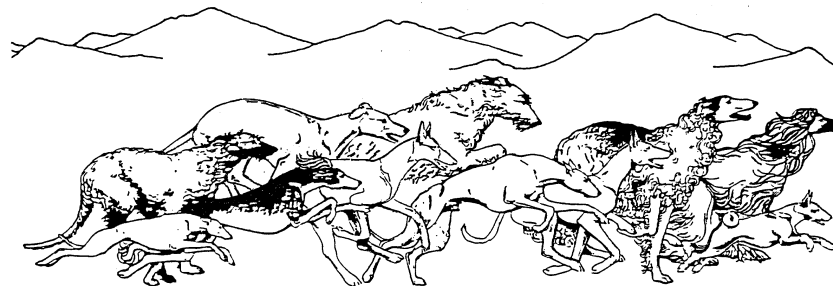

ELIGIBLE BREEDS & REGISTRY

Only purebred Afghan Hounds, Azawaks, Basenjis, Borzoi, Cirneco dell'Etna, Greyhounds, Ibizan Hounds, Irish Wolfhounds, Italian Greyhounds, Pharaoh Hounds, Rhodesian Ridgebacks, Salukis, Scottish Deerhounds, Silken Windhound, Sloughis, Whippets and Provisional breeds may be entered in the regular stakes. Current Provisional include purebred Chart Polski, Galgo Español, Magyar Agar, Peruvian Inca Orchid, Portuguese Podengo (Pequeno), Portuguese Podengo (Medio & Grande), and must be individually registered with the appropriate registry. All entries in the regular stakes shall be individually registered with the American Kennel Club, the National Greyhound Association (NGA), including the United Kennel Club (UKC), the Federation Cynologique Internationale, an ASFA-recognized foreign or ASFA Board approved registry or possess a critique registration number (CRN) from the Society for the Perpetuation of Desert Bred Salukis (SPDBS). Provisional stake entries shall be individually registered with the appropriate registry. (Dogs with an Indefinite Listing Privilege (ILP) or Purebred Alternate Listing (PAL) from the American Kennel Club shall be considered registered with that body.)

REGULAR STAKES OFFERED:

OPEN - Any eligible sighthound, excluding ASFA Field Champions of record that has met ASFA certification requirements.

FIELD CHAMPION - Any ASFA Field Champion

VETERAN - Any eligible sighthound which is 6 years or older on the day of the trial, except Irish Wolfhounds whose age shall be at least 5 years; and Afghans, Ibizans, Rhodesian Ridgebacks, Salukis and Whippets whose age shall be at least 7 years of age and has met ASFA certification requirements. Points go toward V-FCh and V-LCM titles.

SINGLES STAKE: Any eligible sighthound including those disqualified to run in other stakes and provisional breeds. Each hound runs alone. Not eligible for Best of Breed or Best in Field. Hounds are eligible to earn TCP and CPX titles from the Singles stake.

PROVISIONAL - Any eligible sighthound of a provisional breed that has met certification requirements. Not eligible to compete in Best of Breed or Best in field.

LURE CHASING INSTINCT (LCI) STAKE: Open to NON sighthounds and sighthound mixes. All entries shall be individually registered with the AKC (including ILP & PAL) or the UKC. A photocopy of acceptable registry must be submitted with each dog's first ASFA field trial entry. Dogs without a recognized registry number may obtain an ASFA ID number for a \$10 registration fee at time of entry.

Small Open: for dogs 17-1/2 inches or less at the withers and / or brachycephalic ("flat-faced") dogs who have not achieved the title of LCC.

Small Excellent: for dogs 17-1/2 inches or less at the withers and/or brachycephalic dogs who have achieved the title of LCC.

Small Veteran: for dogs 17-1/2 inches or less at the withers and/or brachycephalic dogs over the age of 7 years.

Large Open: for dogs over 17-1/2 inches at the withers who have not achieved the title of LCC.

Large Excellent: is for dogs over 17-1/2 inches at the withers who have achieved the title of LCC.

Large Veteran: for dogs over 17-1/2 inches at the withers who are over the age of 7 years.

Sighthound Mix Open: for dogs with a sighthound breed in its background who have not achieved the title of LCC.

Sighthound Mix Excellent: for dogs with sighthound breed in its background who have achieved the title of LCC.

Sighthound Mix Veteran: for dogs with sighthound breed in its background over the age of 7 years.

When running as a stake within a regular ASFA trial, Small will run 50% of the ASFA course as laid out for the sighthounds up to a maximum of 400 yards. All other stakes will run the full ASFA laid out course.

NON-REGULAR STAKES OFFERED – Each Day

KENNEL STAKE: For hounds of any individual breeds; an entry shall consist of two hounds, designated at time of entry, in one of the regular stakes being owned and kenneled by the same person.

BREEDER STAKE: For any breed which shall have, designated at time of entry, two hounds bred by the same individual.

BENCH STAKE: For any eligible sighthound with proof on file with the ASFA of a conformation champion title from the AKC, CKC or both, or a conformation grand champion title from the UKC.

GENERAL INFORMATION

Conditions of Entry: All entries must be one year or older on the day of the trial. Stakes will be split into flights by public random draw if the entry in any regular stake is 20 or more. Bitches in season, lame hounds and hounds with breed disqualifications will be excused at roll call. Spayed, neutered, monorchid or cryptorchid hounds without breed disqualifications may be entered; hounds with breed disqualifications are not eligible to enter except in the Singles Stake. Hounds not present at the time of roll call will be scratched. All hounds will run twice, in trios if possible or braces (except in the Singles Stake), unless excused, dismissed or disqualified. Entries will not be acknowledged by email or phone.

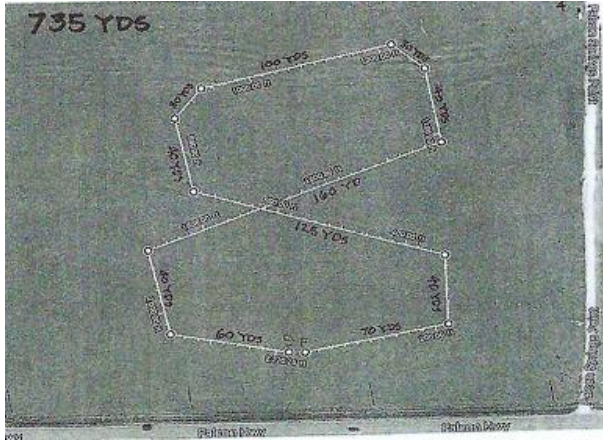

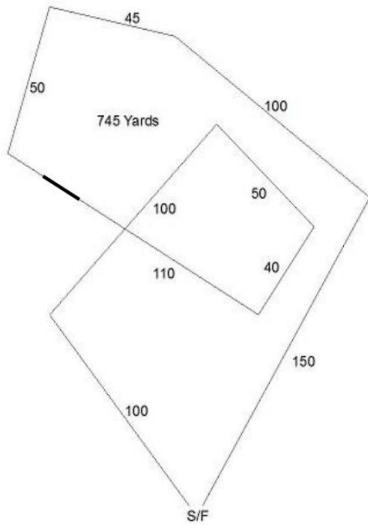

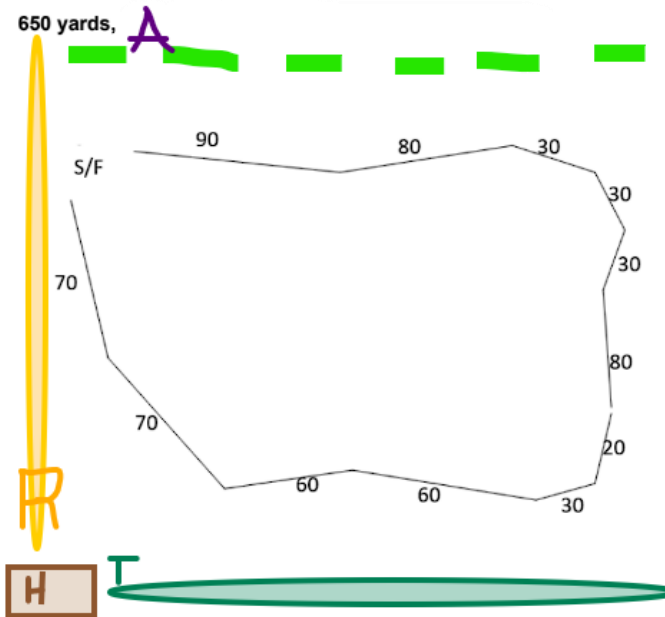
735 yards, clockwise for prelims and reversed for finals



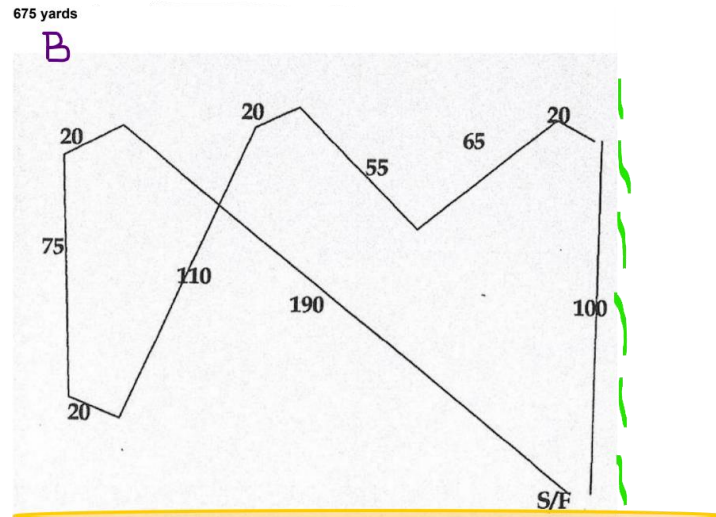
745 yards, clockwise for prelims and reversed for finals

- A \$20.00 fee will be assessed for any returned checks. Persons exhibiting conduct detrimental to ASFA/CLCA/ any hound(s)/other person(s) will be asked to leave the trial site.
- There will be a \$5.00 fine for any owner who does not clean up after his/her hound and for any loose hound not competing in the course in progress.

How To Enter the Trial

1. Complete the entry form(s) – one entry form for each dog and each day that the dog is entered.
 - a. If this is the first time you have entered this dog in an ASFA trial, AND your dog has an AKC QC (qualified courser) OR an ASFA Certification, you MUST include a copy of that with your entry AND a copy of your registration certification (i.e., AKC, UKC, CKC, etc.)
 - b. If your dog does NOT have an AKC QC or ASFA Cert, you are allowed to run in SINGLES, but not the regular open stake. We offer certification AFTER the trial (Saturday ONLY.) Certification forms are included.
2. Email your entries to the Field Trial Secretary at kdarci@yahoo.com ENTRIES THAT ARE EMAILED MUST BE ACCOMPANIED BY PAYMENT THROUGH the CLCA PayPal at: Deann.clcatreasurer@gmail.com. Please add \$1.00 per hound per day entered. If the original entries along with payment are not received the emailed entries will not constitute a valid entry.

1. Complete the entry form(s) – one entry form for each dog and each day that the dog is entered.
 - a. If this is the first time you have entered this dog in an ASFA trial, you MUST include a copy of of your dog's registration certificate (i.e., AKC, UKC, CKC, etc.)
 - b. If your dog does NOT have a registration certificate and this is your first time entering in an ASFA trial you must complete the form titled: **Request for ASFA Lure Chasing Instinct Registration Number**
