- ◆ Late, conditional, unsigned, incomplete or unpaid entries will not be accepted.
- ◆ Early Entries will not be acknowledged by mail. Entries will be acknowledged by e-mail if requested and if an e-mail address is provided.
- ◆ Substitutions may be made for hounds lame or in season **at the time of roll call.**
- ◆ Entries shall be refused for First Time Entered Hounds entering Open, Veteran or Limited Stakes that do not have a copy of registration papers (NGA Greyhounds excepted) to accompany a completed, signed and approved certification form. If a hound has earned a title that waives the certification requirement, a copy of that title certificate must accompany the appropriate ASFA form of waiver
- ◆ Hounds may enter the SINGLES staked without having ASFA certification, but must provide a copy of their official registration papers

GENERAL INFORMATION/CONDITIONS FOR ENTRY

- ◆ All entries must be one year of age or older on the day of the trial.
- ◆ Stakes will be split into flights by public random draw if the entry in any regular stake is 20 or more.
- ◆ Bitches in season, hounds with breed disqualifications, and lame hounds will be excused.
- ◆ Monorchid, cryptorchid, spayed, or neutered hounds may be entered.
- ◆ Hounds with breed disqualification are not eligible to enter except in the Single stake.
- ◆ Hounds not present at the time of Roll Call will be scratched and entry fees will not be refunded.
- ◆ Early entry fees submitted and accepted with early entries will be refunded in full if the withdrawal of said entries is requested by the hound's owner or agent prior to the closing deadline for early entries. Requests may be made by time-stamped email to the FTS or by direct contact (phone or in person) with the FTS. No refunds for early entry fees will be returned after the closing of early-entries unless the entered hound upon inspection is lame or in season
- ◆ Day-of-trial-entry fees submitted and accepted with day-of-trial-entries will be refunded in full if the withdrawal of said entries is requested by the hound's owner or agent prior to the closing deadline for day-of-trial entries. Requests must be made in person to the FTS. No refunds for day-of-trial entry fees will be returned after the closing of day-of-trial entries unless the entered hound upon inspection is lame or in season
- ◆ All hounds will run twice, in trios if possible, or braces, unless excused, dismissed or disqualified.

ELIGIBLE BREEDS AND REGISTRY

- ◆ Only purebred Afghan Hounds, Azawakhs, Basenjis, Borzoi, Cirnechi, Greyhounds, Ibizan Hounds, Irish Wolfhounds, Italian Greyhounds, Pharaoh Hounds, Rhodesian Ridgebacks, Salukis, Scottish Deerhounds, Sloughis, and Whippets and Provisional breeds may be entered in the regular stakes.
- ◆ Current Provisional breed: Silken Windhound.
- ◆ Limited breeds may be entered in the Limited Stake or the Singles Stake. Limited breeds currently include purebred Chart Polski, Galgo Espanol, Magyar Agar, Peruvian Inca Orchid, Portuguese Podengo (Pequeno), Portuguese Podengo (Medio & Grande), and must be individually registered with the appropriate registry.
- ◆ All entries shall be individually registered with the AKC (including ILP & PAL), the NGA, the UKC, the FCI, an ASFA-recognized foreign or ASFA Board approved registry, or possess a CRN from the SPDBS. A photocopy of the acceptable registry must be submitted with each hound's first ASFA field trial entry; this requirement is waived for hounds registered with the NGA.

NOTICES

- ◆ **Certifications will be offered BEFORE the trial and will begin at 8:00 a.m. No certifications will be offered after the trial. A \$10 fee is applicable per run.**
- ◆ Fun Runs or Practice Runs will be offered **ON SATURDAY ONLY** as conditions allow. .Please notify the FTS that you would like to fun run your hound(s). Please work with us and we will work with you to fit you into the schedule.
- ◆ **ALL PERSONS MUST CLEAN UP AFTER THEIR HOUNDS.** The facility and our fellow competitors deserve our respect. If your hound makes a mess, you **MUST** clean it up. *Please report violations to the Field Chair.*
- ◆ A **penalty of \$5.00** will be assessed for any loose hounds not competing in the course in progress.
- ◆ A **return check fee of \$35.00** will be assessed for any check returned due to insufficient funds.
- ◆ An electrical-powered, continuous loop lure machine will be used with back-up equipment available.
- ◆ The lure will consist of light colored plastic and/or fur.
- ◆ Muzzles are not required. It is the responsibility of the owners to determine if their hounds should be muzzled. If a muzzle is used, it must be of a color other than yellow, pink or blue
- ◆ Persons exhibiting conduct detrimental to ASFA, CdECA, any hound, and/or other individual(s) will be asked to leave the trial site
- ◆ This event site has restroom facilities. Water for your hounds also is available. Please bring your own shade and/or shelter
- ◆ Food vendors are not pre-arranged for this event site; however, restaurants are in close proximity in Cat Spring and Bellville. Please plan to “run to lunch” or bring a sack lunch with you.
- ◆ CdECA and the facility assume no liability for injury to any person or dog before, during or after these trials

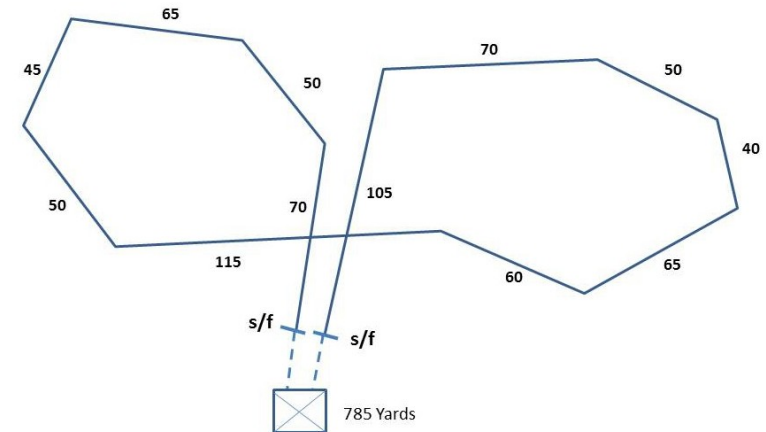

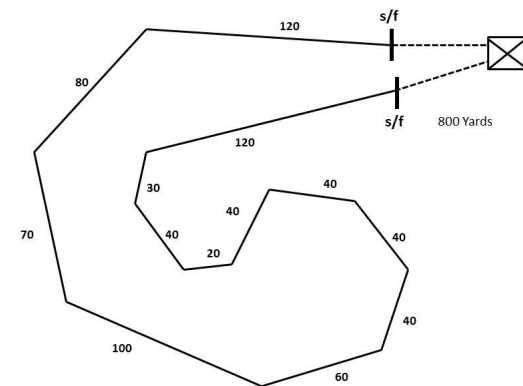
Saturday Course Plan – 785 yards

Directions

From Houston (I-10):

- Take **I-10 West** to Sealy (50 miles).
- Go **North on 36** (2 miles).
- Turn **Left on FM 1094** and go 11 miles.
- Turn **Right on FM 949** and go .2 mile.
- Turn **Left on Mill Creek Rd.** (after bridge the road Y's, **stay to right**).
- The 7IL entrance is on the **Left 2.5 miles**. Look for the **Texas Flag Mailbox**.

From San Antonio (I-10):

- Take **I-10 East** to **Exit 704** (FM 949)
- Go **Left (north) on FM 949** about 11.7 miles to 1094.
- **Cross 1094** and go . 2 mile.
- Turn **Left on Mill Creek Road.** (after bridge the road Y's, **stay to right**)
- The 7IL entrance is on the **Left 2.5 miles**. Look for the **Texas Flag Mailbox**.

From Dallas (45):

- Take **I-45 S** (129 miles)
- **Exit 146** toward Tx-75 to **Madisonville** (go 4.5 miles),
- Turn **Right at 190** (go .2 mile)
- **Turn Left at 90** (go 42.4 miles)
- **Turn Left at Hwy 6 S.** (go 20 miles to Hempstead)
- Take **159 to Bellville** (go 15.5 miles).
- Cross Railroad tracks and turn **Left at Light**.
- After trailer company, turn **Right on Hacienda (at traffic light)** (go 1.7 miles)
- Turn **Left on Mill Creek Rd.** (the road Y's stay left)
