

DIRECTIONS

From St Louis or Springfield, MO: Take I-44 to the Gray Summit/Hwy 100 exit. Go north on Hwy 100 until you reach the Purina Farms sign at Hwy MM. Turn left onto Hwy MM and drive approximately ¾ mile. The Field is located on the right behind the Purina Sheep and Cattle Barns. Note that the main Purina Farms gate is past the field.

From Kansas City: Take I-70 east to the Warrenton/Hwy 47 exit. Go south on Hwy 47 (approximately 25 miles) until you reach Hwy 100. Turn left and travel on Hwy 100 for approximately 10 miles. Go east on I-44 following the directions above (From St Louis/Springfield)

ELIGIBLE BREEDS AND REGISTRY

Only purebred Cirnechi dell'Etna may be entered in the regular stakes. All entries shall be individually registered with the AKC (including ILP & PAL), the UKC, the FCI, an ASFA-recognized foreign or ASFA board approved registry.

STAKES OFFERED

Open Stake - Any eligible Cirneco dell'Etna one year of age or older on the day of the trial having met ASFA certification requirements, excluding ASFA Field Champions of record.

Field Champion Stake - Any ASFA Cirneco dell'Etna Field Champion

Veteran Stake - Any eligible Cirneco dell'Etna, having met ASFA certification requirements, whose age exceeds seven years.

Single Stake - Any eligible Cirneco dell'Etna including those disqualified to run in other stakes. Each hound runs alone. Not eligible for Best of Breed. Hounds are eligible to earn TCP and CPX titles from the Singles stake.

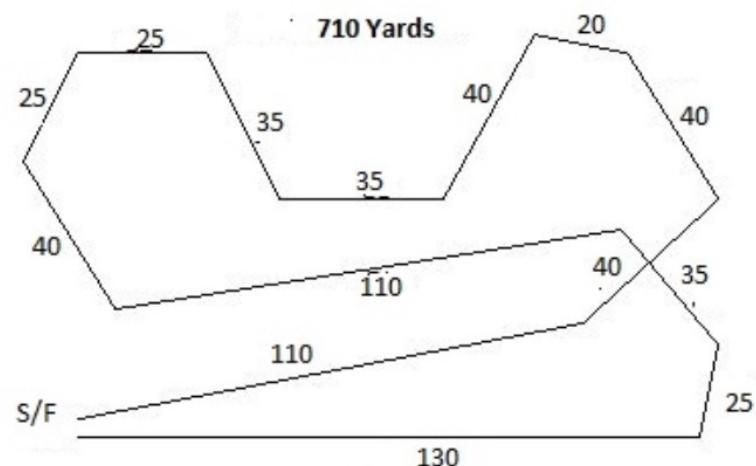
REFUNDS & SUBSTITUTIONS

Early-entry fees submitted and accepted with early-entries will be refunded in full if the withdrawal of said entries is requested by the hound's owner or agent prior to the closing deadline for early-entries. Requests may be made by time-stamped email to the FTS or by direct contact (phone or in person) with the FTS. No refunds for early-entry fees will be returned after the closing of early-entries unless the entered hound upon inspection is lame or in season.

Day-of-entry fees submitted and accepted with gate-entries will be refunded in full if the withdrawal of said entries is requested by the hound's owner or agent prior to the closing deadline for day-of-trial entries. Requests must be made in person to the FTS. No refunds for day-of-trial entry fees will be returned after the closing of day-of-trial entries unless the entered hound upon inspection is lame or in season.

Substitution of hounds will be accepted at the time of roll call/inspection. Once inspection is complete, no further substitution will be allowable.

NOTICE TO ALL

All entries must be one year of age or older on the day of the trial.

Each hound requires an individual entry form for each event in which it is entered.

No entry shall be made and no entry shall be accepted which specifies any condition as to its acceptance.

Entries will not be accepted without fees and must be submitted on an official ASFA entry form.

Stakes will be split if 20 or more entries are present in any one stake at the time of the draw. Splitting of stakes will be held publicly and at the FTS desk.

Bitches in season, hounds with breed disqualifications, and lame hounds will be excused at inspection and refused entry. If presented at inspection, entry fees will be refunded.

Spayed, neutered, monorchid or cryptorchid hounds without breed

disqualifications may be entered.

Hounds with breed disqualifications are not eligible to enter except in the Single Stake.

The lure will consist of plastic contrasting in color with the immediate field environment.

The course will be reversed for Finals and again for Runoffs.

Muzzles are not required; it is the responsibility of the owners to determine if their hound should be muzzled.

Exhibitors should follow their veterinarian's recommendation to assure their dogs are free of internal and external parasites, any communicable diseases and have appropriate vaccinations.

No entry fees will be refunded if the event cannot be started or completed by reason of riots, civil disturbances, fire, extreme and/or dangerous weather conditions, an Act of God, public emergency, act of a public enemy, strikes or any other cause beyond the control of the Club or its members and representatives.

Persons exhibiting conduct non-compliant with these notices and/or detrimental to ASFA/CdECA/any hound(s)/other person(s) will be asked to leave the trial site.

The event-hosting club, its agents, members, representatives, volunteers, etc, assume no responsibility for any loss, damage or injury sustained by exhibitors, handlers, or to any of their dogs or property and further assumes no responsibility for injury to children or spectators.

All rights to televise, videotape, advertise, photograph, promote or otherwise exploit this event are vested in the club, or in persons to whom

- We will be running with Italian Greyhounds
- Breed running order will be Italian Greyhounds then Cirneco dell'Etna to completion of all Preliminary, Final, Runoff and BOB runs.
- In order to avoid delays, we need assistance from all to help in getting dogs to inspection, the paddock, and the line as quickly as possible.
- Although the field is completely fenced, it is also used as a pasture for cows and sheep during the week. Water will be available for cooling hounds. Shade is limited. If conditions are muddy, parking will be confined to gravel parking lot and gravel roads.
