

**Directions to Sam Michaels Park:**

**From East or North:** Rt. 340 for 20 miles (cross 2 bridges) to West Virginia Route 230, Shepherdstown Pike and turn right. Make an Immediate left to stay on Shepherdstown Pike then Turn Right at the stop sign to stay on Shepherdstown Pike. Travel 2.6 mi. to Job Corps Rd. and turn Left. Go half a mile to the park but do not take the first entrance. Continue on to the third entrance and turn left.

**From West and South:I-81** to exit 12 onto WV.-45 East toward Charles town WV. After approximately 1 mile WV-45 becomes route 9. After 9 miles take the exit for Route 8, Wiltshire Rd. Turn left onto Wiltshire road and then an immediate right onto Charles Town Rd. Take the 3<sup>rd</sup> left onto Shenandoah Junction Road for .7 mile and then turn left to stay on Shenandoah Junction Road then take the next right to stay on Shenandoah Junction Rd for .5 mile and turn right onto Flowing Springs Rd. After approximately 1 mile turn left onto Job Corps Rd. Stay on Job Corps Rd. for 1.2 miles to the trial on the right. Follow the coursing signs.

## ELIGIBLE BREEDS & REGISTRY

**Only** purebred Afghan Hounds, Azawakhs, Basenjis, Borzoi, Cirneco dell'Etna, Greyhounds, Ibizan Hounds, Irish Wolfhounds, Italian Greyhounds, Pharaoh Hounds, Rhodesian Ridgebacks, Salukis, Scottish Deerhounds, Sloughis, Whippets, and Provisional breeds may be entered in the regular stakes. Current Provisional breed: Silken Windhound.

**Limited** breeds may be entered in the Limited Stake or the Singles Stake. Limited breeds currently include purebred Chart Polski, Galgo Español, Magyar Agar, Peruvian Inca Orchid, Portuguese Podengo (Pequeno), Portuguese Podengo (Medio & Grande), and must be individually registered with the appropriate registry.

**All** entries shall be individually registered with the AKC (ILP/PAL included), the NGA, the UKC, the FCI, an ASFA-recognized foreign or ASFA Board approved registry, or possess a CRN from the SPDBS. A photocopy of acceptable registry must be submitted with each hound's first ASFA field trial entry; this requirement is waived for hounds registered with the NGA.

### REGULAR STAKES OFFERED

**OPEN STAKE:** Any eligible sighthound, excluding ASFA Field Champions of record.

**FIELD CHAMPION STAKE:** Any ASFA Field Champion

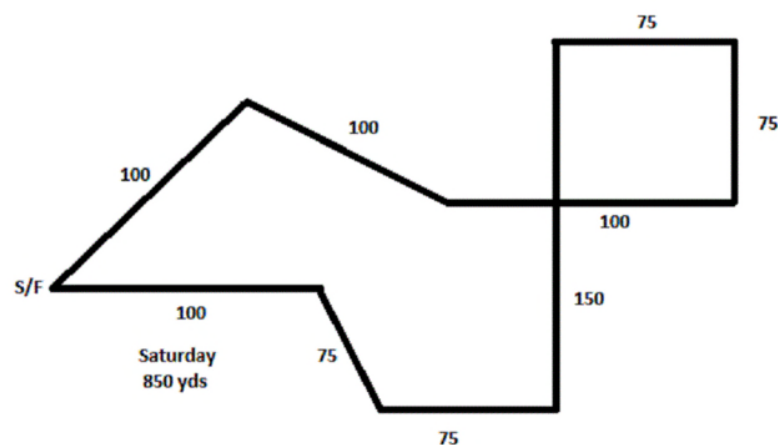
**VETERAN STAKE:** Any eligible hound whose age is at least six years, except Irish Wolfhounds whose age shall be at least five years, and Afghan Hounds, Rhodesian Ridgebacks and Whippets whose age shall be at least seven years. Points go toward V-FCh or V-LCM titles.

**LIMITED STAKE:** Any eligible sighthound of a Limited breed that has met certification requirements. Not eligible to compete in Best of Breed or Best in Field.

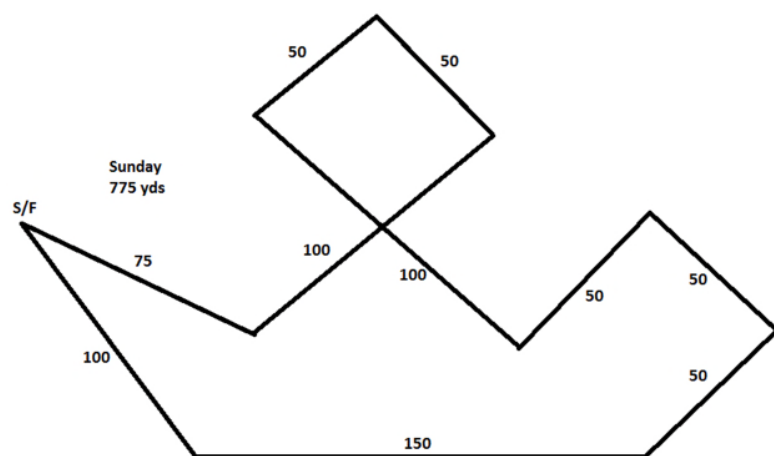
**SINGLE STAKE:** Any eligible sighthound including those disqualified to run in other stakes. Each hound runs alone. Not eligible for Best of Breed or Best in Field. Hounds are eligible to earn TCP and CPX titles from the Singles stake. Limited breeds are not eligible for these titles.

Best in Field will be offered Saturday and Sunday

## COURSE PLANS



The club reserves the right to alter the course diagram as required by weather and/or field conditions on the day of the trial.



**Conditions of Entry:** All entries must be one year or older on the day of the trial • Stakes will be split into flights by public random draw if the entry in any regular stake is 20 or more • Bitches in season, lame hounds and hounds with breed disqualifications will be excused at roll call. • Spayed, neutered, monorchid or cryptorchid hounds without breed disqualifications may be entered; hounds with breed disqualifications are not eligible to enter except in the Single Stake • Hounds not present at the time of roll call will be scratched

• All hounds will run twice, in trios if possible or braces (except in the Single Stake), unless excused, dismissed or disqualified.

**Equipment:** Type of lure machine: battery-powered continuous-loop system.
