ELIGIBLE BREEDS & REGISTRY

Only purebred Afghan Hounds, Azawakhs, Basenjis, Borzoi, Cirneco dell'Etna, Greyhounds, Ibizan Hounds, Irish Wolfhounds, Italian Greyhounds, Pharaoh Hounds, Rhodesian Ridgebacks, Salukis, Scottish Deerhounds, Sloughis, Silken Windhounds, Whippets, Limited breeds may be entered in the Limited Stake or the Singles Stake. Limited breeds currently include purebred Chart Polski, Galgo Español, Magyar Agar, Peruvian Inca Orchid, Portuguese Podengo (Pequeno), Portuguese Podengo (Medio & Grande), and must be individually registered with the appropriate registry.

ENTRIES WILL NOT BE ACKNOWLEDGED BY MAIL OR TELEPHONE. LATE, INCOMPLETE, UNSIGNED OR CONDITIONAL ENTRIES WILL NOT BE ACCEPTED.

REGULAR STAKES OFFERED

OPEN STAKE: Any eligible sighthound, excluding ASFA Field Champions of record, that has met the certification requirements..

FIELD CHAMPION STAKE: Any ASFA Field Champion of record.

VETERAN STAKE: Any eligible hound whose age is at least six years, except Irish Wolfhounds whose age shall be at least five years, and Afghan Hounds, Rhodesian Ridgebacks, Salukies, and Whippets whose age shall be at least seven years and that have met the certification requirements. Points go toward V-FCh or V-LCM titles.

LIMITED STAKE: Any eligible sighthound of a Limited breed that has met certification requirements. Not eligible to compete in Best of Breed or Best in Field.

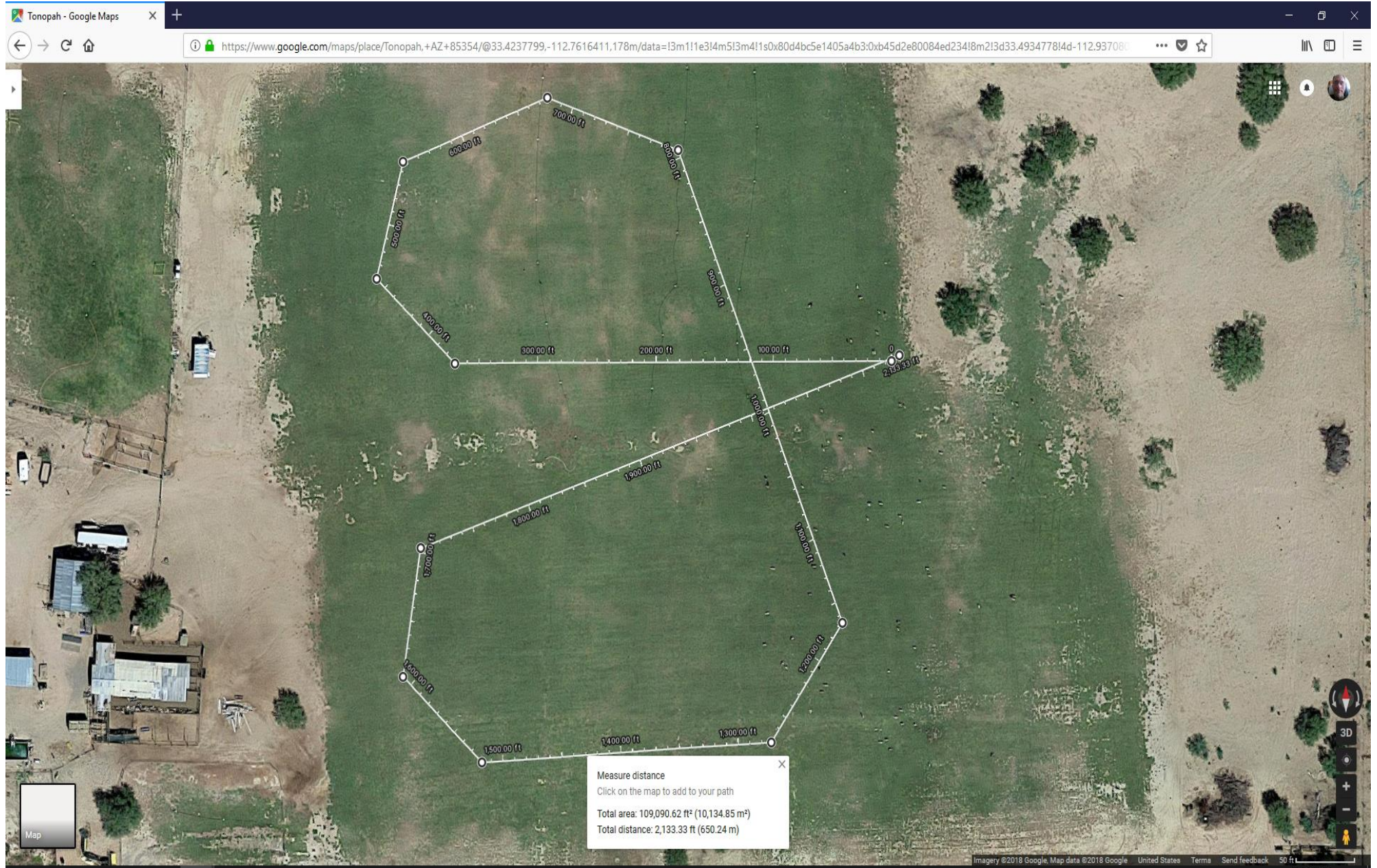
SINGLE STAKE: Any eligible sighthound including those disqualified to run in other stakes. Each hound runs alone. Not eligible for Best of Breed or Best in Field. Hounds are eligible to earn TCP and CPX titles from the Singles stake. Limited breeds are not eligible for these titles.:

BEST IN FIELD WILL BE OFFERED

GENERAL INFORMATION

A \$25.00 fee will be assessed for any returned checks. Persons exhibiting conduct detrimental to ASFA/DFB any hound(s)/other person(s) will be asked to leave the trial site. There will be a \$5.00 fine for any owner who does not clean up after his/her hound. Hounds must be one year or older on the day of the trial. Hounds with breed disqualifications are not eligible to enter except in the Single Stake. Regular stakes will be split if 20 or more hounds are present in any one stake at the time of the draw. Hounds will be run twice in trios, if possible, or braces, unless excused, dismissed, or disqualified. Bitches in season, hounds with breed disqualifications, and lame hounds will be excused. Hounds not present at the time of Roll Call will be scratched and entry fee will NOT be refunded. All hounds will be checked for breed disqualifications. Monorchid, cryptorchid, spayed or neutered dogs maybe entered. A penalty of \$5.00 will be assessed for any loose hound not competing in the course in progress. Gasoline powered continuous loop machine will be used as field and weather conditions warrant. Lure will consist of white plastic strips or a combination of black and white plastic. Muzzles are not required; it is the responsibility of the owners to determine if their hound should be muzzled.

Continuous loop equipment will be used. Back-up equipment will be available.
Lure will consist of white plastic or a combination of black and white plastic.
Course plans (reversed for finals) are shown below. DFB reserves the right to alter the course plans, as required, by weather and/or field conditions on the day of the trial. This field is fully fenced. Tents are allowed in the parking area. Overnight camping/RV is allowed (contact the FTS for details).
