

### Eligible Breeds and Registries

Only purebred Afghan Hounds, Azawakhs, Basenjis, Borzoi, Cirneco dell'Etna, Greyhounds, Ibizan Hounds, Irish Wolfhounds, Italian Greyhounds, Pharaoh Hounds, Rhodesian Ridgebacks, Salukis, Scottish Deerhounds, Silken Windhound, Sloughis, Whippets may be entered in the regular stakes. Limited breeds may be entered in the Limited Stake or the Singles Stake. Limited breeds currently include purebred Chart Polski, Galgo Español, Magyar Agar, Peruvian Inca Orchid, Portuguese Podengo (Pequeno), Portuguese Podengo (Medio & Grande), and must be individually registered with the appropriate registry.

All entries shall be individually registered with the AKC (including ILP & PAL), the NGA, the UKC, the FCI, an ASFA-recognized foreign or ASFA Board approved registry, or possess a CRN from the SPDBS. A photocopy of acceptable registry must be submitted with each hound's first ASFA field trial entry; this requirement is waived for hounds registered with the NGA.

**RIBBONS:** 1<sup>St</sup> = Blue, 2<sup>nd</sup> = Red, 3<sup>rd</sup> = Yellow, 4<sup>th</sup> = White, NBQ = Green BOB = Purple/Gold, High Scoring Single = Navy/Gold, BIF = Red, White & Blue

# **Regular Stakes Offered**

All hounds entering Open, Veteran, or Limited stakes for the first time must include a completed certification form or waiver (all breeds) and a copy of the hound's registration certification with their entry ( waived for NGA Greyhounds only).

OPEN STAKE: Any eligible sighthound, excluding ASFA Field Champions of record that have met the certification requirements.

FIELD CHAMPION STAKE: Any ASFA Field Champion.

VETERAN STAKE: Any eligible hound whose age is at least six years, except Irish Wolfhounds whose age shall be at least five years, and Afghan Hounds, Rhodesian Ridgebacks, Salukis, and Whippets whose age shall be at least seven years, who have met requirements. Points go toward V-FCh or V-LCM titles.

LIMITED STAKE: Any eligible sighthound of a Limited Stake breed that has met certification requirements. Not eligible to compete in Best of Breed or Best in Field.

SINGLES STAKE: Any eligible sighthound including those disgualified to run in other stakes. Not eligible for Best of Breed or Best in Field. Hounds are eligible to earn TCP and CPX titles from the Singles stake. Limited breeds are not eligible for these titles.


### GENERAL

- 1. All entries must be one year of age or older on the day of the trial. All first time entries entered in Open, Veterans and Limited must have a signed Hound Certification form. As of January 1, 2003, any hound which is first-time entered in a trial, must have a copy of the hound's registration papers to send in with the entry. This is true if the hound is entering Open, Veterans, Singles, or Limited for the first time. Stakes shall be split by public random draw if the entry in any one stake is 20 or more.
- 2. In the Trial, all hounds will run twice, in trios if possible, or braces (except in the Single Stake), unless excused, dismissed, or disqualified.
- 3. Hounds not present at the time of roll call will be scratched. Each entry will be examined at inspection for breed disqualifications. Bitches in season, hounds with breed disqualifications, and lame hounds will be excused. Entry fees for hounds excused during inspection will be refunded. Spayed or neutered hounds and monorchid or crytorchid hounds without breed disqualifications may be entered. Hounds with breed disqualifications are not eligible to enter except in the Single Stake.
- 4. THE FIELD COMMITTEE RESERVES THE RIGHT TO BAR KNOWN AGGRESSIVE HOUNDS FROM THE TRIAL SITE.
- 5. Certifications will be offered before the trial by early entry only.
- 6. THERE WILL BE A \$5.00 FINE ASSESSED FOR ANY <u>LOOSE HOUND</u> NOT TAKING PART IN THE COURSE IN PROGRESS, OR FOR <u>ANYONE NOT</u> <u>PICKING UP</u> AFTER THEIR OWN DOG(S).
- 7. PLEASE BRING YOUR OWN SHADE AND WATER.
- 8. <u>NO ONE</u>, EXCEPT FIELD COMMITTEE, WILL BE ALLOWED ON THE FIELD WITHOUT EXPRESS PERMISSION OF THE FIELD CHAIRMAN.
- 9. Anyone exhibiting unsportsmanlike conduct will be excused from the field for the day.
