ELIGIBLE BREED AND REGISTRY: Only purebred Basenjjs may be entered. All entries shall be individually registered with the American Kennel Club, the United Kennel Club, the Federation Cynologique Internationale, an ASFA-recognized foreign or ASFA Board approved registry. Dogs with an Indefinite Listing Privilege (ILP) or a Purebred Alternate Listing (PAL) from the American Kennel Club shall be considered registered with that body. A photocopy of acceptable registry must be submitted with each hound's first ASFA field trial entry.

REGULAR STAKES OFFERED

OPEN: Any eligible Basenji excluding ASFA Field Champions of record. All first-time entries must be accompanied by a signed Hound Certification form and copy of the registration certificate.

FIELD CHAMPION: Any ASFA Field Champion Basenji.

VETERAN: Any eligible Basenji whose age is at least 6 years. Points & placements go to a V-FCh or V-LCM title. All first-time entries must be accompanied by a signed Hound Certification form and copy of the registration certificate.

SINGLES: Any eligible Basenji including those disqualified to run in other stakes. Each Basenji runs alone and is not eligible to run in Best of Breed competition. Basenjjs are eligible to earn TCP and CPX titles from the Singles Stake.

NON-REGULAR STAKES OFFERED

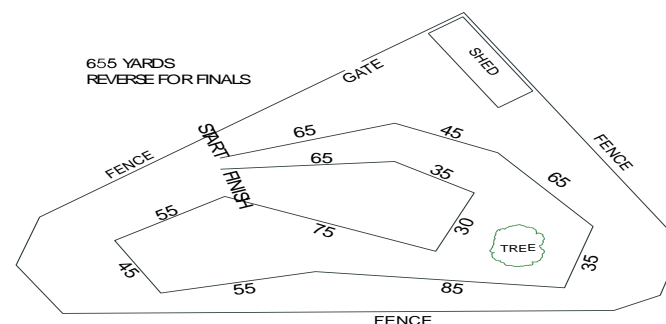
KENNEL STAKE: For Basenjjs; an entry shall consist of two hounds, designated at time of entry, in one of the regular stakes being owned and kenneled by the same person.

BREEDER STAKE: For Basenjjs, which shall have, designated at time of entry, two hounds bred by the same individual.

CONDITIONS OF ENTRY

1. All entries must be one year of age or older on the day of the trial.
2. Stakes shall be split by public random draw if the entry in any one stake is 20 or more.
3. In the Trial, all Basenjjs will run twice, in trios if possible, or braces (except in the Single Stake), unless excused, dismissed, or disqualified.
4. Basenjjs not present at the time of roll call will be scratched. Each entry will be examined at inspection for breed disqualifications. Bitches in season, hounds with breed disqualifications, and lame hounds will be excused. Entry fees for Basenjjs excused during inspection will be refunded. Spayed or neutered Basenjjs without breed disqualifications may be entered; Basenjjs with breed disqualifications are eligible to be entered in the Singles Stake.
5. **Certifications will not be offered.**
6. Battery powered **continuous loop** machines will be used. Lure will consist of white plastic bags. The course will be reversed for the finals and run-offs. Backup equipment will be available.
7. The Field Committee reserves the right to alter the course plan as required by weather and/or field conditions on the day of the trial.
8. **THE FIELD COMMITTEE RESERVES THE RIGHT TO BAR KNOWN AGGRESSIVE BASENJJIS FROM THE TRIAL SITE.**
9. **THERE WILL BE A \$5.00 FINE ASSESSED FOR ANY LOOSE BASENJI NOT TAKING PART IN THE COURSE IN PROGRESS, OR FOR ANYONE NOT PICKING UP AFTER THEIR OWN DOG(S). ALL TRASH, INCLUDING DOG FECES, MUST BE HAULED AWAY BY THE OWNER.**
10. **PLEASE BRING YOUR OWN SHADE AND WATER.**
11. **NO ONE, EXCEPT FIELD COMMITTEE, WILL BE ALLOWED ON THE FIELD WITHOUT EXPRESS PERMISSION OF THE FIELD CHAIRMAN.**
12. Anyone exhibiting unsportsmanlike conduct will be excused from the field for the day.
13. No cigarette smoking permitted on this working farm field.
