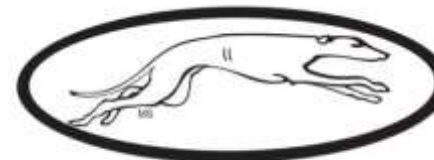

### ELIGIBLE BREEDS & REGISTRY

Only purebred Afghan Hounds, Azawakhs, Basenjis, Borzoi, Cirneco dell'Etna, Greyhounds, Ibizan Hounds, Irish Wolfhounds, Italian Greyhounds, Pharaoh Hounds, Rhodesian Ridgebacks, Salukis, Scottish Deerhounds, Silken Windhound, Sloughis, Whippets, and Provisional breeds

\*may be entered in the regular stake.: There are no Provisional Breeds at this time.

Limited breeds may be entered in the Limited Stake or the Singles Stake. Limited breeds currently include purebred Chart Polski, Galgo Español, Magyar Agar, Peruvian Inca Orchid, Portuguese Podengo (Pequeno), Portuguese Podengo (Medio & Grande), and must be individually registered with the appropriate registry.

All entries shall be individually registered with the AKC (ILP/PAL included), the NGA, the UKC, the FCI, an ASFA-recognized foreign or ASFA Board approved registry, or possess a CRN from the SPDBS. A photocopy of acceptable registry must be submitted with each hound's first ASFA field trial entry; this requirement is waived for hounds registered with the NGA.

### Stakes Offered

**Open:** Any eligible sighthound that has met certification requirements, excluding ASFA Field Champions of record.

**Field Champion:** Any ASFA Field Champion

**Veteran:** Any eligible sighthound that has met certification requirements whose age exceeds 6 years (5 years for IWs; 7 years for Afghans, Rhodesian Ridgebacks, Salukis and Whippets).

**Singles:** Any eligible sighthound including those disqualified to run in other stakes. (Hounds run alone and are not eligible for BOB or BIF) Hounds eligible to earn TCP and CPX titles from the Singles stake. Limited breeds are not eligible for these titles.

**Limited:** Any eligible sighthound of a Limited breed that has met certification requirements. Not eligible to compete in BOB or BIF

### General Information

- All entries must be one year of age or older on the day of the trial.
- Stakes will be split into flights by public random draw if the entry in any regular stake is 20 or more.
- Bitches in season, lame hounds and hounds with breed disqualifications will be excused.
- Substitutions (same owner) are allowed if the FTS is notified 30 minutes prior to roll call.
- Spayed and neutered, monorchid and cryptorchid hounds without breed disqualifications may be entered. Hounds with breed disqualifications are not eligible to enter except in the Single Stake.
- Hounds not present at roll call will be scratched.
- All hounds will run twice, in trios if possible or braces, (except in the Single Stake), unless excused, dismissed or disqualified.
- Battery powered, continuous loop equipment will be used. Lures will consist of highly visible plastic strips and/or fur. Back-up equipment will be available.
- A \$5.00 fine will be assessed for any loose hound on the field that is not competing in the course in progress.
- GANG reserves the right to alter course due to field and/or weather conditions on the day of the trial.
- Any person may, upon reasonable complaint, be asked to leave the grounds by the Field Committee.
- There will be a minimum \$25 returned check charge.

**BEST IN EVENT will be offered on Monday, May 30. In order to be eligible to compete, hounds must have competed in BOTH events and won BOB either Sunday or Monday**

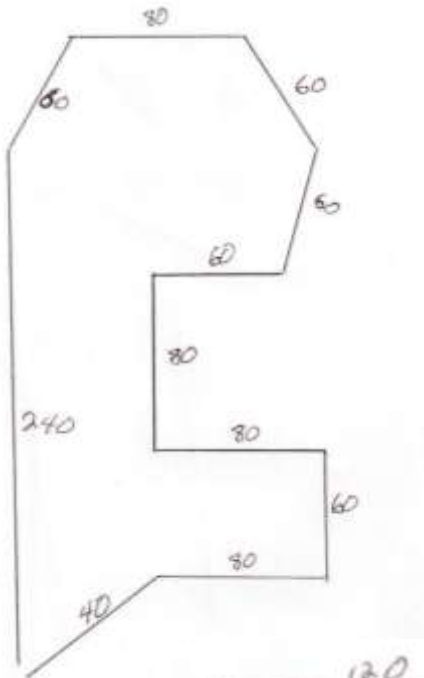
## Course Plans

### Field Conditions

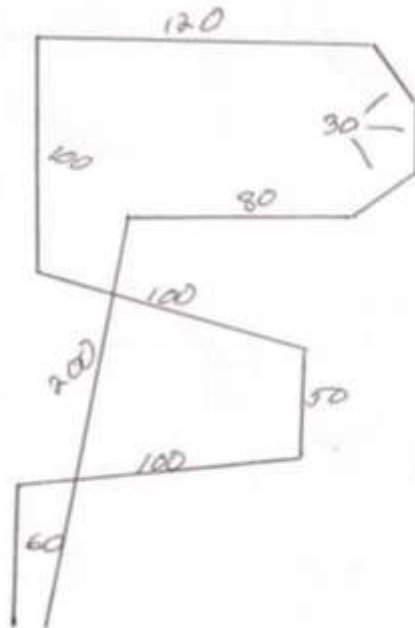
The field is grass, which has been occasionally mowed. It is a hayfield and is not perfectly groomed, but it is level to gently sloping.
