ELIGIBLE BREEDS & REGISTRY

Only purebred Afghan Hounds, Azawakhs, Basenjis, Borzoi, Cirneco dell'Etna, Greyhounds, Ibizan Hounds, Irish Wolfhounds, Italian Greyhounds, Pharaoh Hounds, Rhodesian Ridgebacks, Salukis, Scottish Deerhounds, Silken Windhound, Sloughis, Whippets in the regular stakes. Limited breeds may be entered in the Limited Stake or the Singles Stake. Limited breeds currently include purebred Chart Polski, Galgo Español, Magyar Agar, Peruvian Inca Orchid, Portuguese Podengo (Pequeno), Portuguese Podengo (Medio & Grande), and must be individually registered with the appropriate registry.

All entries shall be individually registered with the AKC (including ILP & PAL), the NGA, the UKC, the FCI, an ASFA-recognized foreign or ASFA Board approved registry, or possess a CRN from the SPDBS. A photocopy of acceptable registry must be submitted with each hound's first ASFA field trial entry; this requirement is waived for hounds registered with the NGA.

As of January 1, 2003, any hound which is first-time entered in a trial, must have a copy of the hound's registration papers to send in with the entry. This is true if the hound is entering Open, Veterans, Singles, or Limited for the first time.

STAKES OFFERED

OPEN: Any eligible sighthound, excluding ASFA Field Champions of Record.

FIELD CHAMPION: Any ASFA Field Champion.

VETERAN STAKE: Any eligible hound whose age is at least six years, except Irish Wolfhounds whose age shall be at least five years, and Afghan Hounds, Rhodesian Ridgebacks, Salukis, and Whippets whose age shall be at least seven years. Points go toward V-FCh or V-LCM titles."

LIMITED: Any eligible sighthound of a Limited stake breed that has met certification requirements. Not eligible to compete in Best of Breed or Best in Field.

SINGLES: Any eligible sighthound including those disqualified to run in other stakes. Hounds are not eligible to run in BOB or BIF. Hounds are eligible to earn TCP and CPX titles from the Singles Stake. Limited breeds are not eligible for these titles.

BEST IN FIELD: will be offered both days.

GENERAL

1. All entries must be one year of age or older on the day of the trial.
2. Stakes shall be split by public random draw if the entry in any one stake is 20 or more at the time of the draw.
3. All hounds will run twice, in trios if possible, or braces, unless excused, dismissed, or disqualified.
4. Hounds not present at the time of roll call will be scratched. Bitches in season, lame hounds, and hounds with breed disqualifications will be excused at roll call. Spayed, neutered, monorchid or cryptorchid hounds without breed disqualifications may be entered. Hounds with breed disqualifications are not eligible to enter except in the Singles Stake.
5. Battery powered **continuous loop** machines will be used. Lure will consist of white plastic bags. The course will be reversed for the finals and run-offs. Backup equipment will be available.
7. The field committee reserves the right to alter the course plan as required by weather and/or field conditions on the day of the trial.
8. **THE FIELD COMMITTEE RESERVES THE RIGHT TO BAR KNOWN AGGRESSIVE HOUNDS FROM THE TRIAL SITE.**
9. **THERE WILL BE A \$10.00 FINE ASSESSED FOR ANY LOOSE HOUND NOT TAKING PART IN THE COURSE IN PROGRESS, OR FOR ANYONE NOT PICKING UP AFTER THEIR OWN DOG(S).**
10. **PLEASE BRING YOUR OWN SHADE AND WATER.**
11. Anyone exhibiting unsportsmanlike conduct will be excused from the field for the day.

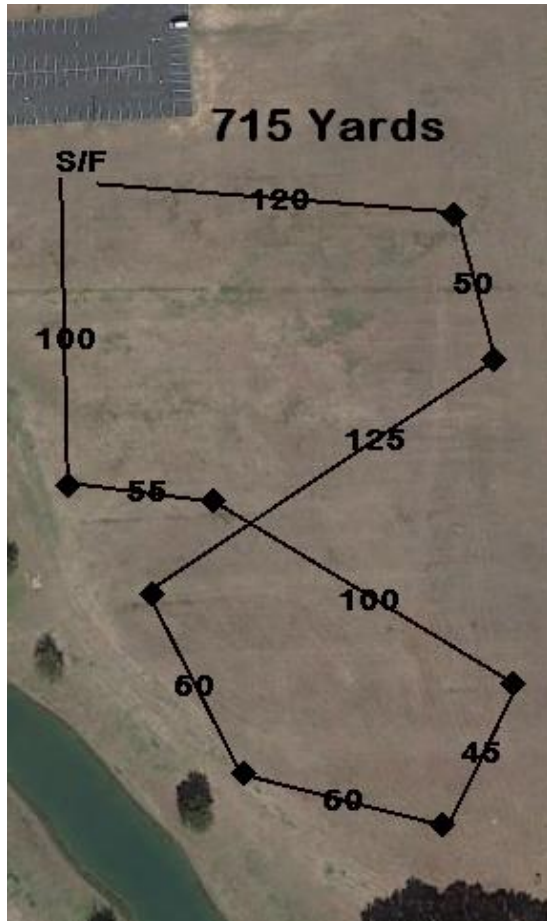

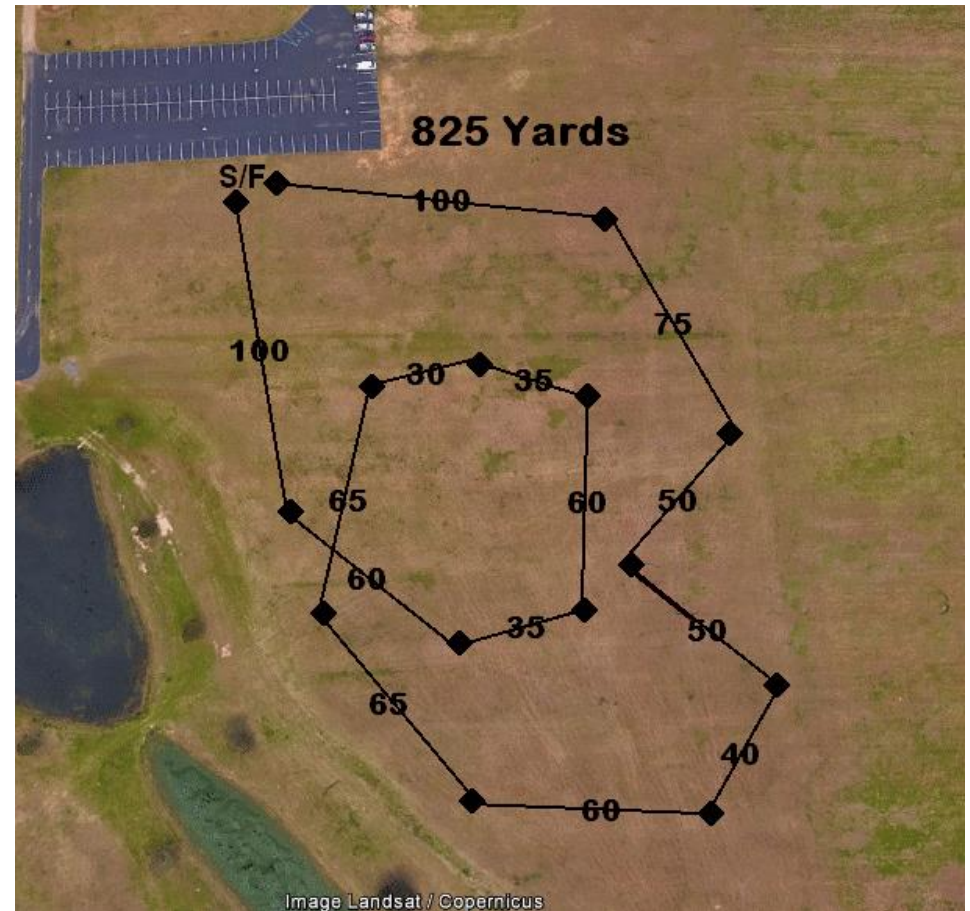
