Only purebred Afghan Hounds, Azawakhs, Baseniis, Borzois, Cirneco dell'etnas, Greyhounds, Ibizan Hounds, Italian Greyhounds, Irish Wolfhounds, Pharaoh Hounds, Rhodesian Ridgebacks, Salukis, Scottish Deerhounds, Sloughis, Silken Windhounds and Whippets may enter. 


