Eligible Breeds & Registration

Purebred Afghan Hounds, Azawakhs, Basenjis, Borzoi, Cirnechi dell'Etna, Greyhounds, Ibizan Hounds, Irish Wolfhounds, Italian Grevhounds, Pharaoh Hounds, Rhodesian Ridgebacks, Salukis, Scottish Deerhounds, Silken Windhounds, Sloughis and Whippets may be entered in all stakes, except Limited and LCI.

Limited breeds may be entered in the Limited Stake or Singles Stake. Limited breeds currently include purebred Chart Polski, Galgo Español, Magyar Agar, Peruvian Inca Orchid, Portuguese Podengo (Pequeno), and Portuguese Podengo (Medio & Grande). They must be individually registered with the appropriate registry.

All entries in the above stakes shall be individually registered with the AKC (including ILP and PAL), the NGA, the UKC, the FCI, an ASFA-recognized foreign or ASFA Board approved registry, or possess a CRN from the SPDBS. A photocopy of acceptable registry must be submitted with each hound's first ASFA field trial entry; this requirement is waived for hounds registered with the NGA

Stakes Offered

REGULAR STAKES

OPEN STAKE: For any eligible sighthound that has met certification requirements, excluding ASFA Field Champions of record.

FIELD CHAMPION STAKE: For any ASFA Field Champion of record. Except that hounds whose owner records show them to be ASFA Field Champions may be entered for a period up to 90 days without official certification. Hounds whose owner records show them to have met the requirements for the Field Champion title may be changed from the Open stake to the Field Champion stake provided notification is made to the Field Trial Secretary prior to roll call. Hounds determined to be not eligible to compete in the Field Champion stake will forfeit all points and placements earned in that stake toward an LCM.

VETERAN STAKE: For any eligible sighthound whose age is at least six years and who has met certification requirements. Except Irish Wolfhounds, whose age shall be at least five years, and Afghans, Rhodesian Ridgebacks, Salukis and Whippets, whose age shall be at least seven years. Points earned in this stake go toward V-FCH and V-LCM titles.

LIMITED STAKE:

For any eligible sighhound of a Limited breed that has met the certification requirements. All rules pertaining to Open Stake shall apply to Limited Stake, except when inconsistent with the following. No ASFA points or placements towards a Field Championship or an LCM will be awarded. Limited Stake breeds are not eligible to compete for Best in Field or Best in Event.

SINGLES STAKE: For any eligible sighthound including sighthounds disgualified to run in other stakes. Each hound runs alone and is not eligible to compete for Best of Breed, Best in Field, or Best in Event . Hounds are eligible to earn TCP & CPX titles from this stake.

Conditions of Entry (applies to all stakes)

- > Hounds must be one year of age or older on day of trial.
- Stakes will be split into flights by public random draw if the entry in any stake is 20 or more.
- Females in season, lame hounds/dogs and those that are unfit to course will be excused at roll call.
- Hounds with breed disqualifications that are entered in regular breed stakes will be excused at roll call.
- Spayed, neutered, monorchid or cryptorchid without breed disqualifications may be entered in regular hound breed stakes.
- > Hounds with breed disqualifications are eligible to enter Singles Stake.
- > Hounds/dogs not present at the time of roll call will be scratched.
- > All hounds/dogs will be run twice unless excused, dismissed or disqualified.
- > All hounds/dogs will run in trios if possible, or braces (except in Singles and LCI stakes).
- > A separate entry form is required for each dog for each day.
- All partipants must read, understand, sign, and comply with the ASFA Lure Coursing Event COVID-19 Acknowledgement and Liability Waiver

Other Information

- Battery powered continuous loop lure machine will be used. Backup equipment will be available.
- > Lure will consist of highly visible plastic strips.
- > Exhibitors are requested to not bring bitches known to be in season to the field.
- > There will be a \$5.00 fine assessed for any loose hound not participating in the course.
- Any person may, upon reasonable complaint, be asked to leave the grounds of the field trial by the Field Trial Committee.
- > The field is partially fenced.
- > Children must be under control of their parents or guardians at all times.

Procedures for COVID-19 Safety

- ✓ We will follow State of Minnesota and local guidelines.
- ✓ Bring your own facial covering. All participants will be required to wear facial coverings when not in their cars.
