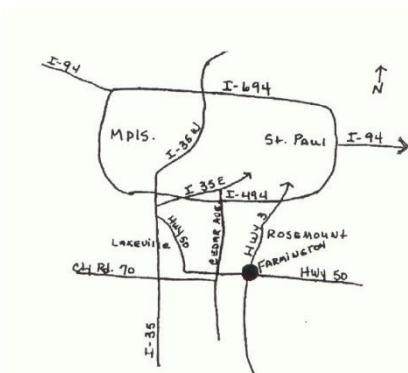

Directions to the Field: From either north or south on I-35, take exit 81 east (County Road 70). Follow 70 east about 3 miles to Cedar Avenue. Turn left on Cedar about 1/8 mile to Highway 50. Turn right (east) on 50 to Farmington. Follow the signs to the Dakota County Fairgrounds. These trials will be held on the **NORTH FIELD.**



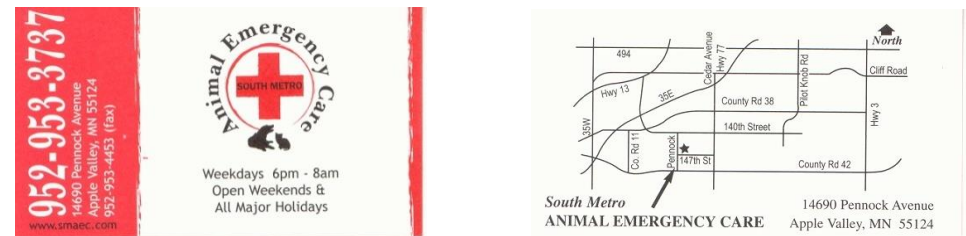
