ELIGIBLE BREEDS & REGISTRY

Only purebred Afghan Hounds, Azawakhs, Baseniis, Borzoi, Cirneco dell'Etna, Grevhounds, Ibizan Hounds, Irish Wolfhounds, Italian Greyhounds, Pharaoh Hounds, Rhodesian Ridgebacks, Salukis, Scottish Deerhounds, Sloughis, Silken Windhounds, and Whippets may be entered in the regular stakes. Limited breeds may be entered in the Limited Stake or the Singles Stake. Limited breeds currently include purebred Chart Polski. Galgo Español. Magyar Agar. Peruvian Inca Orchid. Portuguese Podengo (Pequeno). Portuguese Podengo (Medio & Grande), and must be individually registered with the appropriate registry.

All entries shall be individually registered with the AKC (including ILP and PAL), the NGA, the UKC, the FCI, an ASFA-recognized foreign or ASFA Board approved registry, or possess a CRN from the SPDBS. A photocopy of acceptable registry must be submitted with each hound's first ASFA field trial entry; this requirement is waived for hounds registered with the NGA.

Late, incomplete, unsigned or conditional entries will not be accepted. Entries will NOT be acknowledged by mail. Preliminary courses for all breeds will be completed before beginning final courses.

STAKES OFFERED:

Open Stake: Any eligible sighthound, excluding ASFA Field Champions of record.

Field Champion Stake: Any ASFA Field Champion of record.

Veteran Stake: Any eligible sighthound whose age is at least 6 years. except Irish Wolfhounds whose age shall be at least 5 years, Afghan Hounds, Rhodesian Ridgebacks, Salukis, and Whippets whose age shall be at least 7 years. Points go toward V-FCH or V-LCM titles.

Limited Stake: Any eligible sighthound of a Limited stake breed that has met certification requirements. Not eligible to compete in Best of Breed or Best in Field.

Single Stake: Any eligible sighthound including those disgualified to run in other stakes. Each hound runs alone. Not eligible for Best of Breed or Best in Field. Hounds are eligible to earn TCP and CPX titles from the Singles stake. Limited breeds are not eligible for these titles.

All hounds entering Open, Veteran, or Limited stakes for the first time MUST include a completed ASFA certification form or waiver form and a copy of the hound's registration certificate (registration is not required for NGA Greyhounds ONLY: certification or waiver is not required for Singles stake entries ONLY).

Best in Field will NOT be offered.

Conditions of Entry: All entries must be one year or older on the day of the trial. • Stakes will be solit into flights by public random draw if the entry in any regular stake is 20 or more. • Bitches in season, lame hounds and hounds with breed disgualifications will be excused at roll call. Spayed, neutered, monorchid or cryptorchid hounds without breed disqualifications may be entered; hounds with breed disqualifications are not eligible to enter except in the Single Stake. • Hounds not present at the time of roll call will be scratched. • All hounds will run twice, in trios if possible or braces (except in the Single Stake), unless excused, dismissed or disgualified.

• Hound certification runs will be offered after the trial on Friday only.

A penalty of \$5.00 will be assessed for any loose hound not competing in the course in progress.

Equipment: Battery powered continuous loop lure machine will be used; backup equipment will be available. Lure will consist of highly visible plastic strips.




