

First Place -Blue, Second Place – Red, Third Place –Yellow, Fourth Place –White, NBQ -Green High Scoring Single - Navy and Gold, Best of Breed - Purple and Gold, Best in Regional- Red, White, Blue

TRIAL INFORMATION

Trial Hours – **7:30 am** until completion. Roll Call – **8:30 am** – No Exceptions or Excuses. There will be a verbal roll call, if you are NOT PRESENT before the conclusion of roll call, you will be considered **ABSENT AT ROLL CALL!** Entry Fee will not be refunded when absent. Entries will not be acknowledged by mail or email

All hounds entering Open, Veteran, or Provisional stakes for the first time MUST include a completed ASFA certification form, AKC QC form or waiver form and a copy of the hound's registration certificate (registration is not required for NGA Greyhounds ONLY; certification or waiver is not required for Singles stake entries ONLY). If the paperwork is not present it will be considered a conditional entry. Conditional Entries are not accepted.

ELIGIBLE BREEDS & REGISTRY

Only purebred Afghan Hounds, Azawakhs, Basenjis, Borzoi, Cirneco dell'Etna, Greyhounds, Ibizan Hounds, Irish Wolfhounds, Italian Greyhounds, Pharaoh Hounds, Rhodesian Ridgebacks, Salukis, Scottish Deerhounds, Silken Windhound, Sloughis, Whippets, and Provisional breeds may be entered in the regular stakes. Current Provisional breeds include purebred Chart Polski, Galgo Español, Magyar Agar, Peruvian Inca Orchid, Portuguese Podengo (Pequeno), Portuguese Podengo (Medio & Grande), and must be individually registered with the appropriate registry.

All entries shall be individually registered with the AKC (including ILP & PAL), the NGA, the UKC, the FCI, an ASFA-recognized foreign or ASFA Board approved registry, or possess a CRN from the SPDBS. A photocopy of acceptable registry must be submitted with each hound's first ASFA field trial entry; this requirement is waived for hounds registered with the NGA.

Regional Invitational Eligibility: Any hound that is ASFA pointed is eligible to enter a Regional Invitational in an appropriate stake, including Single Stake, if offered. For a Provisional breed to be eligible, the hound must have received a placement with competition. All points or placements must be earned by the closing date of the event. An eligible hound may be entered in any number of Regional Invitationals. Hounds entered in the Single Stake are not eligible to be entered in Breeder, Kennel, or Bench stakes.

STAKES OFFERED

<u>Open</u>: Any eligible sighthound that has met certification requirements, excluding ASFA Field Champions of record.

Field Champion: Any ASFA Field Champion.

- <u>Veteran</u>: Any eligible sighthound that has met certification requirements whose age is at least six years, except Irish Wolfhounds whose age shall be at least five years, and Afghans, Rhodesian Ridgebacks, Salukis and Whippets whose age shall be at least seven years. Points go toward V-Fch or V-LCM titles.
- Singles: Any eligible sighthound including those disqualified to run in other stakes. Not eligible for Best of Breed or Best in Field. Hounds are eligible to earn TCP (Title of Coursing Proficiency) and CPX (Coursing Proficiency Excellent) titles from the Singles stake. Provisional breeds are not eligible for these titles.
- **Provisional**: Any eligible sighthound of a Provisional stake breed that has met certification requirements. Not eligible for Best of Breed or Best in Field.
- Lure Coursing Instinct: Any hound of 1 year of age, registered with ASFA, AKC, CKC FSS. PAL or Canine Partner registrations are accepted. Entries will be limited to 15 hounds.

Best in Field will not be offered Saturday Best in Regional will be offered on Sunday.

HCA reserves the right to alter the course as required by weather and/or field conditions on the day of the trial. The course will be reversed for finals and again for run-offs or at the discretion of the judges.

- All entries must be one year of age or older on the day of the trial.
- Stakes will be split if 20 or more hounds of the same breed are present, in any one stake, after inspection at the time of the draw.
- All hounds will run twice, in trios if possible, or braces, unless excused, dismissed or disqualified.
- Money will only be refunded for Bitches in season, lame hounds, or hounds with breed disqualifications.
- Each hound will be inspected for lameness, breed disqualifications, and bitches in season.
- Monorchid, spayed and neutered hounds without breed disqualifications may be entered.
- Hounds with breed disqualifications are not eligible to enter except in the Single Stake.
- Hounds not present at time of roll call will be scratched.
- Muzzles are not required, but it is the responsibility of the owner to determine if the hound should be muzzled.
- Dogs may not be tied or staked out. There will be a **\$5** penalty fee for any hound loose on the field, other than those running the course in progress.
- Lure coursing blankets may be provided by the club.
- A battery powered continuous loop machine will be used. Backup equipment is available.
- The Lure will consist of white plastic bags.
- The course will be reversed for finals.
- There is available water, shade & restroom facilities at the site.
- HCA reserves the right to alter the course plans due to weather and/or field conditions.
- Incomplete, unsigned, conditional, or late entries <u>WILL NOT</u> be accepted.

DIRECTIONS TO THE FIELD


<u>From the Kansas City Area</u> – I-35 to I-435 West to Highway 10 to Lawrence. Take Hwy 10 to Clinton Parkway on the West side of Lawrence. Turn Left, stay on Clinton Parkway until it dead-ends. Turn Right. Stay on this road to Clinton State Park entrance – 2^{nd} left. Turn left into the park, it is before the RV Storage.

<u>For I-70 Drivers</u> – Take I-70 (East from Topeka, West from Kansas City), exit at Lecompton, turn South, this is Highway I0. Take this to the Clinton Parkway Exit, at the stop sign, turn right. At the next stop sign, turn right again, then take your 2nd left into Clinton State Park.

In the Park – Once in the park, go through the Permit Station, have your \$\$\$ ready, (you only need a 1 day pass, as they are good til 2 pm the following day). Get back on the main park road, Take the 2nd left, this is a horseshoe drive, follow it, and you will find us. Watch for the Yellow ASFA signs.

*This is a state park, they require permits. If you have a permit from any other state park, you might be able to get a discount – be sure to check!!

Open to all breeds of an age of 1 year or more. All entries shall be individually registered with the AKC (including ILP & PAL), the UKC, the FCI, a ASFArecognized foreign or ASFA Board approved registry, or possess a CRN from the SPDBS. A photocopy of acceptable registry must be submitted with each dog's first ASFA field trial entry. Neutered and spayed dogs without a recognized registry number may obtain an ASFA ID number for a \$10 registration fee at time of entry.

This stake will be Provisional to a total of 15 entries per day.

- Small Open: for dogs 17-1/2 inches or less at the withers and / or brachycephalic ("flat-faced") dogs who have not achieved the title of LCC.
- **Small Senior:** for dogs 17-1/2 inches or less at the withers and/or brachycephalic dogs who have achieved the title of LCC.
- Small Veteran: for dogs 17-1/2 inches or less at the withers and/or brachycephalic dogs over the age of 7 years.
- Large Open: for dogs over 17-1/2 inches at the withers who have not achieved the title of LCC.
- Large Senior: is for dogs over 17-1/2 inches at the withers who have achieved the title of LCC.
- Large Veteran: for dogs over 17-1/2 inches at the withers who are over the age of 7 years.
- **Sighthound mix Open:** for dogs with a sighthound breed in its background who have not achieved the title of LCC.
- **Sighthound mix Senior**: for dogs with sighthound breed in its background who have achieved the title of LCC.
- **Sighthound mix Veteran:** for dogs with sighthound breed in its background over the age of 7 years.

Size S is for dogs shorter than 17.5 inches at the withers and/or brachycephalic ("flat-faced") dogs.

Size L is for all dogs over 17.5 inches at the withers.

Size S will run 50% of the course as laid out in this premium up to a maximum of 400 yards. All other sizes will run the full course length.

REGIONAL INVITATIONAL PERPETUAL TROPHIES

AFGHAN HOUND - The McGovern Trophy - Donated by Tom and Pauline McGovern, longtime Des Moines area residents and members of the Iowa Coursing Association. Tom and Pauline bred and showed Afghans, Borzois, Ibizans and Salukis.

BASENJI - The Anubis Trophy - Donated by Daniel and Tomoko Magnan. The Anubis Cup is awarded to the Basenji Best of Breed winner at the Region 5 Regional Event. The basenji made an appearance in civilization at the dawn of history as a palace dog of the pharaohs. So long ago that they watched the Pyramids being built. They are pictured in the bas-relief and sculptured in stone as far back as 4000 B.C. In fact, the hieroglyph for dog, depicted on the front of the award resembles a basenji. The basenji is one of the few natural breeds recognized by the American Kennel Club. The small, dark oblique eye, the wrinkled forehead, the pliable skin, the fine coat, the curled tail and the precious quality of reticence are part of the basenji's character. Their wrinkled forehead imparts an anxious expression to their face, the look of one who, having known man from the beginning, is terribly worried about the outcome. In coursing, they are known for stamina, agility, durability, and surprising speed for their size. This is due to their horse-like double-suspension gallop running style. Basenjis are clever runners, with a tendency to

learn to outquess the direction of the lure early in their careers. When running with familiar dogs, they tend to run cooperatively, but when running with unfamiliars, some stop at nothing to get to the lure first. While not as fast as some of the other breed, they hold their own in head to head competition. Some say a basenji only runs as fast as it must. When running against other, faster hounds, they tend to run faster. Whether their ancestors arrived here in the 1930s or 1980s, basenjis remain close to their wild roots and still have a wild and fiercely independent nature. Owners will testify to their phenomenal intelligence, inventiveness, curiosity, and clownish sense of humor. Although generally silent they can make a variety of unique sounds. From yodels, howls, crows, snarls and chortles, to a growl worthy of a dog twice the size. They also make some sounds that are beyond description. Often described as catlike, basenjis think for themselves, don't like getting wet, love to shred tissues, enjoy basking in the sun, are adept climbers, and even groom themselves and each other. They are still driven by their hunting heritage, and will give chase to any animal that runs, or flies, from them. In modern Africa they are used by natives for net-hunting. The Anubis cup recognizes the unique contribution basenjis make to lure coursing and the canine species' role of man's best friend.

BORZOI - The Ravenwolf Trophy - Donated by John and Susan Weinkein. Ravenwolf Borzoi, in memory of Ch. Ravenwolf Phaedra, CD, LCM. Phaedra was one of only a handful of Borzoi to win the triple titles of CH, CD, and LCM. She placed in the Top Ten in both coursing and obedience standings. Her off-spring from two litters have achieved AKC championship titles, as well as ASFA Field championship titles. John and Susan were involved in coursing from 1975 to 2003.

GREYHOUND - The Savanna Trophy - Donated by Shelly Johnson, is dedicated to two outstanding Greyhounds whose contributions to ASFA lure coursing will not be forgotten. "Lady", EF Katie Ann, LCM2: Lady's accomplishments in Region V included 2 Regional Invitational BOB's, 5 BIFs and winning the "Run for the Bunnies" in 1996. She also honored our Region by becoming the #1 ASFA Greyhound in 1994. Sadly, we lost Lady due to bone cancer in February of 2002. "Beeline", BII Beeline B Quick, LCM 3: Beeline's accomplishments in Region V include 2 Region Invitational BOBs, 8 BIFs, and winning The Harvest Cup (1994), the Minnesota Cup (1995), and the Director's Cup (1996). She has been in ASFA Top Ten 4 times, nominated for the ASFA Hall of Fame twice, and in 1998 brought great honor to Region V by winning BII at ASFA's most prestigious event. During the 5 years of Beeline's coursing career she traveled all over the U.S. and always remained a wonderful ambassador for our Region.

IRISH WOLFHOUND - The Faol Cu Trophy - Donated by Gayle K. Curtis, Magma Irish Wolfhounds and A.I. (Nina) Gottsch,

Ianina's Irish Wolfhounds. Is offered for the BOB Irish Wolfhound at the ASFA Region V Invitational. Its purpose is to

acknowledge the requirements necessary of the Irish Wolfhound to do the job it was bred to do; recognizing the speed the houndneeds to catch their prey and the strength required to dispatch it. RHODESIAN RIDGEBACK - The Lion's Trophy - Donated by Dawn Gibas-Ferris and Scott Tracey. The trophy is offered in

recognition of the power, stamina and "lion's" heart demonstrated both on and off the field by this wonderful breed. The perpetual honors the champions of today, and pays homage to the legacy of those champions who have passed this way before.

SALUKI - The AmunRa Cup - Donated by Kathy Nelson in recognition of all the beautiful dogs and the unending stamina they

continue to demonstrate at these trials. The trophy honors those who have gone before us with high standards for those who follow. Each year the winner of the trophy will add a photo as the winning hound.

WHIPPET - The Northwind Cup - Is offered in honor of Can. CH. Northwind's Dash to Bryton, Am/Can Fch. Am/Can CD by Kay Nierengarten and Mark Shubert. Dash, a strong, powerful runner, retired at five when he sustained permanent injury on the coursing field. He was 30 points short of an LCM and 12 points short of a Can. FCHX with all placements. We applaud his indomitable spirit, which survived complete paralysis on the field, a dislocated vertebrae, displaced spinal cord and ten weeks in a body cast before resuming many normal activities.

SKEEZIX TROPHY - In honor of Skeezix (Ba), Skeezix, LCM 2. This trophy is awarded to the highest scoring rescue of any breed. This hound must have been adopted from a shelter or legitimate rescue organization, must have an ILP number, must be spayed or neutered, and have earned a qualifying score. This trophy was donated by Mickey Rubin to symbolize that broken lives can be repaired.

BEST IN FIELD - The Director's Cup - is a perpetual trophy originated in 1992 by Region V Director, Frank Zaworski, to honor the hound winning Best In Field at the Region V Invitational. Frank became involved in lure coursing in 1968 and has been judging coursing trials since 1973. He and his wife, Linda, have been involved with Whippets since 1977.
