


TRIAL HOURS: 8:00 am to completion. ROLL CALL: 9:00 am all breeds.

RIBBONS: Ribbons will be awarded for all placements 1st - NBQ. Rosettes will be awarded for BOB, BIF, High Scoring Single, and new ASFA titles. All placements will receive a prize.

ELIGIBLE BREEDS & REGISTRY

Only purebred Afghan Hounds, Azawakhs, Basenjis, Borzoi, Cirneco dell'Etna, Greyhounds, Ibizan Hounds, Irish Wolfhounds, Italian Greyhounds, Pharaoh Hounds, Rhodesian Ridgebacks, Salukis, Scottish Deerhounds, Sloughis, Silken Windhounds, and Whippets. Limited breeds may be entered in the Limited Stake or the Singles Stake. Limited breeds currently include purebred Chart Polski, Galgo Español, Magyar Agar, Peruvian Inca Orchid, Portuguese Podengo (Pequeno), Portuguese Podengo (Medio & Grande), and must be individually registered with the appropriate registry.

All entries shall be individually registered with the AKC (including ILP/PAL), the NGA, the UKC, the FCI, an ASFA-recognized foreign or ASFA Board approved registry, or possess a CRN from the SPDBS. A photocopy of acceptable registry must be submitted with each hound's first ASFA field trial entry; this requirement is waived for hounds registered with the NGA.

Any entry marked "First time entered" must present the judge-signed ASFA Hound Certification or waiver certificate AND a copy of the hound's registration, except NGA, to the secretary BEFORE entries close. A Field Secretary shall refuse any entry for the **Open**, **Veteran** or **Limited stake marked "First Time Entered"** if it is not accompanied by a Hound Certification, unless the hound has a title which waives this requirement, and a copy of the hound's registration. Entries without a hound

certification/waiver certificate will be considered **incomplete** and **will not be accepted**. (See back of entry form for hound certification/waiver certificate. Keep a copy of the certification for your records.)

REMINDER: First time "single" entrants do not need a hound certification/waiver.

STAKES OFFERED

The hound certification requirement applies to hounds entered for the first time.

OPEN: Each stake shall consist of entries of only one breed, dog and bitches that have met certification requirements, excluding ASFA Field Champions of record.

FIELD CHAMPION: Any ASFA Field Champion.

VETERAN: Any eligible hound whose age is at least six years, except Irish Wolfhounds whose age shall be at least five and Afghans, Rhodesian Ridgebacks, Salukis, and Whippets whose age shall be at least seven years. Points go toward V-FCh or V-LCM titles.

LIMITED STAKE: Any eligible sighthound of a Limited breed that has met certification requirements. Not eligible to compete in Best of Breed or Best in Field.

SINGLE STAKE: Any eligible sighthound including those disqualified to run in other stakes. Each hound runs alone. Not eligible for Best of Breed or Best in Field. Hounds are eligible to earn TCP and CPX titles from the Singles stake. Limited breeds are not eligible for these titles.

BEST IN FIELD: Will be offered Saturday. The Denny Reed Memorial Run is on Sunday.

Conditions of Entry:

- All hounds will run twice, in trios if possible or braces (except in the Single stake), unless excused, dismissed or disqualified.
- All entries must be one year or older on the day of the trial.
- Stakes will be split into flights by public random draw if the entry in any regular stake is 20 or more.
- Bitches in season, lame hounds, and hounds with breed disqualifications will be excused at roll call.
- Hounds not present at the time of roll call will be scratched.
- Certification runs will be offered Saturday only before the trial.
- Spayed, neutered, monorchid, or cryptorchid hounds without breed disqualifications may be entered.
- Hounds with breed disqualifications are not eligible to enter except in the Single Stake.
- A penalty of \$5 will be assessed for any loose hound not competing in the course in progress.

EQUIPMENT AND COURSE PLAN

- The lure machine is a battery powered, continuous loop system. Back-up equipment will be available.
- Lures are white, plastic strips.
- ICA reserves the right to alter the course plan as required by weather and/or field conditions
 on the day of the trial.
- Total course length is 650 yards on Saturday and 800 yards on Sunday.
- The course will be reversed for final courses. BOB (and runoffs) will be run in the direction indicated. BIF will be a reverse run of the BOB course.

REMINDER - FIRST TIME ENTRIES

A copy of the hound's registration be submitted with a hound's first ASFA field trial entry, except for hounds registered with the NGA.

HOUND CERTIFICATION

Certifications: Any entry marked **"First time entered"**, must present the judge-signed ASFA Hound Certification or waiver certificate and a copy of the hound's registration to the secretary **BEFORE** entries close. Entries without a hound certification/waiver certificate and/or copy of the hound's registration, except NGA, will be considered **incomplete and will not be accepted**. (See back of entry form for hound certification/waiver certificate. **Keep a copy of the certification for your records**.) First time single entrants do not need a hound certification/waiver

A Hound must be at least eleven months old to run in a certification course.

A certification run will be offered before the trial on Saturday only. Hound Certification runs are \$5.00 per run. Please check with the field secretary to pre-enter. It is the responsibility of the entrant to find another hound of the same breed (or similar running style) to run with his/her dog for the certification.

PRACTICES and Lure Operator Training

Practices will be run on Sunday only (weather and equipment permitting) <u>after</u> the trial is completed.

ROUTES TO THE LOCATION

If you have problems finding the field, call Jocelyn Petersen (319) 269-4178.

Please be aware that there is road construction with alternating lane closures on Hwy 218 North of Cedar Falls which is expected to last until Fall 2016. During this time there is no access to Cedar Wapsi Road. The lowa DOT has detour signs marking the alternate routes to Waverly Road. Additionally, the directions below detail how to find the field without using Cedar Wapsi Road. Please allow yourself adequate time to navigate the detour.

Via I-35 from the North:

- Take Exit #190 for US-18 E/IA-27 S
- Follow IA-27 S/US-218 S approx. 73 miles to Exit #195 & continue to the Round-About
- At the Round-About, take the 2nd "exit" to continue SOUTH on Wildcat Way where you'll
 encounter a RIGHT turn (WEST) onto East 7th Street
- Follow East 7th Street WEST to the stop sign where you'll turn LEFT (SOUTH) onto Waverly Road
- Follow Waverly Road 2.3 miles to Antique Acres on your left

Via US-63 from the North:

- Follow US-63 South to Denver (IA) where you will exit onto 260th Street
- Follow 260th Street WEST aprox. 1.5 miles where it will curve LEFT (SOUTH) and turns into Joplin Avenue
- Follow Joplin Avenue SOUTH approx. 1.6 miles to 275th Street
- Turn RIGHT (WEST) onto 275th Street
- Follow 275th street WEST approx. 3.7 miles to a Round-About where you'll take the 1st "exit" to continue WEST on 275th Street
- At the next Round-About, take the 2nd "exit" to continue SOUTH on Wildcat Way where you'll encounter a RIGHT turn (WEST) onto East 7th Street
- Follow East 7th Street WEST to the stop sign where you'll turn LEFT (SOUTH) onto Waverly Road
- Follow Waverly Road 2.3 miles to Antique Acres on your left
