In an effort to reduce the possible spread of COVID-19, we strongly encourage all participants to purchase their own sipleads & and lure coursing jackets.

Please bring a completed and signed copy of the “Lure Coursing Event COVID-19 Acknowledgement & Liability Waiver” to roll call on the day of the trial.

Registration

All dogs entered in LCI stake must have a registration number. If your dog is registered under any of options A – E below, then you must attach a copy (not the original) of the registration certificate to your dog’s first ASFA trial entry form. If your dog is not registered under any of the options A – E below, then you may obtain a registration number under paragraph F below.

- A. A registration from AKC or CKC as one of their recognized breeds, or
- B. A registration from AKC Canine Partners or CKC (CCN) as a mixed-breed or other ineligible dog for registration under A (above), or
- C. A registration from AKC PAL (Purebreed Alternative Listing), as a pure breed dog ineligible for registration under A (above), or
- D. An FSS (Foundation Stock Service) breed, as a member of a breed that is in the process of obtaining full AKC recognition, or
- E. A registration from UKC (United Kennel Club), which is an international dog registry that focuses on performance, or
- F. If your dog has no registration, you can register your dog with ASFA at the time your dog enters his/her first trial as follows:

- Complete the registration form below
- Attach a one time registration fee of \$10, payable to ASFA
- Submit the registration form and fee to the Field Trial Secretary along with for your dog’s first ASFA trial entry form.

The Field Trial Secretary will submit the registration form and fee to ASFA along with the trial records. Please retain a copy for your records until you receive a permanent registration number from ASFA.

Conditions of Entry

- Dogs must be one year of age or older on day of trial.
- Females in season, lame dogs and those that are unfit to course will be excused at roll call.
- Dogs not present at the time of roll call will be scratched.
- All dogs will be run twice unless excused, dismissed or disqualified.
- All dogs will run alone.
- All participants must read, understand, sign and comply with the ASFA LureCoursing Event COVID-19 Acknowledgement and Liability Waiver.

Stakes Offered

All dogs entered are competing for the title of Lure Coursing Champion (LCC)

Small - Dogs 17.5" or less at the withers and for all brachycephalic (flat faced) dogs

Small Open Stake – for Small dogs that have not achieved the title of LCC

Small Senior Stake – for Small dogs that have achieved the title of LCC.

Small Veteran Stake – for Small dogs that are over the age of 7.

Large - Dogs over 17.5" at the withers

Large Open Stake – for Large dogs that have not achieved the title of LCC

Large Senior Stake – for Large dogs that have achieved the title of LCC.

Large Veteran Stake – for Large dogs that are over the age of 7.

Sighthound Mix - Dogs with sighthound breed in its background

Sighthound Mix Open Stake – for Sighthound Mix dogs that have not achieved the title of LCC

Sighthound Mix Senior Stake – for Sighthound Mix dogs that have achieved the title of LCC.

Sighthound Mix Veteran Stake – for Sighthound Mix dogs that are over the age of 7.

Other Information

- Battery powered continuous loop lure machine will be used. Backup equipment will be available.
- Lure will consist of highly visible plastic strips.
- Exhibitors are requested to not bring bitches known to be in season to the field.
- There will be a \$5.00 fine assessed for any loose hound not participating in the course.
- Any person may, upon reasonable complaint, be asked to leave the grounds of the field trial by the Field Trial Committee.
- The field is partially fenced.
- Children must be under control of their parents or guardians at all times.

Course Plan

The course will be reversed for the finals. ICA reserves the right to alter the course plan as required by weather and/or field conditions on the date of the trial.

The fields are slightly rolling fields of old farmland. The grounds are a mixture of soft earth and sand. Exhibitors should make sure that their dogs are in good condition when running on these fields.

Individuals entering and using the facilities and/or grounds do so at their own risk. Antique Acres shall not be liable for any claims for bodily injury to themselves or their dogs or property damage arising out of or related to the use of the facility.

Procedures for COVID-19 Safety

- We will follow CDC and local guidelines.
- Bring your own facial covering. All participants will be required to wear facial coverings when not in their cars.
- No food will be served, bring your own breakfast and lunch, coffee, water & beverages.
- We ask that you park at a safe distance from other cars. This may mean that you will not find parking in the shade. Accordingly, be sure to bring plenty of shade for your dog(s) and yourself.
- There is limited water available on or near the South Field. Bring your own water.
- Roll Call and Inspection will require social distancing and a mask. The roll call committee will wear gloves and facial coverings. We will ask the owners of females to wipe their dogs and show the inspection committee the tissue.
- For dogs that require wicketing, the wickets will be wiped down after each dog.
- Bring your own face covering, hand sanitizer, gloves, and wet wipes.
- Huntmasters will stand 6 feet from the dogs after inspecting blankets and slip leads.
- At the starting line, all dogs will stand 6 feet apart.
- Practice social distancing. Act responsibly.
- The running order will be posted – take a photo, be sure to wear a mask and social distance when looking at running order and results.
- Bring your own poop bags, pens, paper – avoid having to borrow from others.
- Above all, be safe and have fun with your dogs.
