Roll Call & Inspection for all breeds: 8:30 AM Eastern Time. Worker's dogs may be roll

called early.

Late, incomplete, conditional, unsigned, unpaid entries and entries without a registration number will NOT be accepted. Entries will NOT be acknowledged by mail. Substitutes for lame or in-season hounds will be allowed if substitute has the same owner and the trial secretary is notified before the close of day-of-trial entries.

Rosettes will be offered by LARK for: BIF—Red, White, and Blue, BOB—Purple and Gold, First—Blue, Second—Red, Third—yellow, Fourth—White, NBQ—Green. High scoring single—Navy and gold.

Only purebred Afghan Hounds, Azawakhs, Basenjis, Borzoi, Cirnecho dell'Etna, Greyhounds, Ibizan Hounds, Irish Wolfhounds, Italian Greyhounds, Pharaoh Hounds, Rhodesian Ridgebacks, Salukis, Scottish Deerhounds, Silken Windhounds, Sloughis, Whippets and Provisional breeds may be entered in the regular stakes. Current Provisional breeds include purebred Chart Polski, Galgo Espanol, Magyar Agar, Peruvian Inca Orchid, Portuguese Podengo (Pequeno), and Portuguese Podengo (Medio & Grande), and must be individually registered with the appropriate registry. Provisional breeds are not eligible for Best In Field.

All entries shall be individually registered with the AKC (ILP/PAL included), the NGA, the UKC, the FCI, an ASFA-recognized foreign or ASFA Board approved registry, or possess a CRN from the SPDBS. A photocopy of acceptable registry must be submitted with each hound's first ASFA field trial entry; this requirement is waived for hounds registered with the NGA.

Regular Stakes Offered

OPEN STAKE: Any eligible sighthound who has met certification requirements, excluding ASFA Field Champions of record. A photocopy of the hound's registration must be submitted at the hound's first trial. This is waived for NGA greyhounds

FIELD CHAMPION STAKE: Any ASFA Field Champion of record.

VETERAN STAKE: Any eligible hound whose age is at least six years, except Irish Wolfhounds, whose age shall be at least five years, and Afghan Hounds, Rhodesian Ridgebacks, Salukis and Whippets whose age shall be at least seven years and that have met certification requirements. Points earned in this stake are towards the V-FCH or V-LCM titles.

SINGLES STAKE: Any eligible sighthound including novice hounds and hounds with breed disqualifications and/or hounds that have been disqualified from competition in other stakes, are eligible to enter. Hounds are eligible to earn TCP and CPX titles from the Singles Stake. Provisional Breeds are not eligible for these titles. Not eligible for Best of Breed or Best In Field.


PROVISIONAL STAKE: Any eligible hound of a Provisional breed that has met certification requirements. Not eligible for Best In Field.

Conditions of Entry: All entries must be one year or older on the day of the trial. If the entry in any regular stake is 20 or more, the stakes will be split into flights by public random draw Bitches in season, lame hounds and hounds with breed disqualifications will be excused at roll call. Spayed, neutered, monorchid or cryptorchid hounds without breed disqualifications may be entered; hounds with breed disqualifications are not eligible to enter except in the Single Stake. Hounds not present at the time of roll call will be scratched. All hounds will run twice, in trios if possible or braces (except in the Single Stake), unless excused, dismissed or disqualified. Hound certification runs will be offered after completion of the trial on Saturday.

There will be a \$5.00 fine for any loose hounds on the field which are not in the course in progress. There will also be a \$5.00 fine for any one who does not pick up after their dog.

A battery powered CONTINUOUS LOOP lure machine will be used; backup equipment will be available. Lure will consist of highly visible plastic. The club reserves the right to alter the course as required by weather and/or field condition on the day of the trial. Courses will be reversed for finals, run-offs and again for BOB. The field is not fenced, but the course is well away from the main road.
