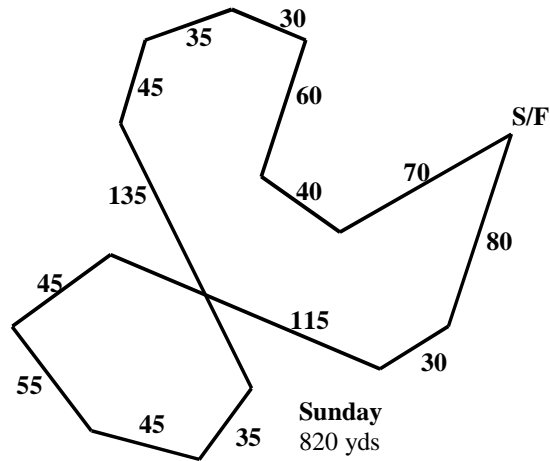
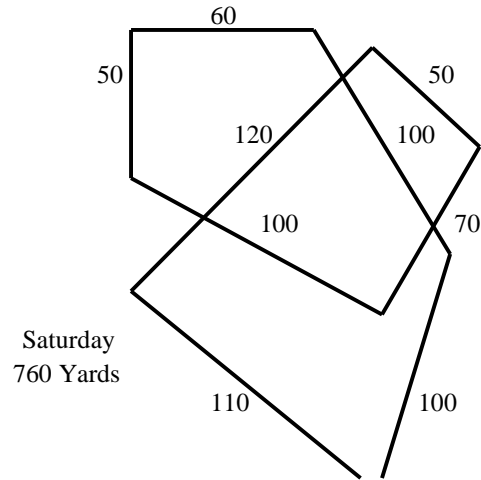

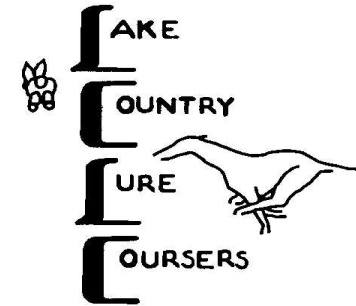
**DIRECTIONS:**

Entries will **NOT** be acknowledged by mail. Late, incomplete, unsigned or conditional entries will not be accepted.

ELIGIBLE BREEDS & REGISTRIES: Only purebred Afghan Hounds, Azawakhs, Basenjis, Borzoi, Cirneco dell'Etna, Greyhounds, Ibizan Hounds, Irish Wolfhounds, Italian Greyhounds, Pharaoh Hounds, Rhodesian Ridgebacks, Salukis, Scottish Deerhounds, Sloughis, Whippets, and Provisional breeds may be entered in the regular stakes. Current Provisional breed: Silken Windhound. Limited breeds may be entered in the Limited Stake or the Singles Stake. Limited breeds currently include purebred Chart Polski, Galgo Español, Magyar Agar, Peruvian Inca Orchid, Portuguese Podengo (Pequeno), Portuguese Podengo (Medio & Grande), and must be individually registered with the appropriate registry.

All entries shall be individually registered with the AKC (including ILP & PAL), the NGA, the UKC, the FCI, an ASFA-recognized foreign or ASFA Board approved registry, or possess a CRN from the SPDBS. A photocopy of acceptable registry must be submitted with each hound's first ASFA field trial entry; this requirement is waived for hounds registered with the NGA.

All hounds entering Open, Veteran, or limited stakes for the first time **MUST** include a completed ASFA certification form or waiver form and a copy of the hound's registration certificate (registration is not required for NGA greyhounds **ONLY**, certification or waiver is not required for Single stake entries **ONLY**).

**Hound certification runs will be offered after Best in Field and before Practice.**

**Please allow extra time and postage for entries to cross the border.** Late, incomplete, unsigned or conditional entries will not be accepted.

**Lunch will NOT be offered at this trial but there is a concession in the park or a sub shop near the park entrance.**

All entries in the regular stakes shall be individually registered with the American Kennel Club, the United Kennel Club, the National Greyhound Association, the Federation Cynologique Internationale, an ASFA-recognized foreign or ASFA Board approved registry, or possess a Critique Registration Number (CRN) from the Society for the Perpetuation of Desert Bred Salukis (SPDBS). Limited and/or Provisional stake entries shall be individually registered with the appropriate registry. A photocopy of acceptable registry must be submitted with a hound's first ASFA field trial entry; this requirement is waived for hounds registered with the National Greyhound Registry.

**Breed disqualifications apply.**

### STAKES OFFERED

**Open stake:** any eligible sighthound, excluding ASFA Field Champions of record;

**Field Champion stake:** any ASFA Field Champion;

**Veteran stake:** any eligible hound whose age is at least six years, except Irish Wolfhounds whose age shall be at least five years, and Afghan Hounds, Whippets and Rhodesian Ridgebacks, whose age shall be at least seven years.

**SINGLES STAKE:** Any eligible sighthound including those disqualified to run in other stakes. Not eligible for Best of Breed or Best in Field. Hounds are eligible to earn TCP and CPX titles from the Singles stake. Limited breeds are not eligible for these titles.

**LIMITED STAKE:** Any eligible sighthound of a Limited breed that has met certification requirements. Not eligible to compete in Best of Breed or Best in Field.

**Best in Field** will be offered.

### CONDITIONS

- Hounds must be 1 year of age or older on the day of the trial.
- Stakes will be split into flights by public random draw if the entry in any regular stake is 20 or more.
- All hounds will run twice, in trios if possible or braces unless excused, dismissed or disqualified.
- Bitches in season, hounds with breed disqualifications and lame hounds will be excused and the entry fee refunded. Hounds not present at roll call will be scratched.
- Each entry will be examined at inspection for breed disqualifications. Spayed, neutered, cryptorchid, and monorchid hounds (without breed disqualifications) may be entered; hounds with breed disqualifications are not eligible to enter except in the Single Stake.
- Battery powered, continuous loop lure system will be used. Backup equipment will be available. The lure will consist of white plastic strips.
- The course will be reversed for the finals, and again for runoffs and Best of Breed.
- Direction for Best in Field will be at the discretion of the judges.
- Exhibitors are requested to not bring bitches known to be in season to the field.
- A \$5.00 fine will be assessed for any hound loose or interfering with the course in progress.
- A \$20.00 fine will be assessed to any owner not cleaning up after their hound.
- Any person may, upon reasonable complaint, be asked to leave the grounds of the field trial by the Field Trial Committee
