DIRECTIONS:

From the North: Parkway or Turnpike to Rte 78W. Exit 17/Rte 31S 10 miles to Flemington Circle to Rte 202/31 S. 5 miles to Rte 179 South exit to Lambertville. Fairgrounds on right after exit ramp.

From the South: Rte 95N or 295N to 31N, 12 miles to Rte 202. You can only enter to 202N, go 1/4 mi to U-turn at Wertsville Rd. then 1/2 mile 202 South to Rte 179 South exit to Lambertville. Fairgrounds on right after exit ramp.

From the East: (Jersey Shore) Parkway to 195W to 295/95N (Loop around Trenton) to 31N, 12 miles to Rte 202. Entrance will put you on 202N, go 1/4 mi to U-turn at Wertsville Rd. then 1/2 mile 202S to Rte 179 South exit to Lambertville. Fairgrounds on right after exit ramp.

From the West: (Pennsylvania) 202N 6 miles from state border to Rte 179S/Lambertville exit. Fairgrounds on right after exit ramp.

Once in the Fairgrounds, follow the main road around behind the buildings to the field.

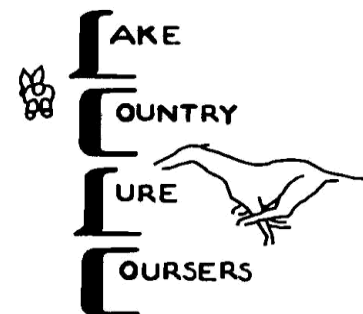

Eligible Breeds and Registries: Only purebred Greyhounds may be entered. All entries in the regular stakes shall be individually registered with the American Kennel Club, AKC (ILP and PAL included), the United Kennel Club, the National Greyhound Association, the Federation Cynologique Internationale, an ASFA-recognized foreign or ASFA Board approved registry. A photocopy of acceptable registry must be submitted with a hound's first ASFA field trial entry; this requirement is waived for hounds registered with the National Greyhound Registry.

All hounds entering Open, Veteran, or limited stakes for the first time MUST include a completed ASFA certification form or waiver form and a copy of the hound's registration certificate

Hound certification runs will be offered on Friday – please contact the Secretary for more information.

STAKES OFFERED

OPEN STAKE any eligible Greyhound, excluding ASFA Field Champions of record, that has met certification requirements;

FIELD CHAMPION STAKE: any Greyhound ASFA Field Champion;

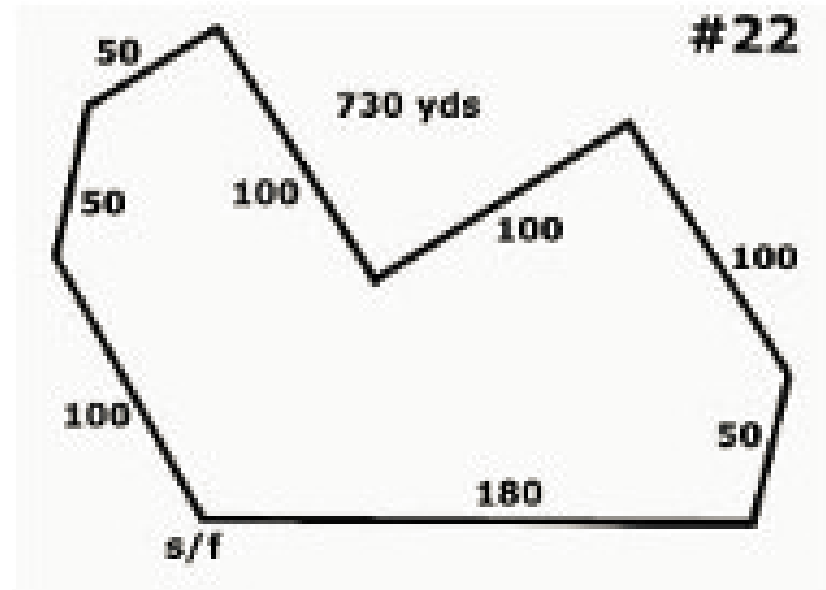
VETERAN STAKE: any eligible Greyhound whose age is at least six years, that has met certification requirements; Points go toward V-FCh or V-LCM titles.

SINGLES STAKE: Any eligible Greyhound including those disqualified to run in other stakes. Not eligible for Best of Breed or Best in Field. Hounds are eligible to earn TCP and CPX titles from the Singles stake. Limited breeds are not eligible for these titles.

CONDITIONS

- Hounds must be 1 year of age or older on the day of the trial.
- Battery powered, continuous loop lure system will be used. Backup equipment will be available. The lure will consist of white plastic strips.
- The course will be reversed for the finals, and again for runoffs and Best of Breed.
- Direction for Best in Field will be at the discretion of the judges.
- Exhibitors are requested to not bring bitches known to be in season to the field.
- A \$5.00 fine will be assessed for any hound loose or interfering with the course in progress.
- A \$20.00 fine will be assessed to any owner not cleaning up after their hound.
- Any person may, upon reasonable complaint, be asked to leave the grounds of the field trial by the Field Trial Committee
- Bitches in season, hounds with breed disqualifications and lame hounds will be excused and the entry fee refunded. Hounds not present at roll call will be scratched.
- Each entry will be examined at inspection for breed disqualifications. Spayed, neutered, cryptorchid, and monorchid hounds (without breed disqualifications) may be entered; hounds with breed disqualifications are not eligible to enter except in the Single Stake. Stakes will be split into flights by public random draw if the entry in any regular stake is 20 or more.
- All hounds will run twice, in trios if possible or braces unless excused, dismissed or disqualified.
