

 - Field is on the right side of road (0.1 mile, past a small water tower, and just before the STOP sign).


Directions from I-40 in New Mexico:

Certification runs for non-AKC sighthound breeds only from 10:00 to 10:25 AM - \$20 per hound. Owners are responsible for supplying a dog of similar running style.

ELIGIBLE BREEDS & REGISTRY

Only purebred Afghan Hounds, Azawakhs, Basenjis, Borzoi, Cirneco dell'Etna, Greyhounds, Ibizan Hounds, Irish Wolfhounds, Italian Greyhounds, Pharaoh Hounds, Rhodesian Ridgebacks, Salukis, Silken Windhounds, Scottish Deerhounds, Sloughis, Whippets. Limited breeds may be entered in the Limited Stake or the Singles Stake. Limited breeds currently include purebred Chart Polski, Galgo Español, Magyar Agar, Peruvian Inca Orchid, Portuguese Podengo (Pequeno), Portuguese Podengo (Medio & Grande), and must be individually registered with the appropriate registry.

All entries shall be individually registered with the AKC (including ILP & PAL), the NGA, the UKC, the FCI, an ASFA-recognized foreign or ASFA Board approved registry, or possess a CRN from the SPDBS. A photocopy of acceptable registry must be submitted with each hound's first ASFA field trial entry; this requirement is waived for hounds registered with the NGA.

UPON REQUEST, ENTRIES WILL BE ACKNOWLEDGED BY EMAIL

Late, incomplete, unsigned, unpaid, or conditional entries will not be accepted. Substitutions may be made for hounds lame or in season prior to roll call. The Free To Be Ranch, other field property owners, LLCC, or its members are not responsible for any accidents at these trials.

STAKES OFFERED:

OPEN STAKE: Any eligible sighthound, excluding ASFA Field Champions of record. Hounds are eligible to earn FCh title.

FIELD CHAMPION STAKE: Any ASFA Field Champion. Hounds are eligible to earn LCM titles.

<u>VETERAN STAKE:</u> Any eligible hound whose age is at least six years, except Irish Wolfhounds whose age shall be at least five years, and Afghan Hounds, Rhodesian Ridgebacks, Salukis, and Whippets whose age shall be at least seven years. Points go toward V-FCh or V-LCM titles.

<u>LIMITED STAKE:</u> Any eligible sighthound of a Limited stake breed that has met certification requirements. Not eligible to compete in Best of Breed or Best in Field.

SINGLE STAKE: Any eligible sighthound including those disqualified to run in other stakes. Not eligible for Best of Breed or Best in Field. Hounds are eligible to earn TCP and CPX titles from the Singles stake. Limited breeds are not eligible for these titles.

CONDITIONS OF ENTRY:


- ⇒ All entries must be one year or older on the day of the trial.
- Stakes will be split into flights by public random draw if the entry in any regular stake is 20 or more.
- Bitches in season, lame hounds and hounds with breed disqualifications will be excused at roll call.
- ⇒ Spaved, neutered, monorchid or cryptorchid hounds without breed disqualifications may be entered.
- ⇒ Hounds with breed disqualifications are not eligible to enter except in the Single Stake.
- ⇒ Hounds not present at the time of roll call will be scratched.
- All hounds will run twice, in trios if possible or braces (except in the Single Stake), unless excused, dismissed or disqualified.

OTHER:

- ⇒ LLCC, FREE TO BE RANCH, and other owners of the event properties, assume no liability for injury to any person or dog before, during or after these Trials.
- ⇒ All animals on Trial grounds are expected to be current on vaccinations as required by New Mexico State Law.
- ⇒ There will be a \$5 fine assessed for any hound loose on the field, other than those running the course in progress. \$5 fine for delay of trial at judge's discretion.
- ⇒ There will be a \$25 fee for returned checks.
- ⇒ Everyone must clean up after themselves and their dogs.
- Absolutely no smoking anywhere on the trial grounds.

Continuous loop equipment will be used. Back-up equipment will be available. Lure will consist of highly visible white and/or black plastic and/or fur strips. Course plans (reversed for finals) are shown on the following page. LLCC reserves the right to alter the course plans, as required, by weather and/or field conditions on the day of the trial. The elevation is over 5,400'. **This is a remote site**; bring your own food, shade and water. No fires of any kind permitted on the field.

AMERICAN SIGHTHOUND FIELD ASSOCIATION HOUND CERTIFICATION

Rule effective October 1, 1994: Ch. V, Sec. 4 (a) OPEN STAKE: To be eligible to enter the open stake, a hound must have been certified by a licensed judge within the year preceding the closing date for the entry or have previously competed in the Open Stake.
