## ELIGIBLE BREEDS & REGISTRY FOR THE TRIALS

Only purebred Afghan Hounds, Azawakhs, Basenjis, Borzoi, Cirneco dell'Etna, Greyhounds, Ibizan Hounds, Irish Wolfhounds, Italian Greyhounds, Pharaoh Hounds, Rhodesian Ridgebacks, Salukis, Scottish Deerhounds, Sloughis, Silken Windhounds and Whippets may be entered in the regular stakes.

Limited breeds may be entered in the Limited Stake or the Singles Stake. Limited breeds currently include purebred Chart Polski, Galgo Español, Magyar Agar, Peruvian Inca Orchid, Portuguese Podengo (Pequeno), Portuguese Podengo (Medio & Grande), and must be individually registered with the appropriate registry.

All entries shall be individually registered with the AKC (ILP/PAL included), the NGA, the UKC, the FCI, an ASFA-recognized foreign or ASFA Board approved registry, or possess a CRN from the SPDBS. A photocopy of acceptable registry must be submitted with each hound's first ASFA field trial entry; this requirement is waived for hounds registered with the NGA.

## REGULAR STAKES OFFERED

**OPEN STAKE:** Any eligible sighthound that has met certification requirements, excluding ASFA Field Champions of record.

**FIELD CHAMPION STAKE:** Any ASFA Field Champion.

**VETERAN STAKE:** Any eligible hound whose age is at least six years and has met certification requirements, except Irish Wolfhounds whose age shall be at least five years, and Afghan Hounds, Rhodesian Ridgebacks, Salukis, and Whippets whose age shall be at least seven years. Points go toward V-FCh or V-LCM titles.

**SINGLE STAKE:** Any eligible sighthound including those disqualified to run in other stakes. Each hound runs alone. Not eligible for Best of Breed or Best in Field. Hounds are eligible to earn TCP and CPX titles from the Singles stake. Limited breeds are not eligible for these titles.

**LIMITED STAKE:** Any eligible sighthound of a Limited stake breed that has met certification requirements. Not eligible to compete in Best of Breed or Best in Field.

## LURE CHASING INSTINCT STAKES OFFERED

The LCI stakes are for non-purebred sighthounds. Dogs run individually but compete against each other in the manner of the regular Singles Stake.

**Small Open:** for dogs 17-1/2 inches or less at the withers and/or brachycephalic ("flat-faced") dogs who have not achieved the title of LCC. **Small Senior:** for dogs 17-1/2 inches or less at the withers and/or brachycephalic dogs who have achieved the title of LCC. **Small Veteran:** for dogs 17-1/2 inches or less at the withers and/or brachycephalic dogs over the age of 7 years.

**Large Open:** for dogs over 17-1/2 inches at the withers who have not achieved the title of LCC. **Large Senior:** is for dogs over 17-1/2 inches at the withers who have achieved the title of LCC. **Large Veteran:** for dogs over 17-1/2 inches at the withers who are over the age of 7 years.

**Sighthound mix Open:** for dogs with a sighthound breed in its background who have not achieved the title of LCC. **Sighthound mix Senior:** for dogs with sighthound breed in its background who have achieved the title of LCC. **Sighthound mix Veteran:** for dogs with sighthound breed in its background over the age of 7 years.

When running as a stake within a regular ASFA trial, Small will run 50% of the ASFA course as laid out for the sighthounds up to a maximum of 400 yards. All other stakes will run the full ASFA laid out course length.

**Upon request, entries will be acknowledged by email**

Late, incomplete, unsigned, unpaid, or conditional entries will not be accepted. Substitutions may be made for hounds lame or in season prior to roll call. The HIPICO property owners and the LLCC, or its members are not responsible for any accidents or injury at these trials.

**CONDITIONS OF ENTRY:**

- ⇒ All entries must be one year or older on the day of the trial.
- ⇒ Stakes will be split into flights by public random draw if the entry in any regular stake is 20 or more.
- ⇒ Bitches in season, lame hounds and hounds with breed disqualifications will be excused at roll call.
- ⇒ Spayed, neutered, monorchid or cryptorchid hounds without breed disqualifications may be entered.
- ⇒ Sighthounds with breed disqualifications are not eligible to enter except in the Single Stake
- ⇒ Hounds not present at the time of roll call will be scratched.
- ⇒ All hounds will run twice, in trios if possible or braces (except in the Single Stake), unless excused, dismissed or disqualified.
- ⇒ **\$25 fine for returned checks.**

**OTHER:**

- ⇒ LLCC and HIPICO property owners assume no liability for any accident or injury to any person or dog before, during or after these Trials.
- ⇒ All animals on Trial grounds are expected to be current on vaccinations as required by New Mexico State Law.
- ⇒ There will be a \$5 fine assessed for any hound loose on the field, other than those running the course in progress. \$5 fine for delay of trial at judge's discretion.
- ⇒ There will be a **\$25** fee for returned checks.
- ⇒ Everyone must clean up after themselves and their dogs.

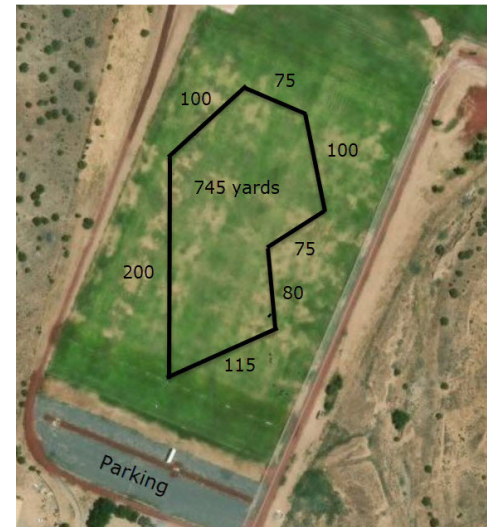

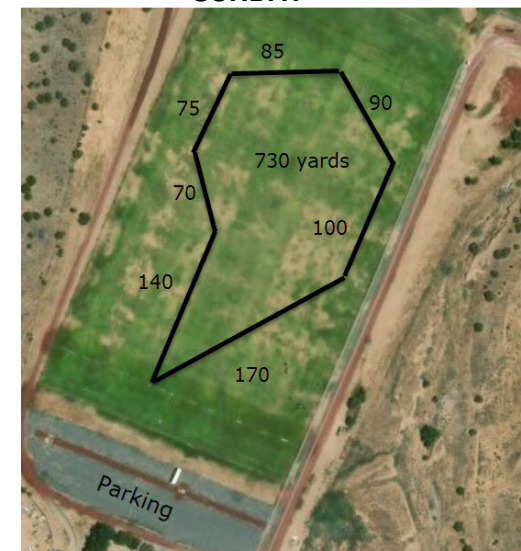
LCI Small dogs will run 50% of each course, using the top of each course shown.

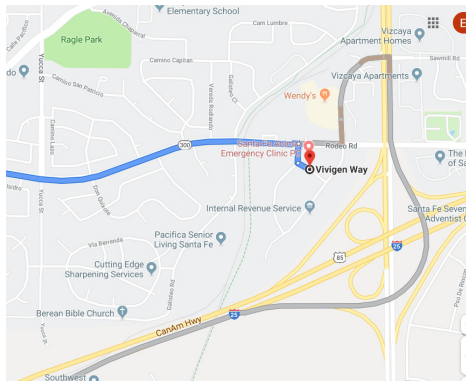

BACKTRACK to intersection of South Polo Drive & Paseo Real [56], head north on Paseo Real (which becomes, Airport Road (284), then becomes Rodeo Road (300) for **~8.6 miles (~18 minutes)** to Vivigen Way and turn south.

YOU CAN ALSO take Paseo Real [56] to Airport Road (284); at the light at Hwy 599 go RIGHT. Take I-25 NORTH (on ramp under the overpass turn LEFT) Exit at SAINT FRANCIS. LEFT on Sawmill Road, RIGHT on Rodeo Road, LEFT on Vivigen Way. Time for either way is about the same.

# Lure Chasing Instinct Program

**Section 1.** All non-purebred sighthound dogs entered must have a registration number via one of the following:

- A. **AKC Registration** as one of the recognized breeds.
- B. **AKC Canine Partners**, which is for mixed-breed dogs and dogs ineligible for AKC registration.
- C. **Purebred Alternative Listing (PAL)** program, which is for purebred dogs that cannot be fully registered with the AKC to participate in AKC events.
- D. **Foundation Stock Service® (FSS)**, which is for recorded breeds on the road to full AKC recognition.
- E. **United Kennel Club (UKC)** registration as one of the recognized breeds.
- F. If the dog has none of the above registrations, **ASFA will provide a unique entry number** for a one-time \$10 charge.
  1. The owner has to complete an ASFA Request for unique entry number.
  2. The Trial Secretary will submit a copy of the form with the records.
  3. The owner will retain a copy as proof of request and payment until permanent number is provided.

**Section 2.** The owner or agent entering a dog in a lure field trial does so at his own risk. The owner or agent and licensed club agree to abide by the rules of the ASFA.

**Section 3.** Entry fees shall be fixed by the host club and shall be forfeited in such cases where dogs are scratched from the field except for one of the following causes.

- A. Dogs determined to be lame at the time of roll call shall be barred from competition and their entry fees shall be refunded.
- B. Bitches in season, or bitches showing a discharge characteristic of being in season, or which come in season after the close of entries, shall be excepted from this rule and their entry fees shall be refunded. Notification to the Field Trial Secretary of bitches in season must be made before or during the roll call. Bitches known to be in season should not be brought onto the trial grounds and shall be removed if discovered to have come in to season.
- C. Entry fees shall be refunded for dogs that have been disqualified for aggression another organization. Fees will be refunded only if the owner or agent notifies the Field Trial Secretary of such ineligibility prior to or during roll call.

**Section 4.** To compete dogs must:

- A. Be a minimum of 12 months old
- B. Be physically fit for competition. Blindness, Lameness and Amputation are considered as being unfit
- C. May be spayed, neutered or intact
- D. Females must not be in heat/season
- E. Be free of bandaging or any other attachments for medical purposes
- F. Not be disqualified
