**ROLL CALL:** 8:00 AM; day of entries close; hounds not present at roll call will be marked absent and are not eligible for a refund of entry fee.

## AWARDS

- Ribbons or rosettes will be offered for all placements:**  
1<sup>st</sup>=Blue, 2<sup>nd</sup>=Red, 3<sup>rd</sup>=Yellow, 4<sup>th</sup>=White, NBQ=Green,  
**High Scoring Singles**–Navy & Gold, **Best of Breed**–Purple & Gold, **Best in Field**–Red, White & Blue
- LCI Best of Variety**–There will be 3 Best of Variety ribbons given, one for each division of LCI (Large, Small, Sighthound Mix). The ribbon will be awarded to the dog in each division that has the highest combined score. If there is a tie, the tie will be broken by choosing the dog that has the highest score in a singles run, (not including any stakes runoff scores). If that is also a tie, the award will be decided by a coin toss.
- Each dog that earns a New ASFA title at out trial will receive a New Title rosette. Please notify the Trial Secretary if your hound might earn a new title at our trial.
- Ribbons and prizes will not be mailed.

### ELIGIBLE BREEDS & REGISTRY

Only purebred Afghan Hounds, Azawakhs, Basenjis, Borzoi, Cirneco dell'Etna, Greyhounds, Ibizan Hounds, Irish Wolfhounds, Italian Greyhounds, Peruvian Inca Orchid, Pharaoh Hounds, Rhodesian Ridgebacks, Salukis, Scottish Deerhounds, Sloughis, Silken Windhounds and Whippets may be entered in the regular stakes.

Provisional breeds may be entered in the Provisional Stake or the Singles Stake. Provisional breeds currently include purebred Chart Polski, Galgo Español, Magyar Agar, Portuguese Podengo (Pequeno), Portuguese Podengo (Medio & Grande), and must be individually registered with the appropriate registry.

All entries shall be individually registered with the AKC (ILP/PAL included), the NGA, the UKC, the FCI, an ASFA-recognized foreign or ASFA Board approved registry, or possess a CRN from the SPDBS. A photocopy of acceptable registry must be submitted with each hound's first ASFA field trial entry; this requirement is waived for hounds registered with the NGA.

### REGULAR STAKES OFFERED

**OPEN STAKE:** Any eligible sighthound, excluding ASFA Field Champions of record that has met the certification requirements.

**FIELD CHAMPION STAKE:** Any ASFA Field Champion

**VETERAN STAKE:** Any eligible hound whose age is at least six years, except Irish Wolfhounds whose age shall be at least five years, and Afghan Hounds, Ibizan Hounds, Rhodesian Ridgebacks, Salukis and Whippets whose age shall be at least seven years. That has obtained an ASFA certification, AKC QC, or other qualifying waivers prior to the closing date. A copy of the certificate MUST be submitted with the entry forms. Points go toward V-Fch or V-LCM titles.

**PROVISIONAL STAKE:** Any eligible sighthound of a provisional breed that has met certification requirements. Not eligible to compete for Best of Breed, Best in Field, or Best in Event. Points and placements are awarded, but no title certificates are issued until the breed is fully recognized by ASFA.

**SINGLES STAKE:** Any eligible sighthound including those disqualified to run in other stakes. Each hound runs alone. Not eligible for Best of Breed or Best in Field. Hounds are eligible to earn TCP and CPX titles from the Singles stake. Provisional breeds are not eligible for these titles.

**LURE CHASING INSTINCT (LCI STAKE):** Open to non-sighthounds and sighthound mixes. All entries shall be individual registered with the AKC (including ILP, CP, and PAL) or the UKC. A photocopy of acceptable registry must be submitted with each dog's first ASFA field trial entry. Dogs without a recognized registry number may obtain an ASFA ID number for a \$10 registry fee at time of entry.

- **Small Open:** dogs 17-1/2" or less at the withers and / or brachycephalic ("flat faced") dogs who have not achieved the title of LCC.

- **Small Excellent:** dogs 17-1/2" or less at the withers and/or brachycephalic dogs who have achieved the title of LCC.

- **Small Veteran:** dogs 17-1/2" or less at the withers and/or brachycephalic dogs over 7 years.

- **Large Open:** dogs over 17-1/2" at the withers who have not achieved the title of LCC.

- **Large Excellent:** dogs over 17-1/2" at the withers who have achieved the title of LCC.

- **Large Veteran:** dogs over 17-1/2" at the withers who are over 7 years.

- **Sighthound Mix Open:** dogs with a sighthound breed in its background who have not achieved the title of LCC.

- **Sighthound Mix Excellent:** for dogs with sighthound breed in its background who have achieved the title of LCC.

- **Sighthound Mix Veteran:** for dogs with sighthound breed in its background over 7 years.

- When running as a stake within a regular ASFA trial, Small will run 50% of the ASFA course as laid out for the sighthounds up to a maximum of 400 yards. All other stakes will run the full ASFA laid out course length.

### CONDITIONS OF ENTRY

*Applies to all stakes*

- All entries must be one year or older on the day of the trial
- Stakes will be split into flights by public random draw if the entry in any regular stake is 20 or more
- Bitches in season, lame hounds and hounds with breed disqualifications will be excused at roll call.
- Spayed, neutered, monorchid or cryptorchid hounds without breed disqualifications may be entered; hounds with breed disqualifications are not eligible to enter except in the Singles Stake Hounds not present at the time of roll call will be scratched
- All hounds will run twice, in trios if possible or braces (except in the Singles and LCI Stakes), unless excused, dismissed or disqualified.
- Please do not bring bitches known to be in season to the field.

**REMINDER:** first time entries: a copy of the hound's registration must be submitted with a hounds ASFA field trial entry, except if the hound is registered with the NGA.

### HOUND CERTIFICATIONS

All first time entered hounds must present either the judge-signed ASFA Hound Certification or waiver certificate or AKC Qualified Courser certification and a copy of the hound's registration to the FTS before entries close to be considered complete. First time singles entrants do not need a hound certification/waiver.

Certifications will be offered following the trial if time allows.

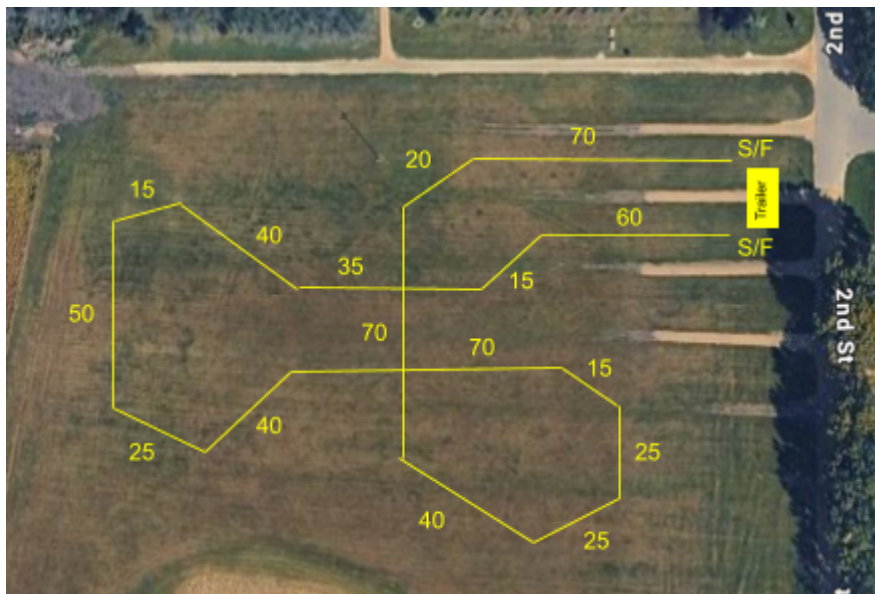
### COURSE PLANS

Minnesota Coursing Association reserves the right to alter the course diagram as required by weather and/or field conditions on the day of the trial.

Courses will be reserved for Finals

This trial is located on the **SOUTH** field.

### ADDITIONAL INFORMATION

- There will be a \$5.00 fine assessed for any loose hound not participating in the course.
- Any person may, upon reasonable complaint, be asked to leave the grounds by the Field Trial Committee.
- Any first time entry which is entered in a trial must have a copy of the hound's registration papers to send in with the entry.
- Dakota County Fairgrounds are not securely fenced; it is strongly recommended that prior to running your hound, you have good control over your dog, as the dogs will run off leash.
- Handlers should wear comfortable, sturdy shoes and be able to hold, catch, and release their dogs.
- Coursing is a physically demanding sport and can tax a hound's physical strength. Hounds that are old, have physical ailments, or are out of condition may be at greater risk for injury. Consult your veterinarian if you have any concerns.
- Muzzles are not required but are permitted at the handler's discretion.
- Please do not bring bitches known to be in season to the field.
- Each entry will be inspected for breed disqualifications, lameness, fitness to compete, and females in season. Any entry found to be unfit to safely compete shall not be allowed to enter and entry fees shall be refunded. Hounds with breed disqualifications will be excused and entry fees will not be refunded.
- The club will have coursing slip leads and blankets available to those who need them.
- MCA issues entry fee refunds for dogs that are in season or lame. You must inform the FTS before roll call to request a refund if your dog will not be attending the trial for these reasons.
- First Time Entry (FTE) LCI dogs will be measured at the trial

### HOW TO ENTER

- Pre-entry: mail completed entry form and payment to the FTS. Do not send entries without a signature.
- Day of trial entry: provided an entry limit has not been reached (if applicable), bring entry form and payment to the event before close of entries.
- Checks should be made payable to Minnesota Coursing Association.
- Separate entry forms and entry fees are required for each dog.
- A fee of \$40.00 will be assessed for any returned checks.
- Incomplete, unsigned, conditional, or unpaid entries will not be accepted.
- The club and/or the Field Trial Secretary assume no responsibility for wrong or incomplete information given on the entry form.

### **LURE CHASING INSTINCT (LCI) PROGRAM**

All non-sighthounds, sighthound-mixes, and mixed-breeds entered must have a registration number with one of the accepted registries or obtain a unique entry number from ASFA (see below). A photocopy of the acceptable registry must be submitted with each dog's first ASFA field trial entry. Acceptable registries:

- American Kennel Club (AKC):
  - Registration as a recognized breed
  - Purebred Alternative Listing (PAL) program, which is for purebred dogs that cannot be fully registered with the AKC to participate in AKC events.
  - Canine Partners (CP), which is for mixed-breed dogs and dogs ineligible for other types of AKC registration.
  - Foundation Stock Service (FSS), which is for recorded breeds on the road to full AKC recognition.
- United Kennel Club (UKC) registration:
  - Registration as a recognized breed
  - A Performance Listing (PL) number

If the dog does not have one of the above registrations, ASFA will provide a unique entry number for a one-time \$10 charge.

1. The owner has to complete an ASFA request for a unique entry number.
2. The Trial Secretary will submit a copy of the form with the records.
3. The owner will retain a copy as proof of request and payment until a permanent number is provided.

### **VETERANS GLORY RUN**

The Veteran's Glory Run is a special tribute to our veteran runners on Saturday. The intent is to celebrate what our dogs love to do, run! Any veteran not entered in Saturday's trial may enter, although this run is intended for those not actively competing.

The Veteran's Glory Run will begin immediately after the handlers' meeting and will conclude before preliminaries.

The chair for the Veteran's Glory Run is Shellie Marvin  
Sign up with Shellie Marvin before 8:15AM on Saturday. The entry fee is \$5.

### **Judges' info:**

All veterans will be judged on a specific portion of the course, although the owner may choose to run more or less than the judged area. Any veteran not running within the judging area is subject to having points deducted. One point will be added to the runner's score for each year over veteran age (for their breed).

## THE MINNESOTA CUP

The Minnesota Cup Trophy originated as a Best in Event (BIE) recognition in the years long before hounds winning Best In Field (BIF) were awarded ASFA points. Best of Breed winners from both Saturday and Sunday who ran both days without scratches or forfeits are eligible to run for BIE on Sunday They need not run BIF to be eligible to compete for BIE. The Minnesota Cup will be run following BIF on Sunday.

**Rule effective October 1, 1994: Ch.
