

- CERTIFICATION RUNS FOR HOUNDS ENTERED IN SINGLES STAKE: 8:00 am day of trial. Before the trial, hounds entered in Singles Stake may do a certification run and, if they pass, be moved to Open Stake (or Veteran stakes, if applicable). The owner needs to submit the signed certification form to the FTS by 8:30 am. Owners need to make arrangements for a hound to run with and have the proper form prepared for the judge to sign. (The form is included toward the end of this premium list).

## Eligible Breeds & Registration

Only purebred Afghan Hounds, Azawakhs, Basenjis, Borzoi, Cirneco dell'Etna, Greyhounds, Ibizan Hounds, Irish Wolfhounds, Italian Greyhounds, Pharaoh Hounds, Rhodesian Ridgebacks, Salukis, Scottish Deerhounds, Silken Windhound, Sloughis, Whippets, and Provisional breeds may be entered in the regular stakes.

Current Provisional breeds include purebred Chart Polski, Galgo Español, Magyar Agar, Peruvian Inca Orchid, Portuguese Podengo (Pequeno), Portuguese Podengo (Medio & Grande), and must be individually registered with the appropriate registry.

Open to NON sighthounds and sighthound mixes, see Lure Chasing Instinct Stake (below).

All entries shall be individually registered with the AKC (including ILP and PAL), the NGA, the UKC, the FCI, an ASFA-recognized foreign or ASFA Board approved Registry, or possess a CRN from the SPDBS. A photocopy of acceptable registry must be submitted with each hound's first ASFA field trial entry; this requirement is waived for hounds registered with the NGA.

## Regular Stakes Offered

<u>OPEN STAKE</u>: For any eligible sighthound that has met certification requirements, excluding ASFA Field Champions of record.

FIELD CHAMPION STAKE: For any ASFA Field Champion of record.

<u>VETERAN STAKE</u>: Any eligible hound that has met the certification process whose age is at least six years, except Irish Wolfhounds whose age shall be at least five and Afghans, Rhodesian Ridgebacks, Salukis, and Whippets whose age shall be at least seven years. Points go toward V-FCh or V-LCM titles

<u>PROVISIONAL STAKE</u>: Any eligible sighthound of a Provisional breed that has met certification requirements. Not eligible to compete in Best of Breed or Best in Field

<u>LURE COURSING INSTINCT (LCI) STAKE</u>: Open to NON sighthounds and sighthound mixes. Entries shall be individually registered with the AKC (including ILP & PAL), the UKC, the FCI, an ASFA recognized foreign or ASFA Board approved registry, possess a CRN from the SPDBS. Or, dogs without a recognized registry number may obtain an ASFA identification number for a \$10 registration fee at time of entry.

**Small Open**: for dogs 17.5" or less at the withers and / or brachycephalic ("flat- faced") dogs who have not achieved the title of LCC.

**Small Senior**: for dogs 17.5" or less at the withers and/or brachycephalic dogs who have achieved the title of LCC.

**Small Veteran**: for dogs 17.5" or less at the withers and/or brachycephalic dogs over the age of 7 years.

**Large Open**: for dogs over 17.5" at the withers who have not achieved the title of LCC.

**Large Senior**: is for dogs over 17.5" at the withers who have achieved the title of LCC.

**Large Veteran**: for dogs over 17.5" at the withers who are over the age of 7 years.

**Sighthound mix Open**: for dogs with a sighthound breed in its background who have not achieved the title of LCC.

**Sighthound mix Senior**: for dogs with sighthound breed in its background who have achieved the title of LCC.

**Sighthound mix Veteran**: for dogs with sighthound breed in its background over the age of 7 years.

When running as a stake within a regular ASFA trial, Small will run 50% of the ASFA course as laid out for the sighthounds up to a maximum of 400 yards. All other stakes will run the full ASFA laid out course length.

SINGLES STAKE: For any eligible sighthound, including sighthounds disqualified to run in other stakes. Each hound runs alone and is not eligible to compete for Best of Breed or Best in Field. Points earned in this stake go toward TCP & CPX titles. Except that Provisional Stake breeds are not eligible for these titles. All hounds entering Open or Veteran for the first time MUST include a completed ASFA certification, AKC QC form or waiver form and a copy of the hound's registration certificate (registration is not required for NGA Greyhounds ONLY; certification or waiver is not required for Singles stake entries ONLY).

**BEST IN FIELD WILL NOT BE OFFERED, BUT BEST IN EVENT WILL BE OFFERED ON SUNDAY.** Best of Breed winners from both Saturday and Sunday that ran both days without scratches or forfeits are eligible to compete for the Minnesota Cup. The Minnesota Cup run will follow the BOB run-offs on Sunday. <u>Singles, Limited and LCI are not eligible for Best in Event.</u>

## Conditions of Entry (applies to all stakes)

- > Hounds must be one year of age or older on day of trial.
- > Stakes will be split into flights by public random draw if the entry in any stake is 20 or more.
- Females in season, lame hounds/dogs and those that are unfit to course will be excused at roll call.
- Hounds with breed disqualifications that are entered in regular breed stakes will be excused at roll call.
- Spayed, neutered, monorchid or cryptorchid without breed disqualifications may be entered in regular hound breed stakes.
- > Hounds with breed disqualifications are eligible to enter Singles Stake.
- > Hounds/dogs not present at the time of roll call will be scratched.
- > All hounds/dogs will be run twice unless excused, dismissed or disqualified.
- > All hounds/dogs will run in trios if possible, or braces (except in Singles and LCI stakes).
- > A separate entry form is required for each dog for each day.

## **Other Information**

- > Battery powered continuous loop lure machine will be used. Backup equipment will be available.
- > Lure will consist of highly visible plastic strips.
- > Exhibitors are requested to not bring bitches known to be in season to the field.
- > There will be a \$5.00 fine assessed for any loose hound not participating in the course.
- Any person may, upon reasonable complaint, be asked to leave the grounds of the field trial by the Field Trial Committee.
- > The field is partially fenced.
- > Children must be under control of their parents or guardians at all times.





- If you are entering LCI and your dog has no other registration, include the "OFFICIAL AMERICAN SIGHTHOUND FIELD ASSOCIATION Request for ASFA Lure Chasing Instinct Registration Number" form and one-time registration fee.

**PRACTICES & HOUND CERTIFICATIONS** Except for Hounds entered in Singles Stake that may certify before the trial, certs & hound practices will be available after the trial on <u>Saturday</u> (weather, equipment & field conditions permitting). The fee for a certification run is \$5. Make arrangements for a hound to run with, and have the proper form for the judge to sign. Certifications will be run before practice runs as a courtesy to the judges.

**REFUNDS** - *MCA will refund entry fees for anyone who cannot or should not attend the trial due to illness, possible illness, or exposure to illness during the pandemic. Contact the Field Trial Secretary.* MCA also provides refunds of entry fees for dogs that are in season or lame, so long as the Field Trial Secretary is notified of the situation **before roll call**. If your dog comes in season or becomes lame before the Trial, and you will not be attending the Trial for that reason, you must notify the Field Trial Secretary BEFORE roll to claim a refund. If the Field Trial Secretary does not receive notice before roll call, MCA will not issue a refund.

## How To Register for LCI (Lure Chasing Instinct) Stake <u>for the First Time</u>

All dogs entered in LCI stake must have a registration number. If your dog is registered under any of options A - E below, you must attach a copy (not the original) of the registration certificate to your dog's first ASFA trial entry form. If your dog is not registered under any of the options A–E below, you may obtain a registration number under paragraph F below.

- A. A registration from AKC or CKC as one of their recognized breeds, or
- B. A registration from AKC "Canine Partners" or CKC (CCN) as a mixed-breed or other ineligible dog for registration under A (above), or
- C. A registration from AKC PAL (Purebreed Alternative Listing), as a pure breed dog ineligible for registration under A (above), or
- D. An FSS (Foundation Stock Service) breed, as a member of a breed that is in the process of obtaining full AKC recognition, or
- E. A registration from UKC (United Kennel Club), which is an international dog registry that focuses on performance, or
- F. If your dog has no registration, you can register your dog with ASFA at the time your dog enters his/her first trial as follows:
  - Complete the registration form entitled "OFFICIAL AMERICAN SIGHTHOUND FIELD ASSOCIATION Request for ASFA Lure Chasing Instinct Registration Number" which is located among the forms toward the end of this premium list.
  - Attach a one time registration fee of \$10, payable to ASFA
  - Submit the registration form and fee to the Field Trial Secretary <u>along with</u> <u>for your dog's first ASFA trial entry form.</u>

The Field Trial Secretary will submit the registration form and fee to ASFA along with the trial records. Please retain a copy for your records until you receive a permanent registration number from ASFA.
