



Directions to the Field

From either north or south on I-35, take exit 81 east (County Road 70). Follow 70 east about 3 miles to Cedar Avenue. Turn left on Cedar about 1/8 mile to Highway 50. Turn right (east) on 50 to Farmington. Follow the signs to the Dakota County Fairgrounds. Proceed to the southwest side of the fairgrounds. The South field is located adjacent to the Pioneer Village.

Eligible Breeds & Registration

Only purebred Afghan Hounds, Azawakhs, Basenjis, Borzoi, Cirneco dell'Etna, Greyhounds, Ibizan Hounds, Irish Wolfhounds, Italian Greyhounds, Pharaoh Hounds, Rhodesian Ridgebacks, Salukis, Scottish Deerhounds, Silken

Windhound, Sloughis, Whippets, and Provisional breeds may be entered in the regular stakes.

Current Provisional breeds include purebred Chart Polski, Galgo Español, Magyar Agar, Peruvian Inca Orchid, Portuguese Podengo (Pequeno), Portuguese Podengo (Medio & Grande), and must be individually registered with the appropriate registry.

Open to NON sighthounds and sighthound mixes, <u>see</u> Lure Chasing Instinct Stake (below).

All entries shall be individually registered with the AKC (including ILP and PAL), the NGA, the UKC, the FCI, an ASFA-recognized foreign or ASFA Board approved registry, or possess a CRN from the SPDBS. A photocopy of acceptable registry must be submitted with each hound's first ASFA field trial entry; this requirement is waived for hounds registered with the NGA.

Regular Stakes Offered

<u>OPEN STAKE</u>: For any eligible sighthound that has met certification requirements, excluding ASFA Field Champions of record.

<u>FIELD CHAMPION STAKE</u>: For any ASFA Field Champion of record.

<u>VETERAN STAKE</u>: Any eligible hound that has met the certification process whose age is at least six years, except Irish Wolfhounds whose age shall be at least five and Afghans, Rhodesian Ridgebacks, Salukis, and Whippets whose age shall be at least seven years. Points go toward V-FCh or V-LCM titles

<u>PROVISIONAL STAKE:</u> Any eligible sighthound of a Provisional breed that has met certification requirements. Not eligible to compete in Best of Breed or Best in Field.

LURE COURSING INSTINCT (LCI) STAKE: Open to NON sighthounds and sighthound mixes. Entries shall be individually registered with the AKC (including ILP & PAL), the UKC, the FCI, an ASFA recognized foreign or ASFA Board approved registry, possess a CRN from the SPDBS. Or, dogs without a recognized registry number may obtain an ASFA identification number for a \$10 registration fee at time of entry.

Small Open: for dogs 17.5" or less at the withers and / or brachycephalic ("flat-faced") dogs who have not achieved the title of LCC.

Small Senior: for dogs 17.5" or less at the withers and/or brachycephalic dogs who have achieved the title of LCC.

Small Veteran: for dogs 17.5" or less at the withers and/or brachycephalic dogs over the age of 7 years.

Large Open: for dogs over 17.5" at the withers who have not achieved the title of LCC.

Large Senior: is for dogs over 17.5" at the withers who have achieved the title of LCC. **Large Veteran**: for dogs over 17.5" at the withers who are over the age of 7 years.

Sighthound mix Open: for dogs with a sighthound breed in its background who have not achieved the title of LCC.

Sighthound mix Senior: for dogs with sighthound breed in its background who have achieved the title of LCC.

Sighthound mix Veteran: for dogs with sighthound breed in its background over the age of 7 years.

When running as a stake within a regular ASFA trial, Small will run 50% of the ASFA course as laid out for the sighthounds up to a maximum of 400 yards. All other stakes will run the full ASFA laid out course length.

SINGLES STAKE: For any eligible sighthound, including including sighthounds disqualified to run in other stakes. Each hound runs alone and is not eligible to compete for Best of Breed or Best in Field. Points earned in this stake go toward TCP & CPX titles. Except that Provisional Stake breeds are not eligible for these titles.

All hounds entering Open or Veteran for the first time MUST include a completed ASFA certification, AKC QC form or waiver form and a copy of the hound's registration certificate (registration is not required for NGA Greyhounds ONLY; certification or waiver is not required for Singles stake entries ONLY).

BEST IN FIELD will be offered on Saturday.

Conditions of Entry

Hounds must be one year of age or older on day of trial. • Stakes will be split into flights by public random draw if the entry in any regular stake is 20 or more. • Bitches in season, lame hounds, and hounds with breed disqualifications will be excused at roll call. • Spayed, neutered, monorchid or cryptorchid hounds without breed disqualifications may be entered. Hounds with breed disqualifications are not eligible to enter, except in Singles Stake. • Hounds not present at the time of roll call will be scratched. • All Hounds will be run twice in trios if possible, or braces (except in the Singles Stake and Lure Chasing Instinct Stake), unless excused, dismissed or disqualified.

MCA provides loaner slip leads and blankets.

Preliminary courses for all breeds will be completed before beginning final courses.


Equipment


Course Plans


The course will be reversed for finals, runoffs and Best of Breed. MCA reserves the right to alter the course plan as required by weather and/or field conditions on the day of the trial.

The terrain is grassy.

Other Information

- Exhibitors are asked **not** to bring bitches known to be in season to the field.
- A \$5.00 fine will be assessed for any loose dog not participating in the course.
- Any person, upon reasonable complaint, may be asked to leave the grounds of the field trial by the Field Trial Committee.
- The field is partly fenced.
- There is limited shade and some water at the site.
- Dogs must be on leash or crated, except when they are running in their courses.
- Children must be under the control of their parents or guardians.
- PLEASE CLEAN UP AFTER YOURSELVES AND YOUR DOGS!!
- ALL RETURNED CHECKS WILL BE CHARGED A \$40 FEE.
- CERTIFICATIONS will be offered on Saturday after completion of the trial if weather, equipment, daylight & judges permit. The cost is \$5 per hound for MCA members, \$10 for non-members. Please arrange for a hound to run with your testing hound, and have the Hound Certification Form ready for the judge to sign. (The form is included in this premium list.) As a courtesy to judges, certifications will be run before practices.
- PRACTICES AND LURE OPERTAING TRAINING will be offered on Saturday ONLY, weather equipment and time permitting. The cost is \$5 for MCA members, \$10 for non-members.
- Please notify the Field Trial Secretary if your hound is close to completing a title.

Procedures for COVID-19 Safety

- ✓ We will follow State of Minnesota and local guidelines.
- ✓ Bring your own facial covering. All participants will be required to wear while
 on the field.
- ✓ No food will be served, bring your own breakfast and lunch, coffee, water & beverages.
- ✓ We ask that you park at a safe distance from other cars. This may mean that you will not find parking in the shade. Accordingly, be sure to bring plenty of shade for your dog(s) and yourself.
- ✓ There is no water available on or near the South Field. Bring your own water.
- ✓ Roll Call and Inspection will be done at you car, instead of in a central location.

 The roll call committee will wear gloves and facial coverings. We will ask the owners of females to wipe their dogs and show the inspection committee the tissue.
- ✓ For dogs that require wicketing, the wickets will be wiped down after each dog.
- ✓ Bring your own face covering, hand sanitizer, and wet wipes.
- Restroom doors will be left open for airflow.
- ✓ Huntmasters will stand 6 feet from the dogs after inspecting blankets and slip leads.
- ✓ At the starting line, all dogs will stand 6 feet apart.
- ✓ Practice social distancing. Act responsibly!!
- ✓ The running order will be posted as usual, and if needed, we will use a bull horn to notify you if you choose to stay by your car.
- ✓ Bring your own poop bags, pens, paper avoid having to borrow from others.
- ✓ Above all, be safe and have fun with your dogs!!!
