

## Eligible Breeds & Registration

Purebred Afghan Hounds, Azawakhs, Basenjis, Borzoi, Cirnechi dell'Etna, Greyhounds, Ibizan Hounds, Irish Wolfhounds, Italian Greyhounds, Pharaoh Hounds, Rhodesian Ridgebacks, Salukis, Scottish Deerhounds, Silken Windhounds, Sloughis and Whippets may be entered in all stakes.

Limited breeds may be entered in the Limited Stake or Singles Stake. Limited breeds currently include purebred Chart Polski, Galgo Español, Magyar Agar, Peruvian Inca Orchid, Portuguese

Podengo (Pequeno), Portuguese Podengo (Medio & Grande), and must be individually registered with the appropriate registry.

Lure Chasing Instinct (LCI) Stake is open to all non-sighthound breeds and mixed breeds. See Lure Chasing Instinct Stake (below).

All entries shall be individually registered with the AKC (including ILP and PAL), the NGA, the UKC, the FCI, an ASFA-recognized foreign or ASFA Board approved registry, or possess a CRN from the SPDBS. A photocopy of acceptable registry must be submitted with each hound's first ASFA field trial entry; this requirement is waived for hounds registered with the NGA.

## **Regular Stakes Offered**

<u>OPEN STAKE</u>: For any eligible sighthound that has met certification requirements, excluding ASFA Field Champions of record.

<u>FIELD CHAMPION STAKE</u>: For any ASFA Field Champion of record. Except that hounds whose owner records show them to be ASFA Field Champions may be entered for a period up to 90 days without official certification. Hounds whose owner records show them to have met the requirements for the Field Champion title may be changed from the Open stake to the Field Champion stake provided notification is made to the Field Trial Secretary prior to roll call. Hounds determined to be not eligible to compete in the Field Champion stake will forfeit all points and placements earned in that stake toward an LCM.

<u>VETERAN STAKE</u>: For any eligible sighthound whose age is at least six years and who has met certification requirements. Except Irish Wolfhounds, whose age shall be at least five years, and Afghans, Rhodesian Ridgebacks, Salukis and Whippets, whose age shall be at least seven years. Points earned in this stake go toward V-FCH and V-LCM titles.

\*\*NEW\*\* LURE COURSING INSTINCT (LCI) STAKE: Open to all non-sighthound breeds. Entries shall be individually registered with the AKC (including ILP & PAL), the UKC, the FCI, an ASFA recognized foreign or ASFA Board approved registry, possess a CRN from the SPDBS. Or, dogs without a recognized registry number may obtain an ASFA identification number for a \$10 registration fee at time of entry. See ASFA Registration Form latr in this premium list. LCI stake is offered on Saturday only and will be limited to a total of 10 entries. Small is for dogs shorter than 17-1/2 inches at the withers and/or brachycephalic ("flat-faced") dogs. Large is for dogs over 18 inches at the withers. Small will run 50% of the course as laid out in this premium up to a maximum of 400 yards. All other sizes will run the full course length.

<u>LIMITED STAKE</u>: For sighthounds of any breed that has been approved for Limited Status and that has met certification requirements. Sighthounds running in Limited Stake are not eligible to compete in Best of Breed or Best in Field.

SINGLES STAKE: For any eligible sighthound, including Limited Stake breeds, and including sighthounds disqualified to run in other stakes. Each hound runs singly and is not eligible to compete for Best of Breed or Best in Field. Points earned in this stake go toward TCP & CPX titles. Except that Limited Stake breeds are not eligible for these titles.

## BEST IN FIELD WILL BE OFFERED ON SATURDAY ONLY.

## **Conditions of Entry**

Hounds must be one year of age or older on day of trial. • Stakes will be split into flights by public random draw if the entry in any regular stake is 20 or more. • Bitches in season, lame hounds, and hounds with breed disqualifications will be excused at roll call. • Spayed, neutered, monorchid or cryptorchid hounds without breed disqualifications may be entered. Hounds with breed disqualifications are not eligible to enter, except in Singles Stake. • Hounds not present at the time of roll call will be scratched. • All Hounds will be run twice in trios if possible, or braces (except in the Singles Stake and Lure Chasing Instinct Stake), unless excused, dismissed or disqualified.

MCA provides slip leads and blankets.

Preliminary courses for all breeds will be completed before beginning final courses.


## Equipment

PRACTICE SESSIONS AND HOUND CERTIFICATIONS will be available after the trial on <u>SATURDAY ONLY</u> (weather, equipment & field conditions permitting). Anyone certifying a hound must pay \$5, make arrangements for a hound to run with, and have the proper form for the judge to sign. (The form is included in the premium list.) Certifications will be run before practice runs as a courtesy to the judges,.

**REFUNDS** - MCA will refund entry fees for dogs that are in season or lame, so long as the Field Trial Secretary is notified of the situation **before roll call** If your dog comes in season or becomes lame before the Trial, and you will not be attending the Trial for that reason, you must notify the Field Trial Secretary BEFORE roll to claim a refunt. If the Field Trial Secretary does not receive notice before roll call, MCA will not issue a refund.
