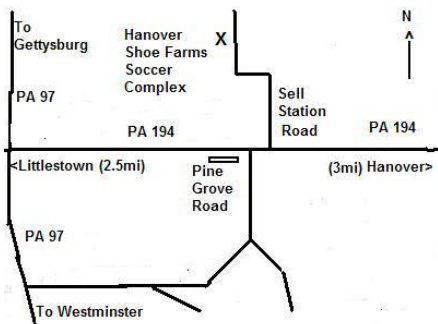
**Directions to Hanover Shoe Farms, Sells Station Road Site:**

**Map of area:**

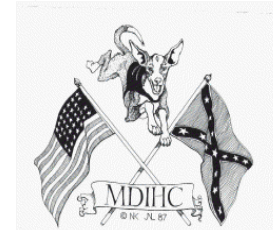

### ELIGIBLE BREEDS & REGISTRY

Only purebred Afghan Hounds, Azawakhs, Basenjis, Borzoi, Cirneco dell'Etna, Greyhounds, Ibizan Hounds, Irish Wolfhounds, Italian Greyhounds, Pharaoh Hounds, Rhodesian Ridgebacks, Salukis, Scottish Deerhounds, Silken Windhounds, Sloughis, and Whippets.

Limited breeds may be entered in the Limited Stake or the Singles Stake. Limited breeds currently include purebred Chart Polski, Galgo Español, Magyar Agar, Peruvian Inca Orchid, Portuguese

Podengo (Pequeno), Portuguese Podengo (Medio & Grande), and must be individually registered with the appropriate registry.

All entries shall be individually registered with the AKC (ILP/PAL included), the NGA, the UKC, the FCI, an ASFA-recognized foreign or ASFA Board approved registry, or possess a CRN from the SPDBS. A photocopy of acceptable registry must be submitted with each hound's first ASFA field trial entry; this requirement is waived for hounds registered with the NGA.

### REGULAR STAKES OFFERED

**OPEN STAKE:** Any eligible sighthound that has met certification requirements, excluding ASFA Field Champions of record.

**FIELD CHAMPION STAKE:** Any ASFA Field Champion

**VETERAN STAKE:** Any eligible hound whose age is at least six years, except Irish Wolfhounds whose age shall be at least five years, and Afghan Hounds, Rhodesian Ridgebacks, Salukis and Whippets whose age shall be at least seven years. Points go toward V-FCh or V-LCM titles.

**LIMITED STAKE:** Any eligible sighthound of a Limited breed that has met certification requirements. Not eligible to compete in Best of Breed or Best in Field.

**SINGLE STAKE:** Any eligible sighthound including those disqualified to run in other stakes. Each hound runs alone. Not eligible for Best of Breed or Best in Field. Hounds are eligible to earn TCP and CPS titles from the Singles stake. Limited breeds are not eligible for these titles.

**Lure Coursing Instinct STAKE:** Open to all breeds. All entries shall be individually registered with the AKC (including ILP & PAL), the UKC, the FCI, an ASFA recognized foreign or ASFA Board approved registry, or possess a CRN from the SPDBS. A photocopy of acceptable registry must be submitted with each dog's first ASFA field trial entry. Dogs without a recognized registry number may obtain an ASFA ID number for a \$10 registration fee at time of entry. This stake will be limited to a total of 20 entries.

**Small** is for dogs shorter than 18 inches at the withers and / or brachycephalic ("flat-faced") dogs.

**Large** is for dogs over 18 inches at the withers.

**Small** will run 50% of the course as laid out in this premium up to a maximum of 400 yards. All other sizes will run the full course length.

- **All entries must be one year or older on the day of the trial**
- **Stakes will be split into flights by public random draw if the entry in any regular stake is 20 or more**
- **Bitches in season, lame hounds and hounds with breed disqualifications will be excused at roll call. Spayed, neutered, monorchid or cryptorchid hounds without breed disqualifications may be entered.**
- **Hounds with breed disqualifications are not eligible to enter except in the Single Stake**
- **Hounds not present at the time of roll call will be scratched**
- **All hounds will run twice, in trios if possible or braces (except in the Single Stake), unless excused, dismissed or disqualified. Battery powered, continuous loop lure machines will be used. The lure will consist of white plastic strips. Backup equipment will be available. The course will be reversed for the finals, runoffs and Best of Breed.**

The members of MDIHC reserve the right to alter the course plan as required by weather and/or field conditions on the date of the trial. Exhibitors are requested to not bring bitches known to be in season to the field.

There will be a \$5.00 fine assessed for any loose hound not participating in the course.

Any person may, upon reasonable complaint, be asked to leave the grounds of the field trial by the Field Trial Committee.

The field is board fenced; camping is permitted, but there is NO electricity or water.

**Children must be under control of their parents or guardians at all times.**

**NOTICE FOR FIRST-TIME ENTERED HOUNDS**

As of January 1, 2003, any hound which is first-time entered in a trial, must have a copy of the hound's registration papers to send in with the entry. This is true if the hound is entering Open, Veteran, Singles, or Limited Stake for the first time.

## 2019 Best in Sighthound Spree Rules:

- To be eligible for Best in Sighthound Spree, a hound MUST participate in both the Fun Match on Saturday and the ASFA Trial on Sunday.

- A hound may be entered in any of the Adult Classes in the Fun Match to be eligible for the Spree trophy (12-18, Open, Altered or Coursing) but may be entered in the Coursing Class ONLY if pre-entered in the ASFA Field Trial on Sunday.

- The dog from each breed with most dogs defeated over two days, combining Conformation and the Field Trial, will advance to the Spree judging following Sunday's trial. Any breed ties will be "judged off" before the final Spree judging.

- The Best in Event Ribbon and Trophy will be awarded to the hound that, in the opinion of the Judges, characterizes the best combination of Form and Function for its breed.
