Ribbons

Ribbons or rosettes will be offered for all placements, 1st (blue), 2nd (red), 3rd (yellow), 4th (white), NBQ (green), High Scoring Single (navy/gold), Best of Breed (purple/gold), & Best in Field (red/white/blue). Other prizes may be offered by MGA and friends of MGA.

Trial Hours: 7:00 A.M. until one hour after the last scored course of the day

Substitutions will be accepted for lame or in-season hounds.

Make checks payable to "MGA" in US funds. Do NOT send entries "signature required". Entries will NOT be acknowledged by mail. Late, incomplete, or unpaid entries will not be accepted. Entries will be acknowledged by e-mail if a legible e-mail address is provided on the entry form. There will be a \$25 fee for any returned check.

Eligible Breeds & Registry

Only purebred Afghan Hounds, Azawakhs, Basenjis, Borzoi, Cirnecho dell'Etna, Greyhounds, Ibizan Hounds, Irish Wolfhounds, Italian Greyhounds, Pharaoh Hounds, Rhodesian Ridgebacks, Salukis, Scottish Deerhounds, Silken Windhounds, Sloughis, Whippets and Provisional breeds may be entered in the regular stakes. Current Provisional breeds include purebred Chart Polski, Galgo Español, Magyar Agar, Peruvian Inca Orchid, Portuguese Podengo (Pequeno), and Portuguese Podengo (Medio & Grande), and must be individually registered with the appropriate registry.

All entries shall be individually registered with the AKC (ILP/PAL included), the NGA, the UKC, the FCI, an ASFA-recognized foreign or ASFA Board approved registry, or possess a CRN from the SPDBS. A photocopy of acceptable registry must be submitted with each hound's first ASFA field trial entry; this requirement is waived for hounds registered with the NGA.

Regular Stakes Offered

OPEN STAKE: Any eligible sighthound, excluding ASFA Field Champions of record, that has met the certification requirements.

FIELD CHAMPION STAKE: Any ASFA Field Champion of record.

VETERAN STAKE: Any eligible sighthound that has met the certification requirements and whose age is at least six years, except Irish Wolfhounds, whose age shall be at least five years, and Afghan Hounds, Rhodesian Ridgebacks, Salukis, and Whippets, whose age shall be at least seven years.

Points go toward V-FCh or V-LCM titles.

BEST IN FIELD WILL BE OFFERED

PROVISIONAL STAKE: Any eligible sighthound of a Provisional breed that has met certification requirements. Not eligible to compete for Best of Breed or Best in Field.

SINGLE STAKE: Any eligible sighthound including those disqualified to run in other stakes. Each hound runs alone. Not eligible for Best of Breed or Best in Field. Hounds are eligible to earn TCP and CPX titles from the Singles stake. Provisional breeds are not eligible for these titles.

Lure Coursing Instinct (LCI) Stakes

Open to non-sighthound and sighthound mixes. All entries must be individually registered with the AKC (including ILP and PAL) or the UKC. A photocopy of acceptable registry must be submitted with each dog's first ASFA field trial entry. Dogs without a recognized registry number may obtain an ASFA ID number for a \$10 registration fee at time of entry.

SMALL OPEN STAKE: For dogs 17-1/2 inches or less at the withers and/or brachycephalic ("flat-faced") dogs that have not achieved the title of LCC.

SMALL SENIOR STAKE: For dogs 17-1/2 inches or less at the withers and/or brachycephalic dogs that have achieved the title of LCC.

SMALL VETERAN STAKE: For dogs 17-1/2 inches or less at the withers and/or brachycephalic dogs that are over the age of 7 years.

LARGE OPEN STAKE: For dogs over 17-1/2 inches at the withers that have not achieved the title of LCC.

LARGE SENIOR STAKE: For dogs over 17-1/2 inches at the withers that have achieved the title of LCC.

LARGE VETERAN STAKE: For dogs over 17-1/2 inches at the withers that are over the age of 7 years.

SIGHTHOUND MIX OPEN STAKE: For dogs with sighthound breed in its background that have not achieved the title of LCC.

SIGHTHOUND MIX SENIOR STAKE: For dogs with sighthound breed in its background that have achieved the title of LCC.

SIGHTHOUND MIX VETERAN STAKE: For dogs with sighthound breed in its background that are over the age of 7 years.

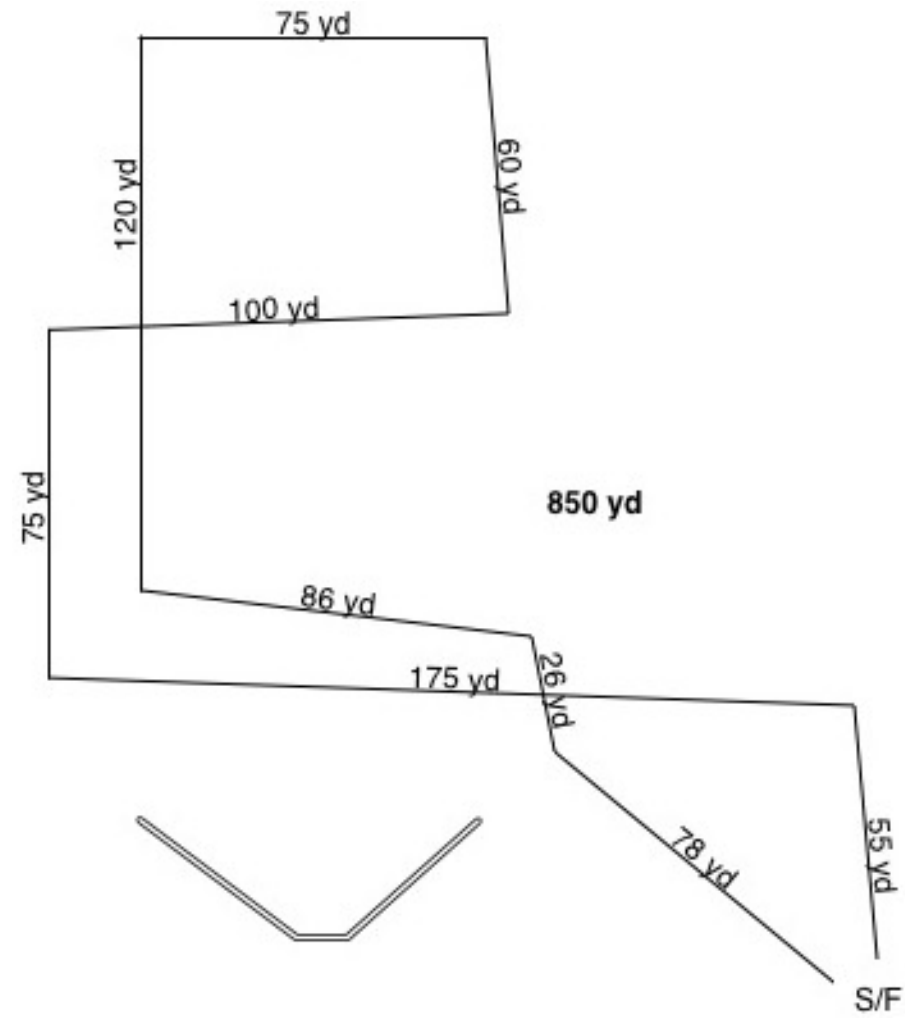
Conditions of Entry

All entries must be one year or older on the day of the trial • Stakes will be split into flights by public random draw if the entry in any regular stake is 20 or more • Bitches in season, lame hounds and hounds with breed disqualifications will be excused at roll call. Spayed, neutered, monorchid or cryptorchid hounds without breed disqualifications may be entered. Hounds with breed disqualifications are not eligible to enter except in the Single Stake • Hounds not present at the time of roll call will be scratched • All hounds will run twice, in trios if possible or braces (except in the Single Stake and all LCI Stakes), unless excused, dismissed or disqualified.

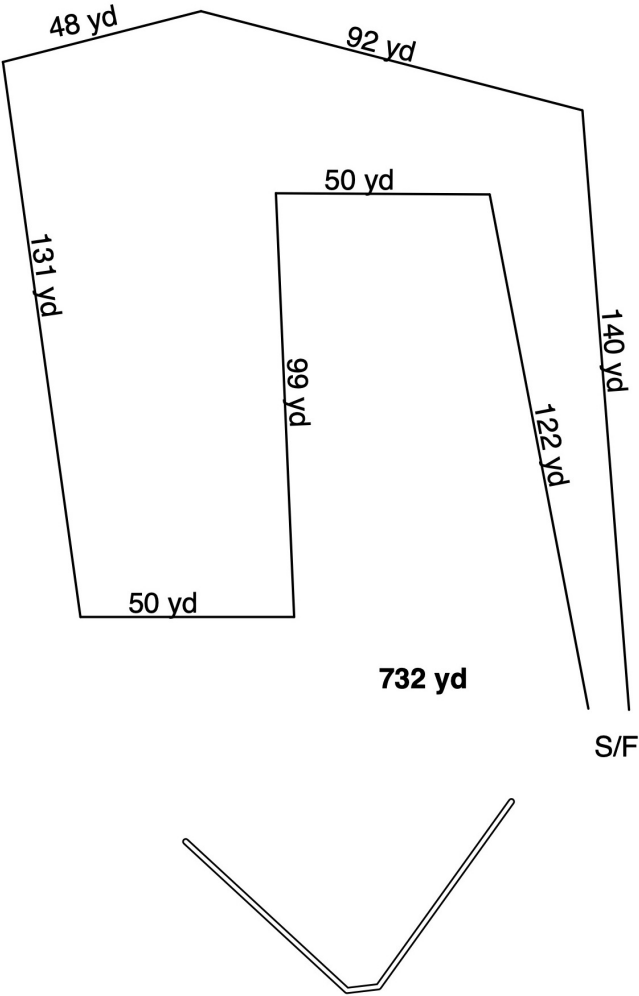
Course Plans

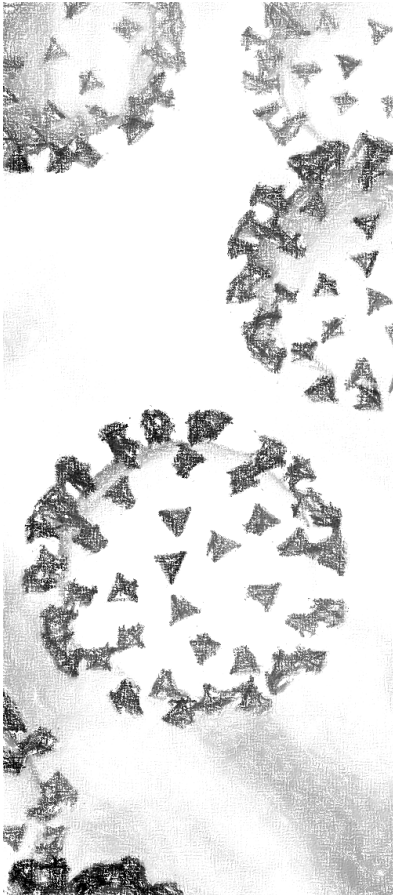
Gas- or battery-powered continuous loop lure machines will be used, with backup equipment on site • The lure will consist of highly visible white or black plastic strips and/or fur strips • Course may be altered as required by weather or field conditions • A \$5.00 fine will be collected from the handler of any non-competing hound running loose on the field during the course in progress, and from any person not cleaning up after his/her hound.

COVID-19 PROCEDURES AND POLICIES

MGA reserves the right to change these procedures and policies as regulations and circumstances evolve before and during the event.

Please stay home...

- If you are ill, feel unwell, coughing, sneezing, or running a temperature;
- If you have recently been in the presence of a person who has either tested positive for COVID-19 or has the symptoms (coughing/sneezing/temperature); or
- **If you are unable or unwilling to wear a mask.**

Please **park with** enough **separation** for another vehicle.

Masks must be worn when using the restrooms in park buildings or portable toilets. When exiting a portable toilet, please prop the door open to facilitate air circulation.

Avoid touching dogs that are not your responsibility.

Field committee members, the judge, and all exhibitors must **maintain 6-foot social distancing** whenever possible.

The field committee and judge will wear masks.

All exhibitors interacting with field committee members, including the secretary, or the judge, having their dog inspected, waiting in the paddock, or running their dog in the course must **wear masks**. Please consider wearing a mask whenever away from your vehicle.

Roll call and **inspection** will be **performed on one dog at a time at your vehicle**. If you enter a bitch, you will **swipe your own dog** and show the inspection committee the tissue. The inspection committee will sanitize the wicket between dogs.

To minimize persons in the paddock, please remain at a distance until your dog's course has been called to the paddock.

Hounds will be slipped 6 feet apart. The huntmaster will be positioned at least 6 feet from any exhibitor after inspecting blankets and slip leads.

Exhibitors are advised to **refrain from touching any field equipment, including the lures**.

Draw sheets and score sheets will be posted both on-site and on-line. Please retrieve your information quickly and avoid congregating. Bring your own pen and paper, take a picture, or use social media, such as MGA's public Facebook page.
