From the South: I-75 to Lapeer Rd (M24, north of Pontiac). Go north on Lapeer Rd to Sutton Rd. Turn right on Sutton Rd. Go 2 miles to 440 E Sutton Rd. The drive to the field is on the right, just before the farmhouse. Follow signs down the drive and park on right.

From the North: I-69 to Lapeer Rd (M24, north of Pontiac). Go south on Lapeer Rd to just past Sutton Rd. Do a U-Turn (a "Michigan left"). Go back to Sutton Rd, and turn right. Go 2 miles to 440 E Sutton Rd. The drive to the field is on the right, just before the farmhouse. Follow signs down the drive and park on right.

Ribbons

Ribbons or rosettes will be offered for all placements, 1st (blue), 2nd (red), 3rd (yellow), 4th (white), NBQ (green), Best Single Stake Winner (navy/gold), Best of Breed (purple/gold), & Best in Field (red/white/blue). Other prizes may be offered by MGA and friends of MGA.

Make checks payable to "MGA". Do NOT send entries "signature required". Entries will NOT be acknowledged by mail. Late, incomplete, or unpaid entries will not be accepted. Entries will be acknowledged by e-mail if a legible e-mail address is provided on the entry form. There will be a \$25 fee for any returned check.

Eligible Breeds & Registry

Only purebred Afghan Hounds, Azawakhs, Basenjis, Borzoi, Cirnecho dell'Etna, Greyhounds, Ibizan Hounds, Irish Wolfhounds, Italian Greyhounds, Pharaoh Hounds, Rhodesian Ridgebacks, Salukis, Scottish Deerhounds, Sloughis, Whippets, and Provisional breeds may be entered in the regular stakes. Current Provisional breed: Silken Windhounds. Limited breeds may be entered in the Limited Stake or the Singles Stake. Limited breeds currently include purebred Chart Polski, Galgo Español, Magyar Agar, Peruvian Inca Orchid, Portuguese Podengo (Pequeno), and Portuguese Podengo (Medio & Grande), and must be individually registered with the appropriate registry.

All entries shall be individually registered with the AKC, the NGA, the UKC, the FCI, an ASFA-recognized foreign or ASFA Board approved registry, or possess a CRN from the SPDBS. A photocopy of acceptable registry must be submitted with each hound's first ASFA field trial entry; this requirement is waived for hounds registered with the NGA.

Regular Stakes Offered

OPEN STAKE: Any eligible sighthound, excluding ASFA Field Champions of record.

FIELD CHAMPION STAKE: Any ASFA Field Champion of record.

VETERAN STAKE: Any eligible hound whose age is at least six years, except Irish Wolfhounds, whose age shall be at least five years, and Afghan Hounds, Rhodesian Ridgebacks, and Whippets, whose age shall be at least seven years. Points go toward V-FCh or V-LCM titles.

LIMITED STAKE: Any eligible sighthound of a Limited breed that has met certification requirements. Not eligible to compete in Best of Breed or Best in Field.

SINGLE STAKE: Any eligible sighthound including those disqualified to run in other stakes. Each hound runs alone. Not eligible for Best of Breed or Best in Field. Hounds are eligible to earn TCP and CPX titles from the Singles stake. Limited breeds are not eligible for these titles.

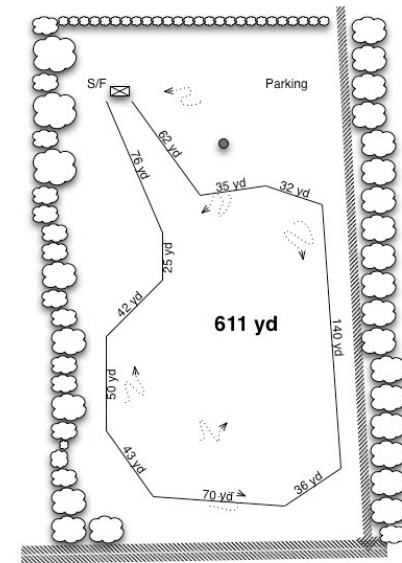
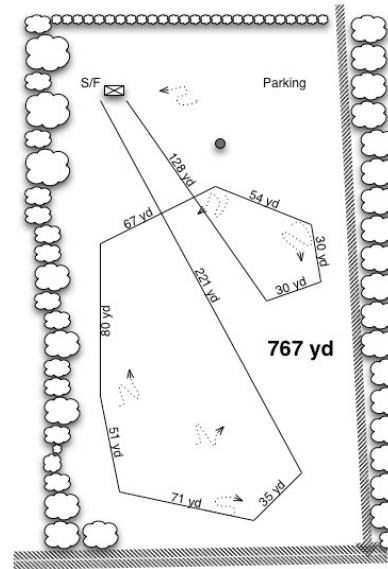
Conditions of Entry

All entries must be one year or older on the day of the trial • Stakes will be split into flights by public random draw if the entry in any regular stake is 20 or more • Bitches in season, lame hounds and hounds with breed disqualifications will be excused at roll call. Spayed, neutered, monorchid or cryptorchid hounds without breed disqualifications may be entered. Hounds with breed disqualifications are not eligible to enter except in the Single Stake • Hounds not present at the time of roll call will be scratched • All hounds will run twice, in trios if possible or braces (except in the Single Stake), unless excused, dismissed or disqualified.

Course Plans

Battery-powered continuous loop lure machines will be used, with backup equipment on site • The lure will consist of highly visible white or black plastic strips and/or fur strips • Course may be altered as required by weather or field conditions • A \$5.00 fine will be collected from the handler of any non-competing hound running loose on the field during the course in progress, and from any person not cleaning up after his/her hound.

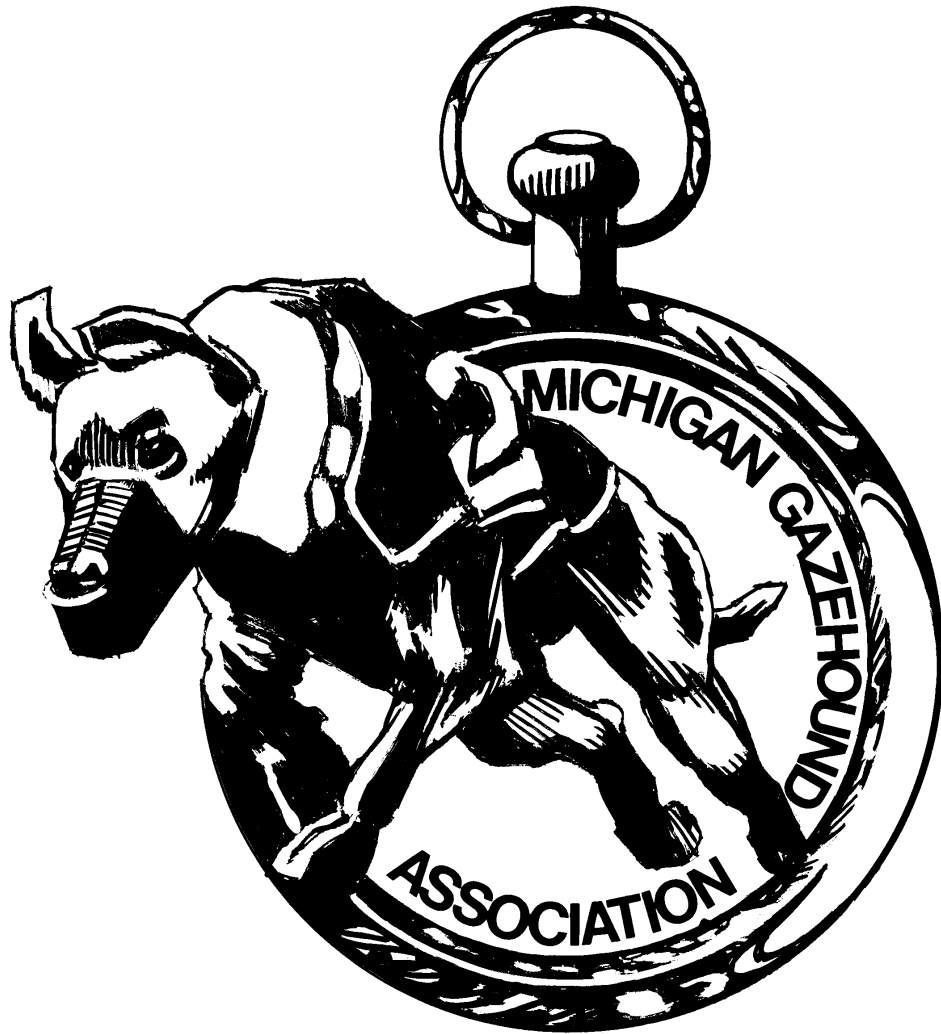
