Only purebred Afghan Hounds, Azawakhs, Basenjis, Borzoi, Cirnecho dell'Etna, Greyhounds, Ibizan Hounds, Irish Wolfhounds, Italian Greyhounds, Pharaoh Hounds, Rhodesian Ridgebacks, Salukis, Scottish Deerhounds, Silken Windhounds, Sloughis, Whippets and Provisional breeds may be entered in the regular stakes. Current Provisional breed: none. Limited breeds may be entered in the Limited Stake or the Singles Stake. 


