Current Provisional breeds include purebred Chart Polski, Galgo Español, Magyar Agar, Peruvian Inca Orchid, Portuguese Podengo (Pequeno), and Portuguese Podengo (Medio & Grande), and must be individually registered with the appropriate registry.


