Substitutes for lame or in-season hounds are allowed if substitute has same owner and the Field Secretary is notified by 8:00 AM the day of the trial.

ELIGIBLE BREEDS & REGISTRY

Only purebred Afghan Hounds, Azawakhs, Basenjis, Borzoi, Cirneco dell'Etna, Greyhounds, Ibizan Hounds, Irish Wolfhounds, Italian Greyhounds, Pharaoh Hounds, Rhodesian Ridgebacks, Salukis, Scottish Deerhounds, Silken Windhound, Sloughis, Whippets, and Provisional breeds may be entered in the regular stakes. Current Provisional breed: none. Limited breeds may be entered in the Limited Stake or the Singles Stake. Limited breeds currently include purebred Chart Polski, Galgo Español, Magyar Agar, Peruvian Inca Orchid, Portuguese Podengo (Pequeno), Portuguese Podengo (Medio & Grande), and must be individually registered with the appropriate registry.

All entries shall be individually registered with the AKC (including ILP & PAL), the NGA, the UKC, the FCI, an ASFA-recognized foreign or ASFA Board approved registry, or possess a CRN from the SPDBS. A photocopy of acceptable registry must be submitted with each hound's first ASFA field trial entry; this requirement is waived for hounds registered with the NGA.

STAKES OFFERED

OPEN STAKE: Any eligible sighthound, excluding ASFA Field Champions of record. Must possess certification form signed prior to the close of entries

FIELD CHAMPION STAKE: Any ASFA Field Champion

VETERAN STAKE: Any eligible hound whose age is at least six years, except lWs whose age shall be at least five years, and Afghan Hounds, Rhodesian Ridgebacks, Saluki and Whippets whose age shall be at least seven years. Points & placements go toward VFCh and VLCM titles

LIMITED STAKE: Any eligible sighthound of a Limited breed that has met certification requirements.

SINGLES STAKE: Any eligible sighthound including those disqualified to run in other stakes. Each hound runs alone. Not eligible for Best of Breed or Best in Field. Hounds are eligible to earn TCP and CPX titles from the Singles stake. Limited breeds are not eligible for these titles.

Best in Field Will NOT be offered

Ralph Eyles Memorial Trophy awarded to winner of Best in Event Run on Sunday To be eligible:

- Must be entered in regular stakes both days
- Open to all Best of Breed winners each day
- · Must run in all stake courses.

NOTE: This event carries no ASFA recognition.

SPECIAL NOTES

- All entries must be one year or older on the day of the trial.
- Stakes will be split into flights by public random draw if the entry in any regular stake is 20 or more.
- Bitches in season, lame hounds and hounds with breed disqualifications will be excused at roll call.
- Spayed, neutered, monorchid or cryptorchid hounds without breed disqualifications may be entered.
- Hounds with breed disqualifications are not eligible to enter except in the Single Stake.
- Hounds not present at the time of roll call will be scratched
- All hounds will run twice, in trios if possible or braces (except in the Single Stake), unless excused, dismissed or disqualified.
- Muzzles are not required. It is the responsibility of the owner to determine if their hound needs to be muzzled.
- Lure machine is gas powered, continuous loop. Battery back up equipment is available.
- Lure will consist of highly visible plastic strips.
- There will be a \$5 fine for any loose hound on the field that is not part of the course in progress.
- There will be a \$31 fee assessed for any returned checks
- Course will be reversed for finals and again for run-offs and Best of Breed.
- Checks must be in U.S. Funds drawn on U.S. Banks.
- MWCC assumes no liability for injury to any hound or person, before, during or after the trial.

HOUND CERTIFICATION

<u>Certification</u>: Except those entering in Singles. Any entry marked **First Time Entered** must present a completed ASFA hound certification form to the Field Secretary BEFORE entries close. See the back of the entry form for certification forms and make extra copies if needed. Certification runs will be offered at a cost of \$5.00 per run on Saturday only after the completion of the trial. It is the responsibility of the entrant to find another hound of the same breed or similar running style to run with his/her hound for the certification. A sign-up sheet will be available on the day of the trial.

<u>Practice</u>: Limited practice runs will be allowed after the certification runs on Saturday, weather and equipment permitting. A sign-up sheet will be available from the Field Secretary


