## **ELIGIBLE BREEDS & REGISTRY**

Only purebred Afghan Hounds, Azawakhs, Basenjis, Borzoi, Cirneco dell'Etna, Greyhounds, Ibizan Hounds, Irish Wolfhounds, Italian Greyhounds, Pharaoh Hounds, Rhodesian Ridgebacks, Salukis, Scottish Deerhounds, Silken Windhound, Sloughis, Whippets, and Provisional breeds may be entered in the regular stakes. Current Provisional breed: none. Limited breeds may be entered in the Limited Stake or the Singles Stake. Limited breeds currently include purebred Chart Polski, Galgo Español, Magyar Agar, Peruvian Inca Orchid, Portuguese Podengo (Pequeno), Portuguese Podengo (Medio & Grande), and must be individually registered with the appropriate registry.

All entries shall be individually registered with the AKC (including ILP & PAL), the NGA, the UKC, the FCI, an ASFA-recognized foreign or ASFA Board approved registry, or possess a CRN from the SPDBS. A photocopy of acceptable registry must be submitted with each hound's first ASFA field trial entry; this requirement is waived for hounds registered with the NGA.

## **STAKES OFFERED**

**OPEN STAKE:** Any eligible sighthound, excluding ASFA Field Champions of record. Must possess certification form signed prior to the close of entries

FIELD CHAMPION STAKE: Any ASFA Field Champion

**VETERAN STAKE:** Any eligible hound whose age is at least six years, except IWs whose age shall be at least five years, and Afghan Hounds, Rhodesian Ridgebacks, Saluki and Whippets whose age shall be at least seven years . Points & placements go toward VFCh and VLCM titles

**LIMITED STAKE:** Any eligible sighthound of a Limited breed that has met certification requirements. Not eligible for Best of Breed or Best in Field. Hounds are eligible to earn TCP and CPX titles from the Singles stake. Limited breeds are not eligible for these titles.

**SINGLES STAKE:** Any eligible sighthound including those disqualified to run in other stakes. Each hound runs alone. Not eligible for Best of Breed or Best in Field. Hounds are eligible to earn TCP and CPX titles from the Singles stake. Limited breeds are not eligible for these titles.

**LURE COURSING INSTINCT (LCI) STAKE:** Open to NON sighthounds and sighthound mixes. All entries shall be individually registered with the AKC (including ILP & PAL) or the UKC. A photocopy of acceptable registry must be submitted with each dog's first ASFA field trial entry. Dogs without a recognized registry number may obtain an ASFA ID number for a \$10 registration fee at time of entry.

**Small Open**: for dogs 17-1/2 inches or less at the withers and / or brachycephalic ("flat-faced") dogs who have not achieved the title of LCC.

**Small Senior**: for dogs 17-1/2 inches or less at the withers and/or brachycephalic dogs who have achieved the title of LCC.

**Small Veteran**: for dogs 17-1/2 inches or less at the withers and/or brachycephalic dogs over the age of 7 years.

**Large Open**: for dogs over 17-1/2 inches at the withers who have not achieved the title of LCC. **Large Senior**: is for dogs over 17-1/2 inches at the withers who have achieved the title of LCC. **Large Veteran**: for dogs over 17-1/2 inches at the withers who are over the age of 7 years.

Sighthound Mix Open: for dogs with a sighthound breed in its background who have not achieved the title of LCC.

**Sighthound Mix Senior**: for dogs with sighthound breed in its background who have achieved the title of LCC.

**Sighthound Mix Veteran**: for dogs with sighthound breed in its background over the age of 7 years. When running as a stake within a regular ASFA trial, Small will run 50% of the ASFA course as laid out for the sighthounds up to a maximum of 400 yards. All other stakes will run the full ASFA laid out course length.

Best in Field Will be offered both days

## SPECIAL NOTES

- All entries must be one year or older on the day of the trial.
- Stakes will be split into flights by public random draw if the entry in any regular stake is 20 or more.
- Bitches in season, lame hounds and hounds with breed disqualifications will be excused at roll call.
- Spayed, neutered, monorchid or cryptorchid hounds without breed disqualifications may be entered.
- Hounds with breed disqualifications are not eligible to enter except in the Single Stake.
- Hounds not present at the time of roll call will be scratched
- All hounds will run twice, in trios if possible or braces (except in the Single Stake), unless excused, dismissed or disqualified.
- Muzzles are not required. It is the responsibility of the owner to determine if their hound needs to be muzzled.
- Lure machine is gas powered, continuous loop. Battery back up equipment is available.
- Lure will consist of highly visible plastic strips.
- There will be a \$5 fine for any loose hound on the field that is not part of the course in progress.
- There will be a \$31 fee assessed for any returned checks
- Course will be reversed for finals and again for run-offs and Best of Breed.
- Checks must be in U.S. Funds drawn on U.S. Banks.
- MWCC assumes no liability for injury to any hound or person, before, during or after the trial.

## • COVID-19 RESTRICTIONS

- 1 Roll call will be roaming. The inspection committee will go vehicle to vehicle to inspect and roll call all dogs.
- 2 Owners SHALL wear masks during inspection.
- 3 Owners/handlers will in the presence of the inspectors, wipe bitches and show tissue to them, then gait their dogs
- 4 All Whippets will be stacked by the owner/handler and a member of the inspection committee will wicket the entrant. Note: As requested by the American Whippet Club regardless if a Field Champion, all Whippets must be measured at the time of roll call.
- 5 No one except workers will not be allowed to congregate in the building
- 6 Other than workers, all individuals wishing to use the restrooms will use the back door and wear masks while inside.
- 7 Except at the start/finish, all people will maintain 6 feet separation when congregating
- 8 If possible, one vehicle width separation will be maintained in the parking lot. No community tents or pop-ups.
- 9 Draws/scores will be posted outside and owners/exhibitors should rotate and quickly jot down or take picture of colors/scores

10 Masks will be REQUIRED from the time you bring your hound to the line, during the run, and until you leave the field with your hound. This is for the safety of all involved. If you are unable to comply with the mask requirement, please stay home. Please practice social distancing as much as possible at all times!

## HOUND CERTIFICATION

<u>Certification</u>: Except those entering in Singles. Any entry marked **First Time Entered** must present a completed ASFA hound certification form to the Field Secretary BEFORE entries close. See the back of the entry form for certification forms and make extra copies if needed. Certification runs will be offered at a cost of \$5.00 per run on Saturday only after the completion of the trial. 
