SINGLES STAKE

ATTENTION: As of January 1, 2012, the Singles stake is now a regular stake which means it must be offered at all ASFA Field Trials, except at Regional Invitationals, International Invitationals, and Breed Specialty Trials. Since it is a regular stake, the entry for the Singles stake cannot be limited in number

The ribbon awarded to the highest placing qualifying Single is navy/gold at a regular ASFA field trial. If there is a tie for first place, ties shall be run off using the same protocol as judging the Singles stake. Hounds competing in the Singles stake are eligible to earn a Title of Coursing Proficiency (TCP) and a Title of Coursing Proficiency Excellent (CPX). These titles are not available to hounds in the Limited Breeds.
