

DIRECTIONS: far east side of Indianapolis

FROM THE EAST ON I-70: Take I-70 East to exit 96 (Mt. Comfort Rd. exit). Go south (left) on N County Road 600 W approximately 2.9 miles to US-40. Turn right (west) and go approximately 3 miles to S. German Church Rd. Turn right (south) on German Church Rd. and go 1.3 miles to Prospect. The field is on the left at the corner of S. German Church road and Prospect street. ASFA signs will be posted.

FROM THE EAST ON I-74: Take I-74 West to exit 96 (Post Rd. exit). Go north (right) on Post Road approximately 2 miles to US-42/Brookville Rd. Turn right (east) and go approximately 2.1 miles to S. German Church Rd. Turn left (north) on German Church Rd. and go 1.3 miles to Prospect St. The field is on the right at the corner of S. German Church road and Prospect street. ASFA signs will be posted.

FROM I-465: Take I-465 to exit 47 (on the southeast side of Indianapolis). Go right onto US-52/ Brookville Road. Go east on US-52 approximately 3.4 miles to S. German Church Rd. Turn left (north) on German Church Rd. and go 1.3 miles to Prospect St. The field is on the right at the corner of S. German Church road and Prospect street. ASFA signs will be posted.

RIBBONS: Ribbons will be awarded for all placements, 1st – Blue, 2nd – Red, 3rd – Yellow, 4th – White, NBQ – Green, Highest Scoring Single – Blue/Gold. Rosettes will be awarded for Best in Breed – Purple/Gold and Best in Field – Red/White/Blue

ELIGIBLE BREEDS & REGISTRY:

Only purebred Afghan Hounds, Azawakhs, Basenjis, Borzoi, Cirneco dell'Etna, Greyhounds, Ibizian Hounds, Irish Wolfhounds, Italian Greyhounds, Pharaoh Hounds, Rhodesian Ridgebacks, Salukis, Scottish Deerhounds, Silken Windhounds, Sloughis, Whippets and Provisional breeds may be entered in the regular stakes. Current Provisional Breeds: none.

Limited breeds may be entered in the Limited Stake or the Singles Stake. Limited breeds currently include purebred: Chart Polski, Galgo Espanol, Magyar Agar, Peruvian Inca Orchids, Portuguese Podengos (Pequeno), Portuguese Podengo (Medio & Grande) and must be individually registered with the appropriate registry.

All entries shall be individually registered with the AKC (ILP/PAL included), the NGA, the UKC, the FCI, an ASFA-recognized foreign or ASFA Board approved registry, or possess a CRN from the SPDBS. **A photocopy or acceptable registry must be submitted with each hounds first ASFA Field trial entry; this requirement is waived for hounds registered with the NGA.**

REGULAR STAKES OFFERED:

OPEN: Any eligible sighthound except ASFA Field Champions of Record

FIELD CHAMPION: Any ASFA Field Champion.

VETERAN: Any eligible sighthound whose age is at least six years except Irish Wolfhounds whose age shall be at least five years and Afghan Hounds, Rhodesian Ridgebacks and Whippets whose age shall be at least seven years. Points go toward V-Fch or V-LCM titles.

LIMITED STAKE: Any eligible sighthound of a Limited breed that has meet certification requirements.

SINGLE STAKE: Any eligible sighthound including those disqualified to run in other stakes. Each hound runs alone. Not eligible to compete in Best in Breed or Best in Field. Hounds are Eligible to earn TCP or CPX titles from the Single Stake. Limited breeds are not eligible for these titles.

BEST IN FIELD WILL BE OFFERED ON **SATURDAY ONLY**

CONDITIONS OF ENTRY:

All entries must be one year or older on the day of the trial. Stakes will be split into flights by Public random draw if the entry in any regular stake is 20 or more. Bitches in season, lame Hounds and hounds with breed disqualifications will be excused at roll call. Spayed, neutered, monorchid or cryptorchid hounds without breed disqualifications may be entered. Hounds with breed disqualifications are not eligible to enter except in the Single Stake. Hounds not present at the time of roll call will be scratched. All hounds will run twice, in trios, if possible or braces (except in the Single Stake), unless excused, dismissed or disqualified.

Hound Certifications will be offered on **Saturday ONLY** immediately after Best in Field. Cost will be \$5 per certification run. Practice will be offered as well, equipment and time permitting. Cost will be \$3 per practice run.

A penalty of \$5.00 will be assessed for any hound that is loose on the field and not in competition with the course in progress.

There will be a \$5.00 fee assessed to anyone who fails to pick-up after their hound. ESSA has kindly given us permission to use their field so let's all be good stewards so we don't lose the use of this field.

Bring your own shade and water.

Breakfast and lunch will be available for purchase both days.

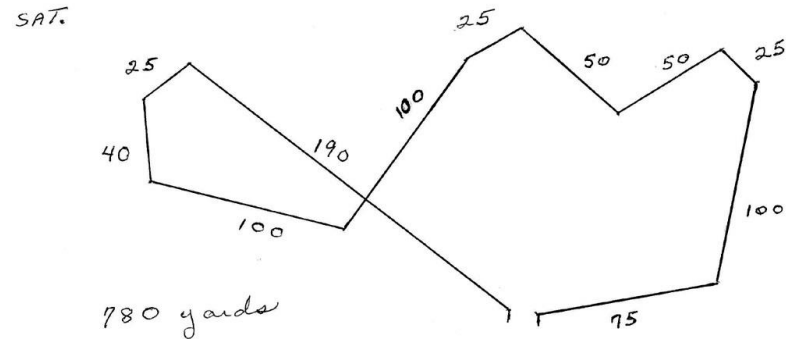

The lure will consist of highly visible plastic strips and will run on a battery-powered continuous loop system. Back-up equipment will be available.

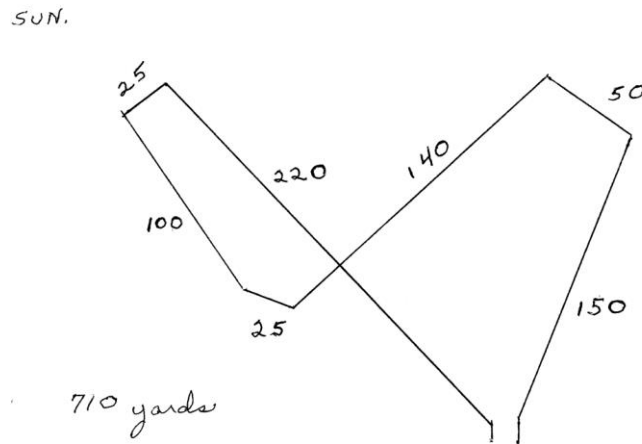
COURSE PLANS:
