### Directions to the Site:

**From the North:** From I-5 take exit #127 (Hwy 512 Puyallup exit) toward Puyallup. Take the Pacific Ave. exit (Hwy 7) and turn right.

Go South on Pacific Ave. approx. 5 miles to the Roy "Y" and bear right on WA-507/Spanaway McKenna Hwy.

Go 1.2 miles and turn slight left onto 8th Ave. Continue another 5.2 miles.

Just after crossing 288th St. (flashing yellow light), turn left into the entrance to the Polo Field on a dirt road marked with signage. Follow dirt road to field.

**From the South:** Take I-5 exit 88A (Tenino exit) and follow to Yelm.

Turn right at the stop light and follow to McKenna.

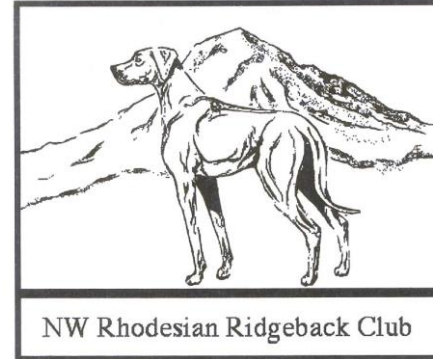
Turn right at the stop light in McKenna (Union 76) on Hwy 702/352nd St.

### ELIGIBLE BREEDS & REGISTRY

Only purebred Afghan Hounds, Azawakhs, Basenjis, Borzoi, Cirneco dell'Etna, Greyhounds, Ibizan Hounds, Irish Wolfhounds, Italian Greyhounds, Pharaoh Hounds, Rhodesian Ridgebacks, Salukis, Scottish Deerhounds, Silken Windhounds, Sloughis, Whippets may be entered in the regular stakes. Limited breeds may be entered in the Limited Stake or the Singles Stake. Limited breeds currently include purebred Chart Polski, Galgo Español, Magyar Agar, Peruvian Inca Orchid, Portuguese Podengo (Pequeno), Portuguese Podengo (Medio & Grande), and must be individually registered with the appropriate registry.

All entries shall be individually registered with the AKC (including ILP & PAL), the NGA, the UKC, the FCI, an ASFA-recognized foreign or ASFA Board approved registry, or possess a CRN from the SPDBS. A photocopy of acceptable registry must be submitted with each hound's first ASFA field trial entry; this requirement is waived for hounds registered with the NGA.

### STAKES OFFERED:

- **OPEN STAKE:** Any eligible sighthound, excluding ASFA Field Champions of record.
- **FIELD CHAMPION STAKE:** Any ASFA Field Champion of record.
- **VETERAN STAKE:** Any eligible hound whose age is at least six years, except Irish Wolfhounds whose age shall be at least five years, and Afghan Hounds, Rhodesian Ridgebacks, Salukis, and Whippets whose age shall be at least seven years. Points go toward V-FCh or V-LCM titles.
- **LIMITED STAKE:** Any eligible sighthound of a Limited breed that has met certification requirements. Not eligible to compete in Best of Breed or Best in Field.
- **SINGLE STAKE:** Any eligible sighthound including those disqualified to run in other stakes. Each hound runs alone. Not eligible for Best of Breed or Best in Field. Hounds are eligible to earn TCP and CPX titles from the Singles stake. Limited breeds are not eligible for these titles.
- **Best in Field:** Will be offered.

### CONDITIONS OF ENTRY:

All entries must be one year or older on the day of the trial

- Stakes will be split into flights by public random draw if the entry in any regular stake is 20 or more
  - Bitches in season, lame hounds and hounds with breed disqualifications will be excused at roll call. Spayed, neutered, monorchid or cryptorchid hounds without breed disqualifications may be entered. Hounds with breed disqualifications are not eligible to enter except in the Single Stake
- Hounds not present at the time of roll call will be scratched
- All hounds will run twice, in trios if possible or braces (except in the Single Stake), unless excused, dismissed or disqualified.

### EQUIPMENT:

- Lure machine is battery-powered Drag.
- Back-up equipment will be available.
- Lure will consist of three white plastic bags.

### CERTIFICATION:

- Certification runs to be held first.
- Certification runs will be limited to no more than 10 hounds. Pre- entry strongly encouraged
- Pre-arrange certification runs with the Field Secretary. Runs will be filled on a first come first served basis
- You must provide for your by-dog. The by-dog must be a qualified courser. If not the same breed, it must have a similar running style.

### ADDITIONAL INFORMATION:

- Parking will in the parking area on the East side of the lure field, or as directed.
- *A \$5 penalty will be assessed for any loose hound on the trial site not competing in the course in progress*
- NWRRC requests that everyone pick up after their dogs and leave no trash on the field at the end of the day.
- No alcoholic beverages will be permitted.
- Persons exhibiting unsportsmanlike conduct detrimental to NWRRC, ASFA, or any other person may be asked, at the Field Committee's discretion to leave the trial site.
- Persons exhibiting abuse or mistreatment of any hound on the grounds during trial hours may be asked, at the Field Committee's discretion, to leave the trial site.
- Any hound that displays any uncontrolled aggressive behavior toward any person or hounds on the trial grounds, except hounds competing in the course then in progress, may be excused from the field for the day, at the Field Committee's discretion.
- Water is available on site.
- Fast food restaurants are 10 minutes from the field in North Bend.
