**FROM THE EAST:** Take Exit 149B which is Rt 35 North. Take Rt 35 north for approx. -  
imately 33 miles to Rt 67. Take a right onto 67 and look for the Memorial  
Drive exit. Take the Memorial Drive exit and turn left at the end of the road.  
The AMA facility is on your right. Follow the ASFA signs to the field.

**ELIGIBLE BREEDS & REGISTRY:**

Only purebred Afghan Hounds, Azawakhs, Basenjis, Borzoi, Cirneco dell'Etna, Greyhounds, Ibizian Hounds, Irish Wolfhounds, Italian Greyhounds, Pharaoh Hounds, Rhodesian Ridgebacks, Salukis, Scottish Deerhounds, Silken Windhounds, Sloughis, and Whippets may be entered in the regular stakes. .

Limited breeds may be entered in the Limited Stake or the Singles Stake. Limited breeds currently include purebred: Chart Polski, Galgo Espanol, Magyar Agar, Peruvian Inca Orchids, Portuguese Podengos (Pequeno), Portuguese Podengo (Medio & Grande) and must be individually registered with the appropriate registry.

All entries shall be individually registered with the AKC (ILP/PAL included), the NGA, the UKC, the FCI, an ASFA-recognized foreign or ASFA Board approved registry, or possess a CRN from the SPDBS. **A photocopy or acceptable registry must be submitted with each hounds first ASFA Field trial entry; this requirement is waived for hounds registered with the NGA.**

**REGULAR STAKES OFFERED:**

**OPEN:** Any eligible sighthound except ASFA Field Champions of Record that have met the Certification Requirements  
**FIELD CHAMPION:** Any ASFA Field Champion.  
**VETERAN:** Any eligible sighthound whose age is at least six years except Irish Wolfhounds whose age shall be at least five years and Afghan Hounds, Rhodesian Ridgebacks, Salukis and Whippets whose age shall be at least seven years and have met the Certification Requirements. Points go toward V-Fch or V-LCM titles.  
**LIMITED STAKE:** Any eligible sighthound of a Limited breed that has meet certification requirements. Not eligible to compete in Best of Breed or Best in Field  
**SINGLE STAKE:** Any eligible sighthound including those disqualified to run in other stakes. Each hound runs alone. Not eligible to compete in Best in Breed or Best in Field. Hounds are eligible to earn TCP and CPX titles from the Single Stake. Limited breeds are not eligible for these titles.

**BEST IN FIELD WILL BE OFFERED ON SATURDAY ONLY**

**CONDITIONS OF ENTRY:**

All entries must be one year or older on the day of the trial. Stakes will be split into flights by public random draw if the entry in any regular stake is 20 or more. Bitches in season, lame hounds and hounds with breed disqualifications will be excused at roll call. Spayed, neutered, monorchid or cryptorchid hounds without breed disqualifications may be entered. Hounds with breed disqualifications are not eligible to enter except in the Single Stake. Hounds not present at roll call will be scratched. All hounds will run twice, in trios, if possible or braces (except in the Single Stake), unless excused, dismissed or disqualified.

**ADDITIONAL INFORMATION:**

Practice will be offered, equipment and time permitting. Cost will be \$3 per practice run.

A penalty of \$5.00 will be assessed for any hound that is loose on the field and not in competition with the course in progress.

There will be a \$5.00 fee assessed to anyone who fails to pick-up after their hound.

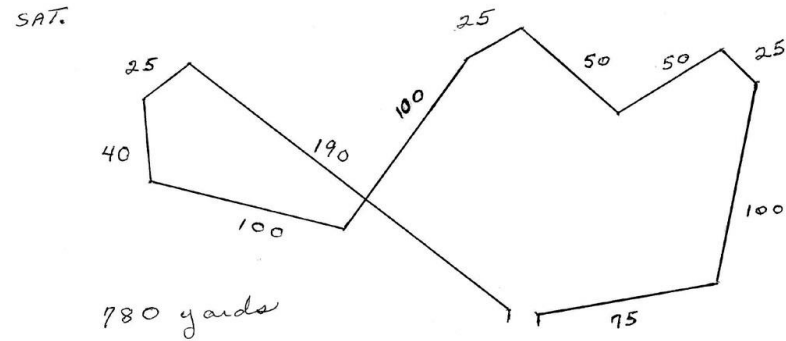
The lure will consist of highly visible plastic strips and will run on a battery-powered continuous loop system. back-up equipment will be available.

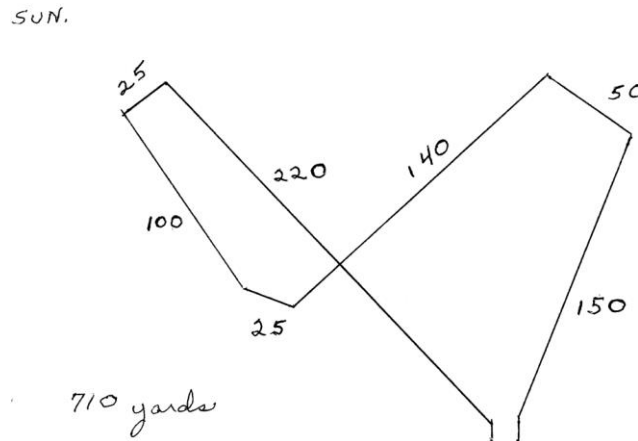

## **PROCEDURES TO FOLLOW REGARDING COVID-19**

**MASKS MUST BE WORN BY EVERYONE** except when you are at or in your vehicle (except when your dog/(s) are being inspected and you would be required to wear a mask at that time.

You would be required to wear a mask when running your dog(s).

Everyone including the Field Committee, Judges and exhibitors need to maintain 6-foot distancing whenever possible

**ROLL CALL and INSPECTION** will be performed on one dog at a time at the exhibitors vehicle. If you have entered a bitch, you will **SWIPE YOUR OWN DOG** and show the inspection committee the tissue. The inspection committee will wipe down the wickets after each dog or has been inspected.

Hand sanitizer and wipes will be provided on the table located under the tent

The Huntmaster will be positioned 6 feet from any exhibitor after inspecting blankets and slip leads.

At the starting line, all dogs will stand 6 feet apart.

Please wait until the draw sheets and/or score sheets have been posted to check your dogs blanket color or score. Obtain that information quickly by using your own paper and pencil or using your phone to avoid congregating.

If you are ill, coughing, sneezing or running a temperature - **PLEASE STAY HOME!!!!**
