


#### Directions:

<u>From South</u>: I-75 to south of Dayton. Take I-675 (northeast) about 20 miles. Exit at Route 235 (Fairborn) and turn left on route 235 north. Go 0.5 miles and turn right at Yellow-Springs-Fairfield Road. Go 3.5 miles to the Park on the right.

From North/West: I-70 to east of Dayton, then exit on I-675 south. (ignore the route 235 exit off of I-70). On I-675 go south 3 miles and exit at Route 235 (Fairborn). Go right on route 235, north 0.5 miles and turn right at Yellow-Springs-Fairfield Road. Go 3.5 miles to the Park on the right.

From East: I-70 to west of Springfield, then exit on route 68 south (Xenia/Yellow Springs). On route 68 go south 6 miles, past Young's Dairy, and turn right at Yellow-Springs-Fairfield Road. Go 2 miles to the Park on the left. The coursing field is next to the pavilion.

Late, incomplete, conditional, unsigned, unpaid entries and entries without a registration number will NOT be accepted. Entries will NOT be acknowledged by mail. ### **ELIGIBLE BREEDS & REGISTRY**

Only purebred Afghan Hounds, Azawakhs, Basenjis, Borzoi, Cirneco dell'Etna, Greyhounds, Ibizan Hounds, Irish Wolfhounds, Italian Greyhounds, Pharaoh Hounds, Rhodesian Ridgebacks, Salukis, Scottish Deerhounds, Silken Windhounds, Sloughis, Whippets may be entered in the regular stakes.

Limited stake breeds may be entered in the Limited Stake or the Singles stake. Limited breeds currently include purebred Chart Polski, Galgo Español, Magyar Agar, Peruvian Inca Orchid, Portuguese Podengo Pequeno, Portuguese Podengo Medio & Grande, and must be individually registered with the appropriate registry.

All entries shall be individually registered with the American Kennel Club (ILP/PAL included), the National Greyhound Association, the United Kennel Club, the Federation Cynologique Internationale, an ASFA approved registry, or possess a Critique Registration Number (CRN) from the Society for the Perpetuation of Desert Bred Salukis (SPDBS).

A photocopy of acceptable registry must be submitted with each hound's first ASFA field trial entry; this requirement is waived for hounds registered with the National Greyhound Registry.

#### Regular Stakes:

**OPEN STAKE**: Any eligible sighthound who has met certification requirements, excluding ASFA Field Champions of record. A photocopy of the hound's registration must be submitted at the hound's first trial. This is waived for NGA greyhounds

FIELD CHAMPION STAKE: Any ASFA Field Champion.

**VETERAN STAKE:** Any eligible hound whose age exceeds 6 years, except Irish Wolfhounds whose age shall exceed 5 years, and Afghans, Rhodesian Ridgebacks, Salukis & Whippets whose age shall exceed 7 years, who has met certification requirements. Points earned in this stake are towards the V-FCH & V-LCM.

**LIMITED STAKE**: Any eligible sighthound of a Limited breed that has met certification requirements. Not eligible to compete in Best of Breed or Best In Field.

**Single Stake:** Any eligible sighthound including those disqualified to run in other stakes. Spayed, neutered, monorchid or cryptorchid hounds without breed disqualifications may be entered. Not eligible for Best of Breed or Best in Field. Hounds are eligible to earn TCP and CPX titles from the Singles stake. Limited breeds are not eligible for these titles. Each Hound runs alone.

Conditions of Entry: All entries must be one year or older on the day of the trial. Stakes will be split into flights by public random draw if the entry in any regular stake is 20 or more. Bitches in season, lame hounds and hounds with breed disqualifications will be excused at roll call. Spayed, neutered, monorchid or cryptorchid hounds without breed disqualifications may be entered; hounds with breed disqualifications are not eligible to enter except in the Single Stake. Hounds not present at the time of roll call will be scratched. All hounds will run twice, in trios if possible or braces (except in the Single Stake), unless excused, dismissed or disqualified. Hound certification runs will be offered this weekend.
